

# UNION COUNTY BOARD OF CHOSEN FREEHOLDERS

# THURSDAY, SEPTEMBER 11, 2014 REGULAR MEETING AGENDA

Chairman Christopher Hudak presided and called the meeting to order at 7:03pm. Roll call showed Vice Chairman Mohamed S. Jalloh, Freeholder Bruce Bergen, Freeholder Linda Carter, Freeholder Angel G. Estrada, Freeholder Sergio Granados, Freeholder Bette Jane Kowalski, Freeholder Alexander Mirabella, and Freeholder Vernell Wright were in attendance.

Also present were County Manager Alfred Faella, County Counsel Robert E. Barry, Esq. and Clerk of the Board James Pellettiere.

The Prayer and Salute to the Flag were led by the Clerk of the Board.

The statement of compliance with the Open Public Meetings Act was led by the Clerk of the Board.

## MOMENT OF SILENCE

Chairman Christopher Hudak called for a moment of silence in memory of the tragic attacks on September 11, 2001.

## PRESENTATIONS FROM THE BOARD

A Certificate and Check Presentation was made to Austin Mathew, who was recognized by the NJAC Foundation and PSE&G Foundation as a recipient of the 2014 Scholarship Award. Freeholder Wright was joined by Freeholder Kowalski, Freeholder Mirabella and Peter Capodice, Superintendent of UC Vo-Tech. Freeholder Wright spoke on behalf of NJAC Foundation and presented Austin with certificate and check.

A Resolution Presentation was made by Vice Chairman Mohamed S. Jalloh and Freeholder Linda Carter to James H. Morris & Azana Crawley, NJ ACT-SO Gold Medalists to congratulate and commend the New Jersey ACT-SO Program and its 2014 Gold Medal Recipients. Vice Chairman Jalloh spoke about the talented recipients. He spoke on acknowledging the talented youths across the County and the importance of bringing that talent back after their college years.

#### **ORDINANCE FOR ADOPTION**

BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS 759-2014 PUBLIC IMPROVEMENTS AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY, NEW ADDITIONAL FURNISHINGS, NEW COMMUNICATION AND **SYSTEMS EQUIPMENT** AND NEW SIGNAL INFORMATION TECHNOLOGY AND TELECOMMUNICATIONS EQUIPMENT IN, BY AND FOR THE COUNTY OF UNION, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$38,793,236 TO PAY THE COST THEREOF, TO APPROPRIATE A STATE GRANT, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

## **PUBLIC COMMENT PORTION**

The meeting is open to the public for the purpose of commenting on Ordinance Number 759-2014 only.

Chairman Hudak asked Director Taylor to give an overview of Bond Ordinance Number 759-2014. Prior to opening the Public Comment Portion.

Director Taylor said the annual Bond Ordinance establishes appropriations to the Capital Budget which allows for various improvements of property in the amount of \$38,793,236.

John Bury, Kenilworth, said the County is spending \$100,000 for a video system for the Freeholders' meeting room, and he asked if we were replacing the current system. Mr. Bury asked if the house on Cooper Road in Scotch Plains is a Juvenile Detention Half Way House and asked why Open Space Funds are not being used.

Chairman Hudak asked Clerk of the Board Pellettiere to explain.

Clerk of the Board Pellettiere said in February or early March the video system failed. He explained they have been operating on a temporary fix, but new equipment is needed. He explained the current equipment was originally purchased in the late 90's and early 2000's.

Director Taylor explained the issues pertaining to the egress to the site. She also explained that two appraisals were performed and this amount represents the appraised value.

Bruce Paterson, Garwood, said he disagrees with Director Taylor's explanation. He stated we should buy the house with Open Space Trust Fund dollars. Mr. Paterson also spoke in regards to Ordinance Number 758-2014.

# FINAL READING STATEMENT

Vice Chairman Jalloh moved Ordinance Number 759-2014 for Final Reading and authorized the Clerk of the Board to advertise the same in accordance with the law. The motion was seconded by Freeholder Kowalski. Roll call showed nine members of the Board voted in the affirmative.

## **PUBLIC COMMENT PORTION**

The meeting is open to the public for the purpose of commenting on Resolutions being offered for adoption only.

Bruce Paterson, Garwood, questioned the federal funds revenue producing item relative to Resolution 2014-706.

Mr. Paterson questioned the total dollar amounts regarding the modification of the budget referring to Resolutions 2014-710 through 714.

Mr. Paterson also made comments regarding political contribution on the following: Resolutions 2014-710 through 714, 723, 724, 727, 728, 743, and 744. He suggested the Board pass a play to play Resolution.

County Counsel Barry stated that all the contracts are in full compliance with play to play laws of New Jersey.

Prior to moving Resolutions that are being offered for adoption, Chairman Hudak noted Resolution Number 2014-746 amended the Annual Meeting Schedule. He stated this Resolution effectively cancels our September 25, 2014 Regular Meeting, recognizing Rosh Hashanah, and is rescheduled as part of a double meeting, next week, on September 18, 2014.
