

**HOLD HARMLESS, INDEMNIFICATION AND ASSUMPTION OF RISK
AGREEMENT**

Serious Injury may result from your participation in this activity.

In consideration of and by participating in any fashion in any activity today and on all future dates at the Watchung Stables, any participant, his/her heirs, assigns, and legal representatives, hereby expressly agree to the following:

1. Participant agrees to assume any and all risks involved in or arising from the participant's use of Watchung Stables services, activities and/or property and facilities including, but not limited to the risks of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, persons, horses or stationary objects, or the negligence or deliberate act of another person.
2. Participant agrees to hold Watchung Stables and the County of Union and all of its successors, assigns, subsidiaries, employees, and agents harmless and release them from any/all liability whatsoever and in connection with any claims, causes of action, injuries, damages, cost or expenses arising out of participant's use of Watchung Stables services, activities and/or property and facilities, including without limitation, those based on death, bodily injury, or property damage.
3. Participant agrees to indemnify and defend Watchung Stables and the County of Union and all of its successors, assigns, subsidiaries, employees, and agents against any and all claims, causes of action, damages, judgments, costs or expenses resulting from the participant's negligence arising from the participant's use of Watchung Stables services and/or property and facilities.
4. Participant certifies that he/she is physically and mentally fit for all equestrian activity and will obey all rules and regulations established by Watchung Stables.

WARNING: UNDER NEW JERSEY LAW, AN EQUESTRIAN AREA OPERATOR IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ANIMAL ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ANIMAL ACTIVITIES, PURSUANT TO P.L.1997, c.287 (C.5:15-1 et seq.).

"Inherent risk or risks of an equine animal activity" means those dangers which are an integral part of equine animal activity, which shall include but need not be limited to:

1. The propensity of an equine animal to behave in ways that result in injury, harm, or death to nearby persons;
2. The unpredictability of an equine animal's reaction to such phenomena as sounds, sudden movement and unfamiliar objects, persons or other animals;
3. Certain natural hazards, such as surface or subsurface ground conditions;
4. Collisions with other equine animals or with objects; and
5. The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, including but not limited to failing to maintain control over the equine animal or not acting within the participant's ability.

Finally, participant represents to Watchung Stables management that this Agreement is being made freely and voluntarily, and that if this Agreement is on behalf of a participant who is under the age of eighteen (18) years, that the undersigned is the participant's parent or legal guardian. Participant further acknowledges and understands that this Agreement shall remain valid now and at all times in the future until it is revoked in writing by participant.

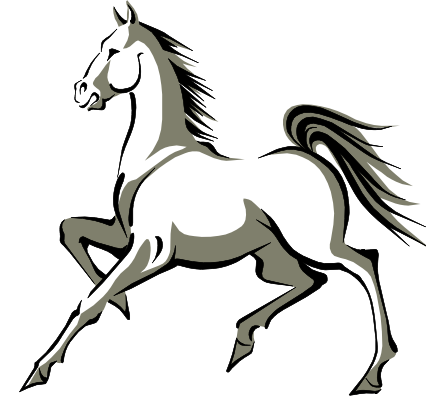

CAMP REGISTRATION DATES AND PROCEDURES:

- **First & Second Squad:** Saturday, May 30, beginning at 8 am by lottery; lottery numbers to be passed out at 7:45am
- **3A (C3 & C2/3) & 3B (D2) Students Enrolled Summer 2014, Fall 2014 and, or Spring 2015:** Saturday, May 30; beginning at 10:00 am; lottery numbers to be passed out at 9:30 AM
- **Union County Resident Beginners or riders new to the program:** Saturday, May 30; lottery numbers to be passed out at 1 PM
- **Out-of-County Beginners or riders new to the program:** Saturday, May 30; beginning at 2 PM if space permits

ENROLLMENT: Boys and girls ages 9 to 17 are eligible to attend. Enrollment is limited to one week per child (if available). All required fees must accompany an application.

Union County recognizes the need to conduct a fair and efficient registration system to handle the demand for the Watchung Stable summer camps. A lottery system will be used to determine your place in line for summer program registration on May 30, 2015.

Registration procedures

- All those registering for camps must complete the Emergency Medical Information Form and, if applicable, complete additional forms as required. **These forms must be returned at time of registration.**
- **May 30th at 7:45am** - 1st & 2nd Squad Riders may draw a random lottery number; registration begins at 8:00am.
- **May 30th at 9:30am** - 3A (C3 & C2/3) & 3B (D2) riders enrolled in Summer 2014, Fall 2014 or Spring 2015 programs: may draw a random lottery number; registration begins at 10:00am.
- **May 30th at 1:00pm** - Union County riders new to the program or beginner riders may draw a random lottery number and register.
- **May 30th at 2:00pm** - Out-of-County riders new to the program or beginner riders may draw a random lottery number and register.

Registration rules

- All registrations must be done in person. **No mail-in registrations will be accepted.**
- 1st Squad may register for 2 weeks on registration day.
- Campers with ratings of 2nd squad and lower may only enroll for one week of camp initially.
- Second week registration preferences must be indicated on your initial application in order to be considered.
 - If any camp openings remain on June 3rd, you will receive a call and be offered a second week of camp (calls will be made in lottery order).
 - Payment for the second week of camp must be made in person within one week of notification or you will forfeit your spot.

Continued~

WATCHUNG STABLES

- One person may register all riders in one family regardless of their riding level. Families unable to be present may have a person represent their family. If a person is registering two families, they will pick two lottery numbers.
- Campers must ride at the highest riding level they have attained. There will be no testing of riders on registration days.
- Proof of residency will be required. Valid forms include a driver's license, utility bill or tax bill. Those without proof of residency will pay the Out-of-County rate.

Registration Day Procedures for Lottery 3B (D2) and 3A (C3 & C2/3)

- The place a person holds on line to pick the lottery number will have no bearing on the order in which registration occurs.
- Lottery numbers will be held by members of the Watchung Stable Auxiliary.
- Once you have drawn a number you must enter the office building.
- Applicants will be called in numerical order, once all numbers have been distributed.
- Persons arriving after the lottery numbers have been passed out will be accommodated in the order in which they arrive and after all number holders have been called.
- If you arrive after registration has begun, you will be placed at the end of the list. Lottery numbers will not be passed out after 9:45am.

Payment Policies

- Payments must be made in full. Make checks payable to "County of Union".
- MasterCard, Visa, AMEX and Discover credit cards are accepted in person.
- Camp is a 4 day session.
- County residents - \$385.00/week Out-of-County residents - \$490.00/week
- 2nd Camp same year/2nd child in family
 - In-County \$366.00/week
 - Out-of-County \$466.00/week

Cancellation Policies

No refunds or credits will be issued.

Wait List Procedures

A wait list will be maintained for each week of camp. Participants will be called from the wait list as cancellations occur.
