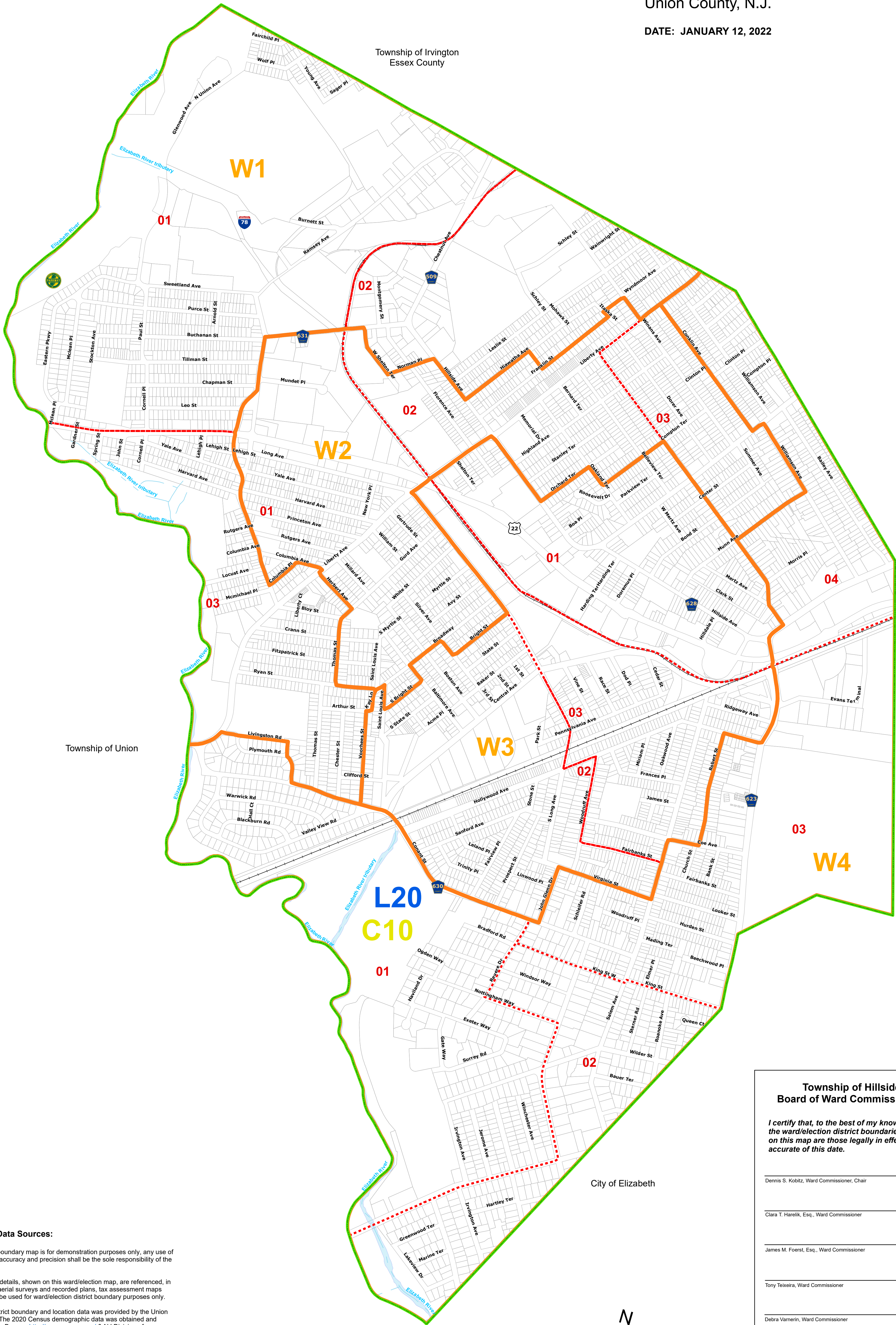


ELECTION DISTRICT MAP
