REPORT OF THE BOROUGH OF ROSELLE RE-WARDING COMMISSION

BOROUGH OF ROSELLE (2014) Descriptions of New Ward Boundaries January 2022

The following data resources were provided by the NJDEP Stream centerlines 2015; NJDOT Street centerlines 2015; TeleAtlas Street centerlines 2010. The parcels (2021) were provided and referenced as the interpretation made by the New Jersey Geographic Information Network (NJGIN). The municipal boundaries 2021, were provided and referenced as the interpretation made by the NJ Office of GIS. This source data was utilized for the preparation of the election district word description as stipulated under N.J.S.A. 19:4-13 et seq., as required by Administrative Law 13:17-3.1 for submission to the Office of the New Jersey Secretary of State (SOS).

The Borough of Roselle in the County of Union in the State of New Jersey is comprised of a total of Five (5) Wards. Due to population changes and other concerns documented during Census 2020, new boundaries for these wards are required to meet Title 40, 40A (Municipalities, Counties) guidelines and the Borough's current needs. The new boundaries for these wards are described herein.

Ward One

The First Ward of the Borough of Roselle shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border is a point on the physical centerline of Sheridan Avenue;

Thence, Easterly, following along the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border, to a point where said boundary intersects the Borough of Roselle, Union County and the City of Elizabeth, Union County shared border;

Continue, Southeasterly, various courses, following along the Borough of Roselle, Union County and the City of Elizabeth, Union County shared border, to a point where said boundary intersects the Borough of Roselle, Union County and the City of Linden, Union County shared border;

Continue, Southwesterly, various courses, following along the Borough of Roselle, Union County and the City of Linden, Union County shared border, to a point where said boundary is intersected by the physical centerline of Drake Avenue;

Thence, Northerly, following along the physical centerline of Drake Avenue, to a point where said boundary is intersected by the physical centerline of East Seventh Avenue;

Continue, West, following along the physical centerline of East Seventh Avenue, to a point where said boundary is intersected by the physical centerline of Harrison Avenue;

Thence, Northwest, following along the physical centerline of Harrison Avenue, to a point where said boundary intersects the physical centerline of First Avenue;

Continue, East, following along the physical centerline of First Avenue, to a point where said boundary intersects the physical centerline of Sheridan Avenue and the physical centerline of East First Avenue;

Thence, Northerly, following along the physical centerline of Sheridan Avenue, to a point where said boundary is intersected by a point on the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border, which is also the point of beginning.

Ward Two

The Second Ward of the Borough of Roselle shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border is a point on the physical centerline of Walnut Street;

Thence, Eastwardly, following along the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border, to a point where said boundary intersects with the physical centerline of Sheridan Avenue;

Continue, Southerly, following along the physical centerline of Sheridan Avenue, to a point where said boundary intersects with the physical centerline of East First Avenue;

Thence, Westerly, following along the physical centerline of East First Avenue, to its point of intersection with the physical centerline of First Avenue and the physical centerline of Harrison Avenue;

Proceed, Southerly, following along the physical centerline of Harrison Avenue, to a point where said boundary intersects the physical centerline of East Seventh Avenue;

Thence, Easterly, following along the physical centerline of East Seventh Avenue, to its point of intersection with the physical centerline of Drake Avenue;

Thence, Southeasterly, various courses, following along the physical centerline of Drake Avenue, to its point of intersection with the Borough of Roselle, Union County and the City of Linden, Union County shared border;

Continue, Southwesterly, various courses, following along the Borough of Roselle, Union County and the City of Linden, Union County shared border, to its point of intersection with the physical centerline of Spruce Street;

Proceed, Northwest, following along the physical centerline of Spruce Street, to its point of intersection with the physical centerline of East Fifth Avenue;

Thence, Easterly, following along the physical centerline of East Fifth Avenue, to its point of intersection with the physical centerline of Poplar Street;

Continue, Northwest, following along the physical centerline of Poplar Street, to its point of intersection with the physical centerline of Second Avenue;

Thence, Westerly, following along the physical centerline of Second Avenue, to its point of intersection with the physical centerline of Walnut Street;

Thence, Northwest, following along the physical centerline of Walnut Street, to its point of intersection with a point on the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border, which is also the point of beginning.

Ward Three

The Third Ward of the Borough of Roselle shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border is a point on the physical centerline of Chestnut Street (County Route 625);

Thence, Eastwardly, following along the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border, to a point where said boundary intersects with the physical centerline of Walnut Street;

Thence, Southerly, following along the physical centerline of the Walnut Street, to a point where said boundary intersects the physical centerline of Second Avenue;

Continue, Easterly, following along the physical centerline of Second Avenue, to a point on the physical centerline of Poplar Street;

Proceed, Southeast, following along the physical centerline of Poplar Street, to a point where said boundary intersects with the physical centerline of East Fifth Avenue;

Thence, Westerly, following along East Fifth Avenue, to a point where said boundary intersects with the physical centerline of Spruce Street;

Thence, Southerly, various courses, following along the physical centerline of Spruce Street, to a point where said boundary intersects with a point on the Borough of Roselle, Union County and the City of Linden, Union County shared border;

Thence, Southwesterly, various courses, following along the Borough of Roselle, Union County and the City of Linden, Union County shared border, to a point where said boundary intersects with the physical centerline of Crescent Avenue;

Thence, Northwesterly, following along the physical centerline of Crescent Avenue, to a point where said boundary intersects with the physical centerline of Raritan Road;

Continue, Southeast, following along the physical centerline of Raritan Road, to a point where said boundary intersects with the physical centerline of Wheatsheaf Road;

Proceed, North, following along the physical centerline of Wheatsheaf Road, to a point where said boundary intersects with the centerline of the Staten Island Railroad Corporation right-of-way (a railroad);

Thence, Northwesterly, following along the centerline of the Staten Island Railroad Corporation right-of-way (a railroad), to a point where said boundary intersects with the physical centerline of West Ninth Avenue;

Thence, East, following along the physical centerline of West Ninth Avenue, to a point where said boundary is intersected by the physical centerline of Locust Street;

Thence, Northerly, following along the physical centerline of Locust Street, to a point where said boundary is intersected by the physical centerline of Fourth Avenue;

Thence, Easterly, following along the physical centerline of Fourth Avenue, to a point where said boundary is intersected by the physical centerline of Chestnut Street (County Route 625);

Thence, Northerly, following along the physical centerline of Chestnut Street (County Route 625), to a point where said boundary is intersected by the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border and the point of beginning.

Ward Four

The Fourth Ward of the Borough of Roselle shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border is a point on the physical centerline of Chestnut Street (County Route 625);

Thence, Southerly, following along the physical centerline of Chestnut Street (County Route 625), to a point where said boundary intersects the physical centerline of Fourth Avenue;

Thence, Westerly, following along the physical centerline of Fourth Avenue, to a point where said boundary intersects the physical centerline of Aldene Road;

Thence, Southeasterly, following along the physical centerline of Aldene Road, to a point where said boundary is intersected by the physical centerline of Fifth Avenue;

Thence, Southwesterly, following along the physical centerline of Fifth Avenue, to a point where said boundary is intersected by the physical centerline of North Wood Avenue, which is also a point on the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border;

Thence, Northwardly then Eastwardly, following along the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border, which is also the physical centerline of

North Wood Avenue, to a point where said boundary is intersected by the physical centerline of Chestnut Street (County Route 625), which is also the point of beginning.

Ward Five

The Fifth Ward of the Borough of Roselle shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of the Fourth Avenue is intersected by the physical centerline of Aldene Road;

Thence, Easterly, following along the physical centerline of Aldene Road, to a point where said boundary intersects with the physical centerline of Locust Street;

Continue, Southerly, following along the physical centerline of Locust Street, to a point where said boundary intersects with the physical centerline of West Ninth Avenue;

Thence, Westerly, following along the physical centerline of West Ninth Avenue, to a point where said boundary intersects with the centerline of the Staten Island Railroad Corporation right-of-way (a railroad);

Thence, Southwest, following along the centerline of the Staten Island Railroad Corporation right-of-way (a railroad), to a point where said boundary intersects with the physical centerline of Wheatsheaf Road;

Thence, Southerly, following along the physical centerline of Wheatsheaf Road, to a point where said boundary intersects with the physical centerline of Raritan Road;

Thence, Northwest, following along the physical centerline of Raritan Road, to a point where said boundary intersects with the physical centerline of Crescent Avenue;

Thence, Southeasterly, various courses, following along the physical centerline of Crescent Avenue, to a point where said boundary intersects with a point on the Borough of Roselle, Union County and the City of Linden, Union County shared border, which is also the physical centerline of East Saint Georges Avenue;

Thence, Southwest then Northwest, following along the Borough of Roselle, Union County and the City of Linden, Union County shared border, to a point where said boundary intersects with the physical centerline of Fifth Avenue, which is also a point on the Borough of Roselle, Union County and the Borough of Roselle Park, Union County shared border;

Thence, Northeast, following along the physical centerline of Fifth Avenue, to a point where said boundary intersects with the physical centerline of Aldene Road;

Thence, Northeast, following along the physical centerline of Aldene Road, to a point where said boundary intersects with the physical centerline of Fourth Avenue, which is also the point of beginning.
