

# UNION COUNTY BOARD OF CHOSEN FREEHOLDERS

# THURSDAY, OCTOBER 1, 2020 REGULAR MEETING MINUTES

### CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:51P.M.

#### ROLL CALL

Roll call showed Chairman Alexander Mirabella, Freeholder Angela R. Garretson, Freeholder Sergio Granados, Freeholder Christopher Hudak, Freeholder Bette Jane Kowalski, Freeholder Kimberly Palmieri-Mouded, Freeholder Andrea Staten, and Freeholder Rebecca Williams were present.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

#### PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

# STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

# APPROVAL OF COMMUNICATIONS

Note and File

Chairman Mirabella called for a motion to approve Communications. On a motion made by Freeholder Kowalski and seconded by Freeholder Staten, roll call showed eight members of the Board voted in the affirmative.

#### **ORDINANCES FOR ADOPTION**

AN ORDINANCE TO AMEND THE UNION COUNTY SOLID WASTE MANAGEMENT PLAN BY INCLUDING A CLASS "C" RECYCLING FACILITY TO BE OWNED AND OPERATED BY LINDEN RENEWABLE ENERGY, LLC LOCATED AT 4900 TREMLEY POINT, LOT 8.02, BLOCK 587, LINDEN, NEW JERSEY TO ACCEPT ORGANIC WASTE OR ORGANIC SUBSTRATE AND UTILIZE ANAEROBIC DIGESTION TO CREATE RENEWABLE NATURAL GAS, A MARKETABLE SOIL AMENDMENT, AND LIQUID DIGESTATE THAT WILL BE PROCESSED ON SITE TO PRODUCE LIQUID ORGANIC FERTILIZER.

Clerk of the Board Pellettiere read Ordinance No. 818-2020 by title.

Freeholder Williams excused herself from the meeting during the presentation of the Ordinance.

Chairman Mirabella noted an earlier Public Hearing held on Ordinance No. 818-2020. He advised that upon the conclusion of the hearing, the Clerk of the Board forwarded the recording of that Public Hearing the members of the Board with a summary of the questions and answers discussed. He called upon Union County Utilities Authority Executive Director Daniel Sullivan.

UCUA Executive Director Daniel Sullivan called upon UCUA's Special Counsel Kevin Conti to elaborate on Ordinance No. 818-2020.

UCUA Special Counsel Kevin Conti advised that in 2019 Linden Renewable Energy, LLC filed an application with the UCUA, proposing inclusion of the noted solid waste management facility at the cited location. He further advised that upon thorough inspection and review by the UCUA, a resolution was composed recommending the facility be approved by the Board. Despite receiving initial approval from the appropriate channels In July, Mr. Kevin Conti noted that NJDEP requested Ordinance No. 818-2020 be revised reintroduced and readopted as a result of a technical issue relative to the verbiage on the original ordinance. UCUA Special Counsel Kevin Conti called upon James Potter and Dennis Toft from Linden Renewable Energy, LLC to elaborate further on the facility.

Linden Renewable Energy, LLC Special Counsel Dennis Toft confirmed that the details relative to the original ordinance had not changed. He gave a brief overview of the solid waste management facility and its operational processes. He noted that the facility met the state's goal for food waste recycling and would provide a significant reduction in greenhouse gas emissions. Mr. Dennis Toft further advised that the facility was designed and built in conformity with several NJDEP permits to ensure safety and appropriate operation of the facility. He turned to President of RNG Energy Solutions, LLC, James Potter for additional information.

RNG Energy Solutions, LLC President James Potter advised that the facility would receive processed waste which would subsequently be converted into renewable natural gas through bioreactors. He noted that this process was a state-of-the-art process used to manage waste in a manner that would significantly reduce greenhouse emissions, noting this facility would be one of the largest reducers of said emissions in the state. He further noted that the natural gas would be processed to produce pipe-line quality gas that would be injected into an interstate pipeline, approximately 4,000 feet from the designated site, and would subsequently be used to create hydrogen. Mr. Potter noted they were currently obtaining the necessary local and state permits to begin construction which was expected to begin in first quarter of 2021.

Chairman Mirabella asked Clerk of the Board Pellettiere to share the comments and or questions from the earlier public hearing relative to Ordinance No. 818-2020.

Clerk of the Board Pellettiere read an email from Mr. Sero Scalera noting his approval for the solid waste management facility.

Clerk of the Board Pellettiere referenced questions received during the prior public hearing, relative to the amount of trucks anticipated to visit the site daily as well as the need for a bond guarantee relative to the project.

Relative to the earlier public hearing, Clerk of the Board Pellettiere confirmed that approximately 74 trucks were expected daily, roughly 5-7 trucks per hour. He also confirmed that the vendors noted there was no need for a guarantee bond relative to performance, adding that the bond noted in the comments related to the financial mechanism used to contend with debt arising from the project.

Clerk of the Board Pellettiere confirmed these were the only comments relative to the earlier public hearing.

Chairman Mirabella asked the vendor to confirm the facility would be constructed in accordance with union contract standards.

RNG Energy Solutions, LLC President Potter confirmed this to be the case, noting a long history of following similar standards in the construction of similar facilities.

#### PUBLIC HEARING ON ORDINANCE

The meeting was opened for the purpose of commenting on Ordinance Number 818-2020 only.

Judy McCarthy, of Linden, inquired about the hours of operation for the facility as well as the union labor hours and permanent jobs that would result from the project. She also inquired about the potential for a turnpike ramp to contend with additional traffic that could result from the facility.

President Potter advised that although the facility would operate 24/7, he expected deliveries to occur 16-18 hours daily. He also confirmed 5-7 trucks per hour. Relative to the union labor hours and permanent positions at the facility, Mr. Potter advised that they had no say in who would be employed, but confirmed a capable union labor force would be ready to tackle the anticipated 10 month construction phase.

Freeholder Hudak spoke relative to the prospective Tremley Point connecter road. He commended NJ State Senator Nicholas P. Scutari for being instrumental in the project as well as former Freeholder Angel G. Estrada. He noted that the Turnpike Authority now owned the Tremley Point project and he expected progress to be forthcoming. He noted the repurposing of certain areas to accommodate the connector road, ideally diverting some of the anticipated traffic from the city streets.

Bruce Paterson, of Garwood, inquired about whether or not any materials would be incoming from New York. He also asked about when the facility would be fully operational and if any emissions or waste would be produced by the facility itself.

RNG President Potter confirmed that construction of the project would run 16 months, noting a target start date of March 1, 2021 and 16 months of construction thereafter. He also advised that he expected waste to be received from NY, given the region has opted for the diversion of organic waste through legislation to reduce said emissions. Lastly, he

advised that Linden and Roselle Sewage Authority had agreed to receive the waste from the facility. He further advised that the facility would release certain emissions similar to a boiler system seen in other large, unrelated facilities like schools.

Daniel Hahn, inquired about the cost of the facility and whether or not the county would be making any financial contributions to the project. Additionally, he asked for a general overview of the process through waste would be received.

RNG President Potter advised that the cost of the facility would be \$220 million, confirming that the county would not be furnishing any funds as the project was being funded by private investments. He also gave a brief overview of the receiving process at the solid waste management facility.

Clerk of the Board Pellettiere confirmed no additional members of the public wishing to comment on Ordinance No. 818-2020.

#### FINAL READING STATEMENT

Freeholder Christopher Hudak, Freeholder Liaison to the Union County Utilities Authority, moved Ordinance Number 818-2020 for Final Reading and authorized the Clerk of the Board to advertise same in accordance with the law.

On a motion made by Freeholder Hudak and seconded by Freeholder Kowalski roll call showed seven members of the Board voted in the affirmative.; with Freeholder Williams absent.

# PUBLIC HEARING ON ORDINANCE

The meeting was opened for the purpose of commenting on Ordinance Number 819-2020 only.

Bruce Paterson, of Garwood, asked for an overview of Ordinance No. 819-2020 and whether or not it was part of the County's Master Plan.

County Counsel Bergen advised that Ordinance No. 819-2020 related to services fees not previously cited and confirmed it did not affect the County's Master Plan.

Clerk of the Board Pellettiere confirmed no additional members of the public wishing to comment on Ordinance No. 819-2020

# FINAL READING STATEMENT

Freeholder Christopher Hudak moved Ordinance Number 819-2020 for Final Reading and authorized the Clerk of the Board to advertise same in accordance with the law.

On a motion made by Freeholder Hudak and seconded by Freeholder Palmieri-Mouded roll call showed seven members of the Board voted in the affirmative; with Freeholder Williams absent.

#### SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Freeholder Kowalski and seconded by Freeholder Hudak roll called showed seven members of the Board voted in the affirmative; with Freeholder Williams absent.

#### **PUBLIC COMMENT PORTION**

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

Bruce Paterson, of Garwood, asked questions relative to several resolutions. Relative to Reso No. 2020-688, he inquired about the use for these funds. Relative to Reso No. 2020-691, he inquired about the services being provided by the vendor. Relative to Reso No. 2020-693, he asked where these services were being furnished within the county. Relative to Reso No. 2020-702, he inquired about the services being provided by the vendor.

Relative to Reso No. 2020-688, Open Space, Recreation, and Historic Preservation Trust Fund Administrator Durbin-Drake advised that the county's acquisition account was under funded and grant funding would be used to offset the deficit.

Relative to Reso No. 2020-691, Director Graziano confirmed that the vendor provided several services under the contract, including intercom and video systems, alarm panels, and security camera installation. He noted that the contract also included 1,500 hours of service time.

Relative to Reso No. 2020-693, Director Graziano noted 22 facilities throughout the county, noting the contract included 7,500 waste pickups.

Relative to Reso No. 2020-702, Clerk Rajoppi advised that an increase was necessary to contend with the pick-up and delivery of collated ballots to the regional post office by the mailer.

Daniel Hahn inquired about Reso No. 2020-690.

Director Zuber confirmed that the locations to be addressed under this Resolution were known to be problematic as it related to excess deer populations.

Clerk of the Board Pellettiere confirmed no additional members of the public wishing to comment

# FREEHOLDER REPORTS AND COMMENTS

Freeholder Hudak spoke relative to the upcoming Great Pumpkin Sail, noting that he was happy that the event could be held in a safe and socially distant manner; he commended the Parks & Recreation staff for their work in facilitating the event. He also thanked Chairman Mirabella for his leadership in securing additional federal grant funding for struggling business in an attempt to allow them to extend

outdoor services into the colder months. On another note, Freeholder Hudak spoke relative to a recent call he received from the Linden Education Association regarding COVID-19 testing for staff and students as the area prepares to transition to some degree to in-person instruction. He noted Jessica Cohen's interactions with the UC Education Association to ensure convenient, mobile-testing resources are made available during the transition process and thereafter.

Freeholder Palmieri-Mouded echoed the sentiments of fellow Freeholder Hudak, noting the importance of convenient testing and timely results as provided by the COVID-19 saliva test. On another note, she spoke relative to October being Breast Cancer Awareness month and encouraged residents to schedule their annual mammograms. Furthermore, she noted that October 13<sup>th</sup> was the official Metastatic Breast Cancer (MBC) Awareness day, noting the county's efforts to bring awareness to this debilitating disease.

On a more somber note, she advised that as COVID-19 cases continued to rise in NJ, residents should continue to take the necessary precautions to thwart another possible outbreak.

Freeholder Staten reminded residents to complete their 2020 Census, if they had not done so already, as well as their mail-in ballots for the 2020 General Election. On another note, she advised that a mobile-testing unit would be in Roselle on October 24st, noting over 300 tests conducted on their first visit. She also advised that a flu-shot clinic would also be in Roselle on October 22, noting additional details would follow as the date approached. To close, she reminded residents about an upcoming food distribution drive at Cedar Brooke Park in Plainfield on October 3<sup>rd</sup>.

Chairman Mirabella recognized the continued efforts of the Board as well as the many residents of Union County during these difficult times. He also reminded residents to tune into the next virtual installment of the Queer Empowerment Hour, on October 14<sup>th</sup>, hosted by his daughter Micayla Mirabella. He also recognized Director of Digital, Web, and Social Media Services Robert Charkowsky for all his hard work in maintaining the county website, an invaluable resource to residents.
