CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:05 P.M.

ROLL CALL

Roll call showed, Chairman Alexander Mirabella, Freeholder Angela R. Garretson, Freeholder Sergio Granados, Freeholder Christopher Hudak, Freeholder Bette Jane Kowalski, Freeholder Andrea Staten, and Freeholder Rebecca Williams were present; with Freeholder Kimberly Palmieri-Mouded absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Deputy Clerk of the Board Annie Croom.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Deputy Clerk of the Board Croom.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Deputy Clerk of the Board Croom.

Chairman Mirabella addressed the public:

Good evening, and welcome to another remote meeting of the Freeholder Board.

Let's begin with congratulations for the candidates who won their seats in Tuesday's General Election. We are all looking forward to working with you in the coming year.

As is our custom, on behalf of the Freeholder Board I would also like to thank everyone in the Union County community for working together during the COVID-19 outbreak. Unfortunately, the danger is far from over. And so we continue to urge everyone to keep safe. Wear masks, observe social distance, and let's all keep our attention focused on protecting the Union County family.

With that in mind, I would like to remind everyone that Union County's free Drive-Through COVID-19 Test Center at Kean University in Union Township is now open every Monday, Wednesday, and Friday. Also, we are expanding the test panel, to include results for flu types A and B in addition to the COVID-19 virus, all on one swab. The new swab will only involve the lower part of your nostril, so

it's going to be a much more comfortable experience than before. That's great news for all of us. And, it will provide you with important information about your health status as the flu season gets under way. So please, take advantage of this important new resource.

We are also moving a new lab onto the Kean campus, which will enable us to turn the results around in as little as 24 hours or less. We expect the new lab to be up and running by early December. Union County's free Mobile Test Unit also continues to provide COVID tests on a walk-up basis, at locations throughout the County. They were in Westfield this afternoon, and they will be in Plainfield this Saturday, November 7. You can check our COVID website, ucnj.org/covid19, for upcoming dates.

For Union County residents in need of food assistance, our next drive-up food distribution event will be at Kean, beginning at 9:00 this Saturday morning. To help connect our residents with jobs, we are also hosting a virtual job fair on Zoom next Thursday afternoon, November 12. If you would like to connect with opportunities at Trinitas Hospital, Wakefern, Remarkable Foods, and Farmland Dairies, please sign up at ucnj.org/virtual-job-fair. Just a reminder, we also offer employment resources online through the Union County Works website, which you can find at ucajc.org.

And, we continue to use online resources to help the Union County family stay connected during the COVID outbreak. Coming up this Saturday is another installment of our "Virtual Saturdays" program for Union County families with special needs children.

And next Wednesday, November 11, we present the next episode of our virtual series on LGBTQ issues, Queer Empowerment Hour. As November 11 is Veterans Day, the theme of the episode is "being queer in the military," so please join us for a lively and thoughtful discussion. You can find more details about all of these programs on the County website, ucnj.org.

And to our military veterans, on behalf of the Freeholder Board, thank you for your service, and for all of your contributions to the Union County community.

There were no questions or comments by the Board.

Authorizing the County Manager to enter into an agreement with Edmunds & Associates, Inc., Northfield, NJ, to provide maintenance and technical support for the County's Financial Accounting and Electronic Requisition System for the period of January 1, 2021 through December 31, 2021, in an amount not to exceed \$21,205.00. (Chairman Alexander Mirabella)

DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT Joseph Graziano, Director

- 1. Amending Resolution Number 2010-964 adopted November 23, 2010 for a Professional Engineering Service Contract with Pennoni Associates Inc, of Newark, New Jersey for the Intersection Improvement Project at Rahway Avenue & Lamberts Mill Road and West Broad Street & Scotch Plains Avenue in Westfield, New Jersey to reflect a change in an account number only. (UC Engineering Project # 2010-017) (Chairman Alexander Mirabella)
- 2. Authorizing the County Manager to execute a Joint Funding Agreement with the United States Department of Interior, U.S. Geological Survey, Water Resources Division, West Trenton, New Jersey (Agreement Number 21LIJFA16) for the period of October 1, 2020 to September 30, 2021 for a sum not to exceed \$17,310.00. (Chairman Alexander Mirabella)

Freeholder Kowalski inquired about this item and whether or not this was an annual agreement.

Director Graziano confirmed this was an annual agreement totaling \$25,000, noting that the remaining balance was the responsibility of the Department of Interior - US Geological Survey. He advised that monies would cover stream gauges and data collection platforms used throughout the county, in particular in Rahway River running through Kenilworth, Rahway, and Springfield.

Amending Resolution Number 2018-686, adopted August 9, 2018, a Professional Engineering Service Contract with CME Associates of Monmouth Junction, New Jersey, to provide additional Licensed Site Remediation Professional Services (LSRP) related to the remediation of the former Trap and Skeet Facility at Lenape Park located in the Township of Cranford, in an amount not to exceed \$45,000.00 for a new contract amount not to exceed \$656,021.00 (Union County Engineering Project Number 2011-029). (Chairman Alexander Mirabella)

Freeholder Hudak inquired about the LSRP and the possibility of selecting an alternative LSRP.

County Counsel Bergen confirmed that the Licensed Site Remediation Professional would remain unless changes in positions occurred, noting it was preferred to maintain the same LSRP through the life of a given project. He added that costs would be billed against authorized reserved funding that would be replenished, as necessary, until the completion of the project.

Director Graziano added that the cited project had been in the works since 2014 with CME Associates and the same LSRP. He advised that the Department could consider alternate LSRPs moving forward. He further advised that the Department was also waiting on the Hazardous Discharge Site Remediation Fund (HDSRF), noting the site was used between 1925 and 2005 as a trap and skeet facility and he expected heavy contamination on site that would have to be addressed before it could be repurposed for public use.

4. Amending Resolution Number 2017-723 adopted September 14, 2017, a Professional Engineering Service contract with Hardesty & Hanover of New York, New York for the Replacement of Gordon Street Bridge over "Out of Service" Conrail Structure No. 2050150, located in the Borough of Roselle and Borough of Roselle Park, New Jersey for an amount not to exceed \$557,408.00 for a new contract amount not to exceed \$1,578,796.69. Funding in the amount of \$557,408.00 for this contract amendment will be provided by way of Transportation Trust Fund, TTF Swap –Funds Exchange Program and administered by the New Jersey Department of Transportation (NJDOT). (UC Engineering Project # 2011-051) (Chairman Alexander Mirabella)

Freeholder Hudak asked about funding for the project and approximately how long construction would last once the project commenced. He also requested additional details be provided as the project progressed, expressing concerns relative to potential traffic disruptions that could result from the project.

Director Graziano advised that the monies being used to fund the project would come from the Transportation Trust Fund and other bridge-related grants, confirming the County itself would not be funding the project. He further advised that The Brooks Act dictated policy for securing a vendor to provide the necessary services, noting only state-approved vendors could respond to the advertised bid notice. He confirmed that Hardesty & Hanover would serve as the final design engineer during construction. He added that an additional vendor would be secured for inspection, post construction, secured through the same, rigorous process. Director Graziano added that he expected the project to go out to bid in the winter, with construction schedule for the spring and summer of 2021, advising that he expected the project to take two years from start to finish.

Chairman Mirabella expressed similar concerns relative to the project and potential traffic disruptions as well as restricting access to neighboring towns.

5. Authorizing the County Manager to enter into an Agreement between the County of Union and the Township of Cranford for the installation of a Rectangular Rapid Flashing Beacon (RRFB) Pedestrian Crosswalk System on Walnut Avenue (CR-632) and Chestnut Street/Retford Avenue in Cranford, New Jersey. System will be purchased and maintained by the Township of Cranford. (Chairman Alexander Mirabella)

Freeholder Hudak inquired about the type of light being installed.

Director Graziano confirmed that it a standard rectangular light would be installed at the cited intersection.

Director Taylor confirmed this to be the case.

DEPARTMENT OF HUMAN SERVICES

Debbie-Ann Anderson, Director

- 1. Authorizing the County Manager to utilize the County's fifth option to extend the contract to Community Access Unlimited, Elizabeth, NJ through the competitive contracting process, to operate the Union County Children's Shelter for the period commencing January 1, 2021 through December 31, 2021, representing year five (5) of the five (5) year contract option, in the amount not to exceed \$410,000.00. (Freeholder Sergio Granados)
- 2. Authorizing the County Manager to utilize the County's fifth option to extend the contract to YWCA of Eastern Union County, Elizabeth, NJ through the competitive contracting process, to operate the Family Justice Center for the period commencing January 1, 2021 through December 31, 2021, representing year five (5) of the five (5) year contract option, in the amount not to exceed \$330,825.00. (Freeholder Sergio Granados)
- 3. Amending Resolution Number 2020-580 to increase funds for the Countywide Code Blue Emergency Shelter Initiative for the winter months of 2019-2020 by an additional amount not to exceed \$100,000.00 for the period of October 1, 2020 through December 31, 2020. (Freeholder Sergio Granados)

Freeholder Hudak asked Director Anderson if this initiative had incurred additional costs due to COVID-19. He also inquired about whether or not some of these costs could be covered by CARES ACT funding.

Director Anderson confirmed that additional costs had emerged due to COVID-19 and that the Department was in the process of looking to offset some of these costs with CARES ACT funding as well as increase capacity by securing additional locations to provide the service. She advised that there had been an increase in the homeless population due to COVID-19 and new protocols made it difficult to secure ample locations as well as place COVID-19 positive individuals within that population. She

noted that recently revised Code Blue guidelines required relative services to be available whenever the weather dropped below 32°.

Freeholder Kowalski expressed similar concerns relative to meeting the demands of housing the homeless population during COVID-19. She inquired about securing additional facilities, noting the use of churches in the past during exigent circumstances.

Director Anderson advised that many churches were unable to provide the necessary services due to COVID-19 and the subsequent restrictions. She added that the Department was looking for both in-county and out-of-county facilities to meet the demand, but noted potential increases in spending relative to out-of-county locations.

- 4. Authorizing the County Manager to enter into a contract with Pharma-Care Inc. Clark, NJ to provide pharmacy consulting services for the patients at Cornerstone Behavioral Health Hospital for the period of January 1, 2021 through December 31, 2021 in the amount not to exceed \$12,000.00. (Freeholder Rebecca Lynne Williams)
- Authorizing the County Manager to certify to the NJ Department of Human Services, Division of Mental Health Services that there have been no changes to the plan for delivery of mental health services and that the County of Union will continue to operate a psychiatric facility during the 2021 calendar year. (Freeholder Rebecca Lynne Williams)

Freeholder Staten asked Director Anderson to elaborate on this item.

Director Anderson advised that this initiative aimed to provide certain resources, including recovery coaches, treatment, and temporary housing for individuals struggling with addiction as well as legal challenges. She thanked Freeholder Hudak for his leadership and efforts relative to the initiative.

Chairman Mirabella thanked Director Anderson and her Department as well as the many volunteers for their efforts relative to the food distribution drives that have provided approximately 700,000 meals to residents in need.
