CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:28 P.M.

ROLL CALL

Roll call showed Chairman Alexander Mirabella, Freeholder Angela R. Garretson, Freeholder Sergio Granados, Freeholder Christopher Hudak, Freeholder Bette Jane Kowalski, Freeholder Kimberly Palmieri-Mouded, Freeholder Andrea Staten and Freeholder Rebecca Williams were present.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

APPROVAL OF COMMUNICATIONS

Chairman Mirabella called for a motion to approve Communications. On a motion made by Freeholder Williams and seconded by Freeholder Kowalski, roll call showed eight members of the Board voted in the affirmative.

ORDINANCE FOR ADOPTION

Clerk of the Board Pellettiere read Orfinance 821-2020 by title.

821-2020 AN ORDINANCE TO AMEND "THE LAWS OF UNION COUNTY:
ADMINISTRATIVE CODE AND POLICIES AND GENERAL
LEGISLATION" BY AMENDING: PART 1-UNION COUNTY
ADMINISTRATIVE CODE, CHAPTER 1, UNION COUNTY
GOVERNMENT STRUCTURE, ARTICLE XVI-DEPARTMENT OF
HUMAN SERVICES; CHAPTER 2, ADMINISTRATIVE LEGISLATION,
ARTICLE V-FISCAL PROVISIONS; AND, CHAPTER 49, FEES,
ARTICLE V-ENGINEERING & PUBLIC WORKS FEES.

BE IT ORDAINED by the Board of Chosen Freeholders of the County of Union that the "Laws of Union County" are hereby amended as follows, to be incorporated within the body of same upon updating and or reprinting of same:

- (A.) In each and every instance within the Laws that a gender specific pronoun is used (including but not limited to: his, her, his/her, his or her, him, him/her, him/herself, she, he, himself, herself), any such word that can be changed to a title or other noun specific to the circumstance, shall be so changed; in all other instances, the gender specific pronoun shall be changed to the appropriate non-gender specific pronoun (including but not limited to: they, them, their, themselves, theirs); and
- (B.) That effective January 1, 2021, in each and every instance within the Laws that the phrase Board of Chosen Freeholders, Chosen Freeholder, Freeholder or similar are used, they shall be changed respectively to Board of County Commissioners, County Commissioner, Commissioner or similar; and

BE IT FURTHER ORDAINED by the Board of Chosen Freeholders of the County of Union that the "Laws of Union County" are hereby amended as outlined in the attached Schedule A:

ARTICLE XVI, Department of Human Services

§ 1-97. Division of Outreach and Advocacy

[Amended 12-13-2018 by Ord. 802-2018]

- A. Under the direction and supervision of the Director of Human Services, the Division of Outreach and Advocacy functions and responsibilities shall include:
 - (1) Identifying and assessing the needs of community residents and identifying gaps in services in order to plan for and stimulate, in cooperation with governmental and voluntary agencies and citizens groups, solutions to address needs and assist residents to thrive.
 - (2) Implementing effective marketing, including consolidating and

- disseminating information through various forms that informs community residents of resources available.
- (3) Improving access to information and other resources through outreach, advocacy, referral, and case management.
- (4) Identifying areas in need of consumer and/or legislative advocacy to improve access to services and improve quality of life for residents of the County.
- (5) Assessing social service provision, workflow and efficiency, in an effort to improve consumer satisfaction.
- (6) Operate and maintain the Director's Action Line.
- B. Division head. There may be a Director of the Division of Outreach and Advocacy who serves as the head of the Division and shall be responsible to the Director of the Department of Human Services for its operation.
- C. Subdivisions. Within the Division of Outreach and Advocacy shall be the following subdivisions:
 - (1) Office of Human Services Constituent Relations (OHSCR)
 - (2) Office of Analytics, Research and Evaluation (OARE)

D. Office of Human Services Constituent Relations (OHSCR)

No Change

E. Office of Analytics, Research and Evaluation (OARE)

- (1) Under the direction of and supervision of the Director of the Division of Outreach and Advocacy, the Office of Analytics, Research and Evaluation's (OARE) functions and responsibilities include:
- (a) Conducts research to produce community-ready information about the work of DHS
- (b) Advises and supports the department's technology planning and implementation
- (c) Supports policy development, quality improvement, planning and decision- making through research, analysis and engagement.

Chapter 2, ADMINISTRATIVE LEGISLATION

ARTICLE V, Fiscal Provisions

[Amended 4-10-2003 by Ord. No. 569]

§ 2-38. Central payroll.

[Amended 1-30-1992 by Ord. No. 358]

Salaries, wages and other compensation of exclusionary employees of the County shall be paid semi-monthly, i.e., payment to be made on the 15th and 30th of each month or the last business day prior thereto. Salaries, wages and other compensation of members of collective bargaining units shall be paid as set forth in their respective negotiated agreements. The head of each department, office or agency shall certify to the Department of Finance, at such times and in such form as it shall prescribe, the names and positions of all persons employed in or by the department who are entitled to be paid in the next ensuing payroll for the County. The comptroller shall then complete a central payroll for the County.

§ 2-39. Advance Payment for Travel

The County of Union does hereby authorize the payment of advances to officers and employees towards their expenses for authorized official travel and expenses incident thereto. Such payment will only be made upon the verification and adjustment of such expenses and advances, and the repayment of any excess advanced, by means of a detailed bill of items and the certification of same, pursuant to procedures established by the Department of Finance. Any such certification or affidavit shall be submitted within 10 days after the completion of the travel for which any advance was made.

§ 49-9. Tipping Fees Charged to Municipalities for Leaf Disposal.

The following fees are hereby established for individual municipalities to be charged when utilizing the County of Union Compost Facility:

- A. Tipping Fee of \$4.00 per cubic yard of un-compacted leaves accepted for composting at the County of Union Compost Facility;
- B. Tipping Fee of \$6.00 per cubic yard of compacted leaves accepted for composting at the County of Union Compost Facility.

PUBLIC HEARING

The meeting was open for the purpose of commenting on Ordinance Number 821-2020 only.

Bruce Paterson, of Garwood, asked for additional information relative to the changes being made.

Counsel Bergen noted several changes being made by the cited ordinance, including: establishing an office of analytic research for human services to improve efficiency; codify advance payment for work-related travel in accordance with existing state law; increase in shared services compost facility fees for leaf disposal. He also noted that the ordinance would replace gender-specific pronouns with gender-neutral pronouns as well as officially recognize the term Freeholder in place of Commissioner.

Clerk Pellettiere confirmed there were no additional public comments or questions on Ordinance No. 821-2020.

FINAL READING STATEMENT

Freeholder Rebecca Williams, Policy Committee Chair, moved Ordinance Number 821-2020 for Final Reading and authorized the Clerk of the Board to advertise same in accordance with the law.

On a motion made by Freeholder Williams and seconded by Freeholder Kowalski, roll call showed eight members of the Board voted in the affirmative.

SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Freeholder Williams and seconded by Freeholder Hudak roll called showed eight members of the Board voted in the affirmative.

PUBLIC COMMENT PORTION

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

Laurel Brennan, Secretary Treasurer of NJ State AFL CIO, spoke relative to Reso No. 2020-850 and We Are One New Jersey and thanked the Board and County for their invaluable partnership and continued support. She expressed the importance of such an initiative for individuals seeking American Citizenship.

She closed by wishing everyone a Healthy New Year, noting that she looked forward to continuing the great work with the support of the new Presidential Administration and their focus on immigration.

Bruce Paterson, of Garwood, expressed his concerns relative to Acting Prosecutor Lyndsay Ruotolo and Reso Nos. 2020-859 & 864. He also inquired about how many employees would be affected by Reso No. 2020-823 and how much money was involved. Relative to Reso No. 2020-825, Mr. Paterson made comments relative to the cited vendor and asked why these additional parking spots were necessary. Regarding Reso No. 2020-830, he asked if Scotch Plains reimbursed the County for operational expenses. Lastly, relative to Reso Nos. 2020-842, 2020-843, 2020-844, Mr. Paterson asked why three firms were necessary to furnish the cited service.

Relative to Reso Nos. 2020-859 & 864, relative to Acting Prosecutor Lyndsay Ruotolo, Chairman Mirabella expressed his and the Board's confidence in her qualifications and ability to execute the demands of the job. He also clarified what gender-neutral pronouns were, noting him/her as an example.

Relative to Reso No. 2020-823, Director Taylor advised that this Resolution would allow employees to sell back accrued 2019 Vacation Time, up to 20 days. She further advised that due to COVID-19, many employees had been unable to use their accrued time and would otherwise lose that time in 2021. She confirmed a total of 69 employees would be affected by this resolution, with a monetary NTE cap of \$393,000.

Relative to Reso No. 2020-825, County Manager Oatman advised that this item was an annual expense and was necessary to accommodate Social Services' employees.

Relative to Reso No. 2020-830, Recreational Facilities Division Director Armando Sanchez confirmed that Scotch Plains did reimburse the County for operational expenses and management fees for KemperSports. He added that any revenue in excess of the requested amount, in this case \$320,000, would go to Scotch Plains.

Relative to Reso No. 2020-842 & 844, Counsel Bergen advised that due to the volume of people employed by the County, multiple law firms were needed to handle varying labor and personnel matters.

Edward "Lefty" Grimes spoke relative to the Watchung Reservation and advised that a link for the virtual tour of the area on the County website was not functioning and the resource could not be accessed. He requested the Board look into the issue and resolve it as a means to provide some type of virtual recreational outlet for residents, in particular, residents with alternative needs, during COVID-19.

Chairman Mirabella and County Manager Oatman confirmed that the County's IT Department was looking into the issue and hoped to resolve it soon. They thanked Mr. Grimes for bringing this issue to the Board's attention.

Jamie Van Schiber (spelling) expressed her concerns relative to the virtual, and in her opinion, informal formatting of the Freeholder meetings in light of COVID-19. She also spoke relative to the Watchung Reservation virtual tour resource that was non-functional at present time. She noted the importance of access to these and other resources as a means to give people an outlet during these difficult times. She closed by noting the importance of considering and attempting to include the differently abled and those with alternative needs, who often need specialized resources and assistance that has not always been possible or furnished during COVID-19.

Chairman Mirabella thanked Ms. Schiber for her comments, noting that although virtual meetings were not ideal, they allowed for the County to conduct essential business with an emphasis on safety for the general public and staff. He advised that the County would continue to observe the guidelines set forth by the State of NJ as they continued to navigate these unprecedented circumstances.

Clerk Pellettiere confirmed there were no additional public comments
