THURSDAY, MAY 21, 2020 AGENDA SETTING MEETING MINUTES

CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:03 PM

ROLL CALL

Roll call showed, Chairman Alexander Mirabella, Freeholder Angela R. Garretson, Freeholder Sergio Granados, Freeholder Christopher Hudak, Freeholder Bette Jane Kowalski, Freeholder Kimberly Palmieri-Mouded, Freeholder Andrea Staten, Freeholder Rebecca Williams were present; with Vice Chairman Angel G. Estrada absent.

Also present were County Manager Edward T. Oatman, County Counsel Robert E. Barry, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

Chairman Mirabella addressed the public:

Good evening, and welcome to another remote meeting of the Freeholder Board. We have convened tonight's meeting remotely, in order to observe the strictest precautions for preventing the spread of the COVID-19 virus.

As is our custom, we begin with heartfelt thanks for the countless thousands of Union County residents, who are working together in a common cause, looking out for one another, and taking care of each other during this time of crisis.

I want to emphasize that includes everyone in the Union County family: those of you who are staying home, wearing masks, and observing the social distance guidelines; those of you who have continued to work providing groceries, medicines, and other essential goods and services; our emergency responders and front line health workers; and those of you who have donated food, medical supplies, financial assistance, and more. In so many different ways, you have all contributed to the progress that we have seen in recent weeks. And so, I encourage you to keep up the good work as we gradually, and carefully, re-start selected County services.

First, I am happy to announce that County parks will continue to be open for passive recreation including walking, jogging, and hiking. In accord with state guidelines, park visitors must continue to observe the six-foot social distance standard.

And, and masks are strongly recommended. I am also very proud to say that we will observe our time honored Memorial Day tradition, of placing flags on the gravesites of our military veterans. This will be one in accord with guidelines to prevent the spread of the virus.

Memorial Day holds a special place in our hearts. It is a very good feeling to know we will be able to honor the memory of those who served, just as we have done in years past.

At this time I can also announce the return of our free recycling programs. The Household Hazardous Waste recycling events will resume on Saturday, June 6.Scrap metal will resume on June 20.And, and shredding events for personal papers will begin on June 27.

Masks will be required, and there will be other modifications to prevent the spread of COVID-19. You can check the County website for all the details.

Before we begin tonight's meeting, I would like to recognize the hundreds of workers, volunteers, partners and businesses who have kept the Union County Drive-Through Test Center at Kean University up and running. To date, we have conducted more than 18,000 tests for Union County residents with symptoms of COVID-19, free of charge. That figure also includes hundreds of emergency responders and front line heath workers throughout New Jersey. This week, we have expanded the testing program.

As of this past Monday, the Test Center is open to all Union County residents, even if you have no symptoms and it continues to be free. We also set up a new online portal to book an appointment, which you can find on the County website at ucnj.org or you can make an appointment over the phone, by calling 908-214-7107. If you think you have been exposed to the virus, or if you have any other reason to be concerned, please do not hesitate to make use of this important resource.

In addition, we have also been marshalling food donations for hundreds of families in need. And, we are distributing 100,000 surgical masks to the 21 municipalities, based on priorities that they identify. We will continue working together with our partners, to ensure that we all pull through this crisis together, as a community.

So let's all redouble our commitment to stay the course and keep encouraging each other in the weeks ahead. As we take careful steps to re-start, let's make sure that we all keep social distance, keep wearing masks, and keep working to protect each other.

With that, just a reminder that tonight will begin with an Agenda meeting, to be followed by a Regular meeting. We will have an official Public Hearing on the 2020 Union County budget during the Regular meeting.

OFFICE OF THE BOARD OF ELECTIONS

Nicole DiRado, Administrator

1. Amending Resolution 2019-239 a contract awarded to ES&S, Omaha, Nebraska, to reflect onsite personnel support services provided during the 2019 General Election day. (Chairman Alexander Mirabella)

Freeholder Kowalski inquired about the services being provided by the vendor.

Administrator DiRado advised that this item related to an amendment to a prior resolution, adding that support services would include on-site assistance related to vote tabulation of mail-in and provision ballots as well as poll station on-site support to assist with the new voting machines. Administrator DiRado further advised that she had anticipated the same level of on-site support, in particular as it relates to vote by mail ballots. She noted that she had requested the rental of a third tabulation machine to contend with the increase in mail in ballots relative to COVID-19. She noted the tremendous and critical support offered by the vendor with their extensive knowledge relative to the software and equipment being used.

Freeholder Hudak inquired about changes to the contract relative to COVID-19 and additional expenses that could result moving forward, noting that some of these expense increases would qualify for reimbursement through the federal Care Act. He made comments relative to the one machine per polling location, and it being be employed for the Primary Election to accommodate limited voting relative to ADA guidelines.

Administrator DiRado advised that she did not anticipated an increase in the 2020 contract. She advised that COVID-19 had created many challenges, including the training of poll workers particularly with the new machines to ensure they have the necessary experience and resources to be successful on Election Day. She noted one of the particular challenges of having a single machine per polling location was that poll workers would be responsible for adjusting ward and district information for each individual voter. She noted that despite these challenges, on-site support would not increase. She also noted that the third tabulation machine that was ordered did qualify for a reimbursement under the Care Act, but there was no guarantee that funds would stretch that far once all claims were made.

Freeholder Granados mentioned the consequential increase in mail-in ballots relative to COVID-19, noting the need for an additional tabulation machine to contend with greater volume. He inquired about the polling locations and ADA accessibility.

Administrator DiRado noted that polling locations would be primarily reserved for those that are visually impaired and require assisted hearing. She added that disabled voters would be required to certify that they cannot vote on a paper ballot. She advised that polling locations would also provide services to those wishing to vote provisionally or for a party differing from their affiliation.

2. Authorizing the County Manager to enter into an agreement with ES&S, Omaha, Nebraska, for the purposes of providing onsite Election Day support for the year 2020 in an amount not to exceed \$40,000. (Chairman Alexander Mirabella)

DEPARTMENT OF ECONOMIC DEVELOPMENT

Amy Wagner, Deputy County Manager/Director

There were no questions or comments from the Board.

- 1. Authorizing the County Manager to award funding for the 2020 Infrastructure and Municipal Aid Grant Program in an amount not to exceed \$1,500,000.00 to the twenty-one (21) municipalities in the County of Union. (Chairman Alexander Mirabella)

(Chairman Alexander Mirabella)
- 2. Resolution authorizing aerial dispensing operation county-wide by the Union County Bureau of Mosquito Control. (Freeholder Andrea Staten)

Freeholder Hudak inquired about whether or not the spraying schedule would be altered due to most people being home as a result of the stay-at-home order.

Director Graziano advised that the spraying schedule would not change as the chemical being used did not pose a danger to humans or animals. He added that this type of spraying was reserved to combat things like the EEE outbreak that occurred in Berkeley Heights last year, not for generic spraying.

Freeholder Palmieri-Mouded asked when the spraying would begin.

Director Graziano advised that no plan was currently in place as no outbreaks had been reported. He noted that now was the prime season for mosquitos, and the situation would likely escalate as the warmer months moved in and if necessary, the resource would be used.

Freeholder Kowalski asked whether or not the department was still checking troubled areas for mosquito breeding. She added that residents were always encouraged to report hot spots so that they could be addressed.

Director Graziano confirmed that the serviced of checking breeding areas was essential and the department continued to inspect brooks and properties with resident approval for hot spots as well as set light traps.

DEPARTMENT OF FINANCE

Bibi Taylor, Director

DEPARTMENT OF HUMAN SERVICES

Debbie-Ann Anderson, Director

1. Authorizing the County Manager to apply for, accept and execute the FY2020 Community Services Block Grant (CSBG) COVID-19 CARES Act funding in the amount of \$430,446 from NJ Department of Community Affairs (NJDCA) for the grant period of April 1, 2020 through September 30, 2022 for the purpose of providing community programming for low income residents of Union County, and would also recognize and accept that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from NJDCA, does further authorize the execution of any such agreement. (Freeholder Sergio Granados)

Freeholder Garretson asked how the funds would be spent.

Director Anderson advised that the first installment was about 35% of the CSBG funding and would be directed towards rental and utility assistance as well as food pantries and emergency shelters, among other resources. She added that residents living within 2% of the poverty line would qualify for these funds as well as undocumented residents. She added that the second installment would be greater than the first as the county expected to receive approximately \$1.2 million under the initiative.

2. Amending Resolution 2020-189, extending a contract to Prevention Links of Roselle for professional services in the form of licensed clinical alcohol and drug counselors (LCADC) to provide clinical assessment, referral and program compliance for the Intoxicated Driver Resource Center (IDRC), to further extend the contract by two (2) months for a new contract period of January 1, 2020 through June 30, 2020, and to reflect additional contract dollars in the amount of \$12,015 for a new contract total not to exceed \$43,015. (Freeholder Sergio Granados)

Freeholder Hudak noted the receipt of these funds and inquired as to whether or not the state would be considering a reduction in monies moving forward as municipal revenue had been somewhat halted due to COVID-19.

Director Anderson noted that she had been advised by the Municipal Alliance that funding has been frozen as of now and municipalities had been instructed to avoid any expenditures until additional guidance had been received. She added that IDRC had been authorized and was working on a way to develop a virtual program to prevent additional delays that could result from COVID-19.

Freeholder Hudak asked if the upcoming format would be used moving forward.

Director Anderson advised that there was a strong possibility that these programs would be done virtually in the future.

DEPARTMENT OF PUBLIC SAFETY

Andrew Moran, Director

1. Authorizing the County Manager to enter into a Memorandum of Agreement for Tuberculosis Services with the New Jersey Medical School Global Tuberculosis Institute for a one-year period from January 1, 2020 through December 31, 2020 in an amount not to exceed \$89,624.94. (Freeholder Angela R. Garretson)

Freeholder Granados inquired about the shared services agreement, noting the many benefits of such an initiative.

Director Moran noted that a contract had been signed with Rutgers to provide tuberculosis (TB) services to Union County. He added that under the shared services agreement the county would be responsible for half of the cost and the town would fund the remaining cost. He advised that the cited funds would cover a nurse's salary for the facility.

On another note, Granados recognized Director Moran, his staff, and the volunteers at the Kean Testing Center for celebrating a National Guard member's graduation and making her day special.

Director Moran commended the testing center volunteers for coming together to make this event special. He added that a cap and gown had been provided and the student was clapped in while family members tuned in through Skype.
