THURSDAY, AUGUST 13, 2020 REGULAR MEETING MINUTES

CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:55 P.M.

ROLL CALL

Roll call showed Chairman Alexander Mirabella, Vice Chairman Angel G. Estrada, Freeholder Angela R. Garretson, Freeholder Sergio Granados, Freeholder Christopher Hudak, Freeholder Bette Jane Kowalski, Freeholder Kimberly Palmieri-Mouded, Freeholder Andrea Staten, and Freeholder Rebecca Williams were present.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

Chairman Mirabella called for a motion to approve Communications. On a motion made by Freeholder Garretson and seconded by Freeholder Williams, roll call showed nine members of the Board voted in the affirmative.

Chairman Mirabella called for a motion to approve the Minutes. On a motion made by Freeholder Williams and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative for the Minutes of June 4th, July 9th, and

July 23 Agenda Setting and Regular Meetings respectively; and eight votes in the affirmative for the Minutes of June 18th Agenda Setting and Regular Meeting, with Freeholder Staten abstaining.

ORDINANCE FOR INTRODUCTION

Clerk Pellettiere read the Ordinance by title.

817-2020 CAPITAL ORDINANCE OF THE COUNTY OF UNION, NEW JERSEY AUTHORIZING THE DEMOLITION OF THE EXISTING COUNTY PARKING DECK ON ELIZABETHTOWN PLAZA AND THE CONSTRUCTION OF A NEW PARKING DECK ON SUCH SITE IN, BY AND FOR THE COUNTY, APPROPRIATING THEREFOR THE SUM OF \$13,500,000 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM CAPITAL SURPLUS OF THE COUNTY.

FIRST READING STATEMENT

Freeholder Sergio Granados, Fiscal Chairman, moved Ordinance Number 817-2020 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The public hearing and final reading is scheduled to be held on September 3, 2020.

On a motion made by Freeholder Granados and seconded by Freeholder Hudak, roll call showed nine members of the Board voted in the affirmative.

SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Freeholder Williams and seconded by Freeholder Palmieri-Mouded, roll called showed nine members of the Board voted in the affirmative.

PUBLIC COMMENT PORTION

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

Clerk of the Board Pellettiere noted he had received email correspondence from Judith Martinez, of Scotch Plains and read her comment into the record.

Judith Martinez expressed her disapproval with the *Black Lives Matter* murals in Hillside and Roselle and questioned the Board's support of an organization with alleged ties to Marxism and the respective ideology.

Chairman Mirabella noted that he appreciated Judith's opinion, but disagreed with the claim that BLM was in any way associated with a Marxist regime, noting the Board's unequivocal support for the BLM movement.

Bruce Paterson, of Garwood, made comments relative to several Resolutions. Relative to Reso Nos. 2020-584 and 2020-590, Mr. Paterson asked for greater detail relative to spending and inquired about the vendor's administration fee. Relative to Reso No. 2020-588, he asked about the cited service and how much of the funding would be consumed in administrative fees. Relative to Reso No. 2020-605, Mr. Paterson asked why County employees had been tasked with making Census calls instead of hiring individuals that were facing unemployment. Relative to Reso No. 2020-609, Mr. Paterson made comments relative to the expected savings from the project. Relative to Reso No. 2020-605, he asked why County Counsel and the respective staff could not undertake the task. Relative to Reso No. 2020-601, he expressed his concern with the overdevelopment of luxury housing in various municipalities that did not include affordable housing units. Relative to Reso No. 2020-602, he made comments about what he perceived as double funding.

Relative to Reso No. 2020-584, Director Anderson advised that funds would be used to sanitize and sterilize two shelters in Union County so they could remain open and continue to function. She further advised that the vendor was not receiving an administration fee and that the expense was reimbursable through FEMA.

Relative to Reso No. 2020-590, Director Anderson advised that the increase was furnished through the Homeless Trust Fund account facilitated by the County Clerk's filing fees. She noted an increase in demand relative to COVID-19 and the subsequent restrictions. She confirmed that the vendor was a non-profit organization and would receive a 5% administration fee.

Relative to Reso No. 2020-588, Chairman Mirabella recognized the tremendous contributions of the organization and the program, noting that the garden grants would allow for various schools and municipalities to establish gardening resources.

Open Space Trust Fund Administrator Durbin-Drake, advised that 20% of funding would go towards administrative fees. She noted that due to COVID-19, funding had been interrupted and the future of the program was still uncertain as state mandates and restrictions were still in place and schools were not open. She added the allotted \$106,000 had not been spent.

Chairman Mirabella commended Freeholder Granados for being instrumental in the initiative and its subsequent success.

Freeholder Granados noted that funding covered the necessary supplies and materials for the gardening project.

Relative to Reso No. 2020-605, County Manager Oatman advised that existing County personnel had been repurposed to conduct Census calls during the COVID-19 pandemic as a means to adhere to state social distancing guidelines and utilize employees working remotely. Relative to Reso No. 2020-609, County Manager Oatman noted that a financial analysis had been done that considered construction and all the associated costs on a new complex in comparison to the rental payments on the currently leased properties. He added that the analysis concluded that the former was the most practical and cost-effective option and determined the approximate savings of \$120 million in 30 years.

Relative to Reso No. 2020-605, County Manager Oatman advised that the firm would be paid the same fee as other outside counsel and would be relied on heavily to navigate through CARES ACT funding and spending, noting that approximately a 1/10 of CARES ACT funding was being used to fund this invaluable resource. He added that as the situation with COVID-19 developed, the County would continue to depend on the firm for guidance to ensure spending compliance.

Relative to Reso No. 2020-601, Deputy County Manager Wagner advised that the county had no control over these developments as they were part of an agreement established between the respective municipalities and the state. Relative to Reso No. 2020-602, she noted that this was a highly regarded initiative and that potential owners had a vested interest in the property as they would be expected to participate in the building and improvements of the units they would later occupy.

Clerk of the Board Pellettiere confirmed that no other public participants were in the cue and that he had received no additional correspondence from any member of the public.

GARRETSON: Authorizing the County Manager to enter into a contract with Training Specialties Inc., Exton, Pennsylvania, to provide Foam Tender Training for the departments in the Urban Area Security Initiative (UASI) region, through the 2017 UASI grant, in an amount not to exceed \$13,500.00.

2020-576 FREEHOLDER SERGIO GRANADOS: Resolution modifying the 2020 Union County adopted budget in the amount of \$50,000.00 as a result of notification received from the State of New Jersey, Department of Community Affairs for a program entitled: LEAP Fellowship Grant.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-577 FREEHOLDER SERGIO GRANADOS: Resolution modifying the 2020 Union County adopted budget in the amount of \$71,976.00 as a result of notification received from the State of New Jersey, Department of Human Services, Division of Aging Services for a program entitled: Area Plan Contract (APC).

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-578 FREEHOLDER SERGIO GRANADOS: Resolution modifying the 2020 Union County adopted budget in the amount of \$331,000.00 as a result of notification received from the State of New Jersey, Department of Health for a Program Entitled: Local Information Network Communications (LINCS) Grant.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-579 FREEHOLDER SERGIO GRANADOS: Resolution modifying the 2020 Union County adopted budget in the amount of \$48,205.00 as a result of notification received from the State of New Jersey, Department of Health and Middlesex County for a program entitled: Comprehensive Cancer Control Grant.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-580 FREEHOLDER SERGIO GRANADOS: Amending Resolution Number 2019-917 to increase the amount payable to In Town Motor Lodge, Morris Avenue, Elizabeth, NJ, a for-profit vendor of the Code Blue Emergency Shelter Initiative, will now exceed the Pay to Play threshold of \$17,500.00 with requirement of properly executed pay to play disclosures. This request is directly related to the increase in

the number of homelessness due to the Shelter in place order due to the COVID-19 Pandemic which will provide shelter assistance to individuals and families for TANF, GA, and/or emergency assistance recipients for the period of July 23, 2020 through December 31, 2020. There is no change in the total amount of funds and no other for-profit vendor is yet also authorized to exceed the pay to play threshold.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-581 FREEHOLDER SERGIO GRANADOS: Amending Resolution 2020-513, a contract with Mutual of America, Parsippany, New Jersey, for the implementation of an employee 401(a) benefits plan for county employees not covered under the Public Employee Retirement System (PERS), to reflect an adjustment to an appropriation account with no change in the total amount of the contract or terms.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-582 FREEHOLDER SERGIO GRANADOS: Amending Resolution Number 2020-514, a contract with Mutual of America, Parsippany, New Jersey, for the provision of Group Life Insurance with Group Accidental Death and Dismemberment Plan for employees not covered under the Public Employee Retirement System (PERS), to reflect an adjustment to an appropriation account with no change in the total amount of the contract or terms.

2020-584 FREEHOLDER SERGIO GRANADOS: Amending Resolution Number 2020-337 adopted on 4/23/2020, to reflect a four-month extension of the grant term through December 31, 2020 and award additional funds not to exceed \$236,128.00 for The Gateway Family YMCA to support emergency shelter operations as a result of COVID-19 expenses.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-585 FREEHOLDER SERGIO GRANADOS: Amending Resolution Number 2019-964, a contract awarded to Family Promise, Summit, NJ to increase the contract award in the amount of \$25,000.00 for a new total amount of \$125,000.00, with no other change in terms.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-586 FREEHOLDER SERGIO GRANADOS: Authorizing the County Manager to enter into a maintenance agreement with Visual Computer Solutions, Inc., of Freehold, NJ in an amount not to exceed \$8,767.50 to maintain the Division of Social Services' Time Management System/Time Clock for the period of September 1, 2020 through November 30, 2020.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-587 FREEHOLDER SERGIO GRANADOS: Authorizing the County Manager to award a contract to Community Access Unlimited, Elizabeth, New Jersey to promote youth, teen, and community development through prevention programs including self-empowerment and youth leadership, Interfaith initiatives and collaboration among community programs for youth and families for the period of August 1, 2020 through December 31, 2020 in the amount of \$50,000.00.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-588 FREEHOLDER CHRISTOPHER HUDAK: Authorizing the County Manager to exercise the third and final option to extend the contract pursuant to Resolution Number 2017-115 to Groundwork Elizabeth, Elizabeth, NJ for continuation of the administration and implementation of the Community Garden Grant in the amount not to exceed \$56,000.00, and continued administration of the Union County Kids Dig In!: A School Garden Grant Program in an amount not to exceed \$50,000.00 both encompassed under the grant program entitled: "Union County Plant A Seed Grant Program" for the period of January 1, 2020 through December 31, 2020, for a total amount not to exceed \$106,000.00.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-589 FREEHOLDER KIMBERLY PALMIERI-MOUDED: Authorizing the County Manager to award the proposed contract extension originally obtained through advertised public bidding (BA#32-2018) in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Department of Engineering, Public Work & Facilities, Division of Facilities Management, New Jersey Overhead Door, Bayville, NJ for the purpose of providing Overhead Door & Gate Systems Service, twenty-four (24) consecutive months from August 31, 2020 through August 30, 2022, in an amount not exceed \$124,700.00.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-590 FREEHOLDER KIMBERLY PALMIERI-MOUDED: Amending resolution 2020-284 adopted on 3/26/2020 to reflect additional grant dollars in the amount of \$31,925 to Family Promise-Union County for a new total overall amount not to exceed \$190,736.00 as outlined in the attached spending plan; with no change to the grant term.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-591 FREEHOLDER ANDREA STATEN: Amending Resolution Number 2019-963 to reduce the initial grant award for the FY2021 Municipal Alliance to Prevent Alcoholism and Drug Abuse program in the amount of \$372,451.00, to change the grant period to October 1, 2020 through June 30, 2021 and to execute contracts based upon a revised Spending Plan.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-592 FREEHOLDER ANDREA STATEN: Amending Resolution Number 2019-918 to reflect a reduction in NJ Governor's Council on Alcoholism and Drug Abuse (GCADA) funds by \$372,451.00, and to reflect a revised grant period of October 1, 2020 through June 30, 2021 for the FY2021 Alliance to Prevent Alcoholism and Drug Abuse Program.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-593 FREEHOLDER ANDREA STATEN: Authorizing the County Manager to award FY2021 One-Time Alcohol and Drug Abuse Innovative (ADAI) funding in an amount not to exceed \$169,574 to CURA, Inc., from September 1, 2020 through August 31, 2021 and further authorizing the County Manager to terminate funds during the contract period if the listed agency fails to meet contractual obligations.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

and disability monitoring services for one 24-month period. Contract shall lead to reductions in cost for the self-insured health plans of the County. Fees shall be paid only when savings have been certified to occur in an amount not to exceed \$50,000.00 for the 24-month period.

On a motion made by Freeholder Granados and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

2020-600 CHAIRMAN ALEXANDER MIRABELLA: Authorizing the County Manager to amend Resolution 2019-447 dated May 23, 2019 approving the Year 45 2019-2020 Annual Action Plan to include additional CARES Act Funding for ESG, and to apply for and receive funds through the Department of Housing and Urban Development 2019-2020 Substantial Amended Annual Action Plan (Year 45) including the Community Development Block Grant Program and Emergency Solutions Grant Program application for HUD CARES Act Funds. In response to COVID-19 the Federal Coronavirus Aid, Relief, and Economic Security Act (CARES) allocated an additional \$2,770,145.00 to the County's CDBG program

(CDBG-CV) and \$3,359,923.00 to the County's Emergency Solutions Grant Program for a revised total of \$6,130,068.00.

2020-601 CHAIRMAN ALEXANDER MIRABELLA: Authorizing the County Manager to award a contract to Elmwood Square Urban Renewal LLP in the amount for \$500,000.00 of HOME Funds, for the development of five (5) Low Income Units (58 total) in Plainfield. Funds will be used from repayment of Center for Hope Hospice project.

2020-602 CHAIRMAN ALEXANDER MIRABELLA: Authorizing the County Manager to accept HOME Investment contract reassignment for Habitat for Humanity of Greater Plainfield and Middlesex County (GPMC) to Morris Habitat for Humanity, INC (MHfH). The merger is to alleviate some financial restraints currently on GPMC operations and will continue to assist Union County residents in the purchasing of affordable single family homes, for the contract period of August 1, 2017 through July 31, 2021 (Year 42), in an amount not to exceed \$280,000.00.

FREEHOLDER REPORTS AND COMMENTS

Freeholder Palmieri-Mouded spoke relative to the COVID-19 mobile testing units facilitated by the County, reminding Westfield residents that a unit would be visiting Tamaques Park the following week to administer testing. She noted her pride in the Union County family and her fellow Board members for their leadership in progressive ideals. She commended the Board's achievements as they relate to the creation of the LGBTQ Office and the erection and continued operation of the Kean COVID-19 Testing Center. She noted the Board's support for the BLM movement and the respective murals in Hillside and Roselle, noting the rich diversity of Union County.

On another note, Freeholder Palmieri-Mouded commended the County's management of CARES ACT funding and the respective expenditures, noting the importance of providing financial assistance to schools, libraries, and small businesses that continue to suffer as a result of COVID-19 and the subsequent restrictions. She closed by recognizing all the parents throughout the county, offering her best wishes as they navigate through tough schooling decisions.

Freeholder Kowalski recognized County Manager Oatman, Deputy County Manager Wagner, and the Departments of Public Safety and Public Works for their efforts in addressing the power outages and other issues that arose as a result of the recent storm. He recognized Patrick as a charitable and dedicated community servant/advocate; a staple in the Irish-American community and a supportive husband.
