ELECTION OF A CHAIR OF THE 2021 BOARD OF UNION COUNTY COMMISSIONERS

The first order of business was the election of a Chair.

The Clerk of the Board called for a nomination for the election of a Chair Pro-Tem of the Board of Chosen Commissioners for the year 2021.
