CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:03 P M

ROLL CALL

Roll call showed, Chairman Alexander Mirabella, Vice Chair Rebecca Williams, Commissioner Angela R. Garretson, Commissioner Christopher Hudak, Commissioner Bette Jane Kowalski, Commissioner and Kimberly Palmieri-Mouded, were present; with Commissioner Sergio Granados, Commissioner Lourdes M. Leon, and Commissioner Andrea Staten absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

Chairman Mirabella addressed the public:

Good evening, and welcome to another remote meeting of the Commissioner Board.

We have a lot of ground to cover tonight, so I'll begin with some brief updates on our COVID-19 testing and vaccination programs. Starting this week, we converted the Test Center at Kean University from a drive-through to a walk-up site and our staff will show you how to take a nasal swab sample yourself; it's easy, and it's convenient. The site is open every Monday and Tuesday morning, and you can make an appointment online at ucnj.org/covid19. You can also visit on a drop-in basis.

On vaccination, we are now offering the Pfizer vaccine to ages 12 and up, and the Moderna for ages 18 and up, at our countywide vaccination sites. If you work during the week, you can get the Pfizer vaccine in Plainfield this weekend, at our free clinic at Plainfield High School, 950 Park Avenue. It will be open on

Saturday, May 22 from 10:00 a.m. to 1:00 p.m. Visit ucnj.org/vax to make an appointment or call 908-613-7VAX.

Also, on Tuesday we offered the Johnson & Johnson vaccine to residents during our emergency food distribution event at Warinanco Park. It's part of our efforts to reach everyone in Union County with a vaccine, and we were really encouraged by the results. I would like to thank PSE&G, WellCare, and the Community FoodBank of NJ for coming to the event with their teams, to offer additional assistance.

Turning now to other business, I am very happy to report that the renovation of the Ulrich Memorial Pool complex in Rahway River Park is complete. The pool will open for the season, on Memorial Day Weekend.

We are also continuing our drive-in concerts and movies. The schedule is on the County website at ucnj.org/calendar, and remember to reserve online at <u>ucnj.org/reserve</u>.

And finally, with Graduation Season is upon us, I wanted to take a moment to congratulate all those who have - or will be - participating in their graduation ceremony. Along with their academic excellence, 2021 Graduates have certainly shown their resiliency during this covid-19 pandemic, and deserve to be commended on their accomplishment!

To that end, I would be remiss, if I didn't take a moment to congratulate our colleague - DR. Angela Garretson - on her commencement from both Rutgers-Newark AND NJIT this past weekend; where she graduated with a PH.D in Educational policy.

And now, let's turn to the business of tonight.

PRESENTATIONS BY THE BOARD

A presentation to the Board was made by the Office of Veteran Services relative to the County's recognition as a "We Value Our Veterans" Employee, a note of significance as the County celebrates "Military Appreciation" Month, followed by a video presentation made to the Board by the Honorable Governor Phil Murphy relative to the County's recognition as a "We Value Our Veterans" Employers Award.

Deputy County Manager Wagner noted that it was her pleasure to present the "We Value Our Veterans" Community Award presented to the County of Union by the state in recognition of the many strides the County has made to support its honored Veterans. She added that based on fourteen different criteria, the County had received 160 out of a possible 190 points to earn the recognition. She turned

the meeting over to Veteran Service Coordinator Janna Williams to say a few words.

Veteran Service Coordinator Janna Williams spoke relative to the month of May being Military Appreciation Month, noting that the County, along with her Department, had been working tirelessly during the last year to make life easier for our brave Veterans and as a result, had been recognized with the "We Value Our Veterans" Community Award. She noted the many new offerings for Veterans through the County of Union including: reserved parking for Veterans at all County facilities; the publication of a quarterly newspaper to inform Veterans about local and national issues; and a Veteran Tree Memorial with scan-able informative signs at Rahway River Park. Veteran Service Coordinator Williams turned the meeting over to Governor Phil Murphy.

Governor Phil Murphy addressed the public:

I would like to congratulate Union County on being a recipient of this year's "We Value Our Veterans" Community Award. We created the "We Value Our Veterans" Community Award program to recognize the communities going above and beyond to honor our military veterans. Union County is the proud home of thousands upon thousands of proud New Jerseyans that have worn our nation's uniform in times of war and in times of peace. It is also the final resting place of those that helped our nation to preserve our liberty. In earning this recognition, and more importantly through the breath of veteran-based services and recognitions you provide, Union County is showing how you are making every day, Veterans' Day. To the Board of Commissioners and the Veteran Services Advisory Committee Chair, my friend, Chairman Alexander Mirabella, Vice Chair and friend Rebecca Williams and a whole host of other friends: Commissioners Dr. Angela R. Garretson, Sergio Granados, Chris Hudak, Bette Jane Kowalski, Lourdes Leon, Kim Palmieri-Mouded, Andrea Staten, Veteran Service Coordinator Janna Williams and Veteran Service Officer Ken Glick and everyone within county government whose support has made this recognition possible, thank you and congratulations. May God Bless our honored Veterans for their service.

Chairman Mirabella thanked County Manager Ed Oatman, Deputy County Manager Wagner, Veteran Service Coordinator Janna Williams and all the staff at the UC Veterans Affairs Office for their efforts. He advised that as the County was preparing for the Memorial Day weekend, many of the Commissioners would participate, as customary, in putting American flags on the gravestones of our deceased Veterans in honor of their sacrifice. He added that the County was honored to be the proud recipient of the "We Value Our Veterans" Community Award and thanked Governor Murphy for the recognition.

A video presentation was made by the Board relative to the 2021 Infrastructure Grant Awards.

Commissioner Hudak noted that it was a privilege to once again be able to provide municipalities with the 2021 Infrastructure Grant. He noted that funding

for this program was initially secured using the proceeds from the sale of Runnells Hospital and given to the various municipalities throughout the County to fund shovel-ready projects. He added that this was the seventh year of the initiative, noting that approximately \$10.5 million had already been furnished, totaling \$21 million in infrastructure funding including the municipal match. He added that it was nice to see these monies put to good use to make necessary improvements that would otherwise be impossible without this type of funding.

Chairman Mirabella commended Commissioner and Fiscal Committee Chairman Hudak for his efforts relative to the 2021 Infrastructure Grant and for being an integral part of the initiative since the very beginning. He noted the importance of this funding in allowing municipalities to fund necessary improvements. He also thanked his fellow Commissioners for their support.

A brief presentation was made by Joann Gemenden, former Recycling and Planning Bureau Chief, relative to the "Bag Up NJ" campaign.

Joanne Gemenden advised that last November, Governor Murphy and the State Legislature had passed a comprehensive bag ban that would go into effect in May of 2022. She advised that a new state-wide campaign has been launched with an informative PSA to debut next week. She added that Union County was the first County to proclaim the month of May as "Bag Up NJ" and thanked the Board for their unyielding support and efforts in preparation to welcome this new legislation and educate the public.

Chairman Mirabella thanked Joann Gemenden for all her efforts, noting that he was proud of Union County for being the first to offer its support and proclaim May "Bag Up NJ" month.

Director Zuber was joined by Recreational Facilities Director Armando Sanchez.

Director Zuber advised that this particular item reflected a change order to reduce the initial anticipated costs of the project. He noted that the upgrades related to the replacement of two all-grass fields installed at Ponderosa Farm Park in 2011. He added that the new fields could not be used for all sports including soccer, lacrosse, and football.

Vice Chair Williams asked if there was a particular term and or timeframe for this service.

Counsel Bergen advised that this firm had been secured and employed for the last 15 months and would continue to focus their efforts on advising the County on how monies received through the CARES Act and the American Recue Plan Act could be properly spent in accordance with federal regulation. He added that this particular item would extend the existing contract with the firm to navigate spending on the anticipated monies to be received through the American Rescue Plan Act. He advised the there was no definitive timeline for the firm's services and they would continue to work until all respective funds were consumed. He added that the County had just received the first payment from the American Rescue Plan Act, with another anticipated payment expected in a year, to be spent by 2024.

Edward Oatman, County Manager

Relative to the nursing staff, County Manager Oatman confirmed this agreement would only affect County nursing staff, adding that the County was looking into employing local organizations like the Visiting Nurse Association to fill the void of nurses that had been reassigned to the County's testing and vaccination centers.
