#### CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:36P.M.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

Chairman Mirabella called for a motion to approve the April Meeting Minutes. On a motion made by Commissioner Kowalski and seconded by Vice Chair Williams, roll call showed six members of the Board voted in the affirmative for the April 8<sup>th</sup> Agenda Setting Meeting Minutes as well as the Agenda Setting and Regular meeting of April

22th; with Commissioner Granados, Commissioner Leon, and Commissioner Staten absent. Relative to the Regular Meeting of April 8<sup>th</sup>, roll call showed five members of the Board voted in the affirmation; with Vice Chair Williams abstaining and Commissioner Granados, Commissioner Leon, and Commissioner Staten absent.

Commissioner Granados joined the meeting.

#### **ORDINANCE FOR INTRODUCTION**

829-2021 AN ORDINANCE TO AMEND PART 1-THE UNION COUNTY ADMINISTRATIVE CODE, CHAPTER 1, UNION COUNTY GOVERNMENT STRUCTURE BY AMENDING ARTICLE XIV-DEPARTMENTS. DIVISIONS, BUREAUS §1-71. DEPARTMENTS ENUMERATED; DELETING ARTICLE XX-DEPARTMENT OF CORRECTIONS; and, AMENDING CHAPTER 140, CONTRACTED OFF-DUTY EMPLOYMENT OF LAW ENFORCEMENT OFFICERS.

#### FIRST READING STATEMENT

Vice Chairman Rebecca Williams, Policy Chair, moved Ordinance Number 829-2021 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The public hearing and final reading will be scheduled to be held on June 10, 2021.

On a motion made by Vice Chair Williams and seconded by Commissioner Granados, roll call showed seven members of the Board voted in the affirmative; with Commissioner Leon and Commissioner Staten absent.

# SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Vice Chair Williams and seconded by Commissioner Kowalski roll called showed seven members of the Board voted in the affirmative; with Commissioner Leon and Commissioner Staten absent

Commissioner Leon joined the meeting.

#### **PUBLIC COMMENT PORTION**

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

Bruce Paterson, of Garwood made comments and asked questions relative to several resolutions. Relative to Reso Nos. 2021-371, 2021-372, and 2021-375, he noted that it was good to see additional grant monies being received for these

items. Relative to Reso No. 2021-386, he asked why the County was making the purchase instead of the Educational Services Commission of NJ. Relative to Reso No. 2021-397, Mr. Paterson inquired about a purchase of golf carts eight years ago and asked why the additional purchase was necessary. Relative to Reso No. 2021-406, he made comments relative to the firm and its link to Finance Director Bibi Taylor. Relative to Reso No. 2021-416, Mr. Paterson noted that in honor of Juneteenth the County should honor previous requests made by Quaney Palmer Chambliss and Salaam Ismail in bringing awareness to the unpleasant, local history relative to slavery.

Relative to Reso No. 2021-386, Director Graziano advised that the purchase was not being made for the Educational Services Commission of NJ but rather, the purchase was being made through the Educational Services Commission Co-op. He added that the Department would be using this co-op to purchase a street sweeper using capital monies to be used by the County.

Relative to Reso No. 2021-397, Recreational Facilities Director Armando Sanchez advised that contrary to Mr. Paterson's claims, the Department had not made a golf cart purchase in a long time. He added that the County leased its golf carts and vehicles from EZ-GO for four years now, noting the vendor was also responsible for the maintenance of all these respective vehicles. He advised that the 4-year contract amount of \$1.8 million did not account for anticipated revenue which was project to be \$3.2 million.

Relative to Reso No. 2021-406, County Manager Oatman advised that the vendor would be responsible for reviewing federal regulations relative to federal funding to ensure appropriate spending of the monies being furnished.

Clerk of the Board Pellettiere confirmed there were no remaining members of the public wishing to comment.
