#### RESOLUTIONS FOR ADOPTION

The following resolutions are being offered for adoption:

2021-700 COMMISSIONER SERGIO GRANADOS: Authorizing the County Manager to apply for and execute the FY2022 Community Services Block Grant (CSBG) contract in the amount of \$318,910.00 from the State of New Jersey, Department of Community Affairs (NJDCA) for the grant period of October 1, 2021 through September 30, 2022 for the purpose of providing community programming for low income residents of Union County, and to recognize and accept that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from NJDCA, does further authorize the execution of any such agreement.

- 2021-702 COMMISSIONER SERGIO GRANADOS: Authorizing the County Manager to enter into a Sub-grant Agreement with HMH Hospitals Corporation, JFK Medical Center, Edison, NJ, to provide nurse case management of lead poisoned children through the County Childhood Lead Poisoning Prevention Program from July 1, 2021 to September 30, 2021 in an amount of not to exceed \$22,373.00.
- 2021-703 COMMISSIONER SERGIO GRANADOS: Authorizing the County Manager to enter into a contract with National Medical Services Inc. dba NMS Laboratories, Willow Grove, PA, for post-mortem toxicology lab services for basic and expanded testing services, for a contract term of October 1, 2021 through September 30, 2023, in an amount not to exceed \$150,000.00.
