Be It Ordained by the Union County Board of Commissioners of the County of Union as follows:




Page 2... Salary Ordinance.

Section 2. The required contribution for employee health benefits shall equal 1.5% of the base salary for calendar year 2021; and

Section 3. The amount of the health benefits contributions effective January 1, 2022 shall be the higher of 1.5% of base salary or Chapter 78, s. 39 year four contributions.

Section 4. That this Ordinance shall take effect at the time and manner provided by law.

Section 5. That the Clerk of this Board be and he is hereby authorized to publish a notice in the appropriate newspaper of such introduction and of a public hearing on February 4, 2021, and shall forward one certified copy of final passage to each Clerk of all Municipalities located within the County of Union.
