

# UNION COUNTY BOARD OF COUNTY COMMISSIONERS

## THURSDAY, OCTOBER 21, 2021 AGENDA SETTING MEETING MINUTES

#### CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:03 P.M.

#### ROLL CALL

Roll call showed Chairman Alexander Mirabella, Vice Chair Rebecca Williams, Commissioner Sergio Granados, Commissioner Christopher Hudak, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, Commissioner Kimberly Palmieri-Mouded, and Commissioner Andrea Staten were present; with Commissioner Angela R. Garretson absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

#### PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

#### STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

Chairman Mirabella addressed the public:

Good evening and welcome to another remote meeting of the Commissioner Board. I just have a couple of brief remarks tonight.

First, I want to remind everyone that the Union County Gun Buyback Amnesty date is this Saturday, October 23, from 9:00 a.m. to 4:00 p.m. It's taking place at the following three locations:

- In Elizabeth, at the Master's Table Christian Fellowship, 207-211 Bond Street.
- In Plainfield, at Shiloh Baptist Church, 515-521 West Fourth Street.
- In Westfield, at Holy Trinity Roman Catholic Church, 506 Westfield Avenue.

You can give us any gun, in any condition, and we will give you a reward of up to \$250.00 – with no questions asked. These buyback events help remove unwanted guns from our neighborhoods and keep them out of the wrong hands. So please.

look through your shelves and closets, and take this opportunity to safely dispose of unwanted guns in your home. For more information visit ucnj.org/buyback.

We also continue to help connect residents impacted by Tropical Storm Ida with federal recovery and relief programs. That includes a virtual Town Hall earlier this week, on Tuesday. I'd like to thank FEMA for participating in the event and answering questions from the community.

Also, I want to remind everyone that Union County's COVID-19 response continues, with free testing, free vaccines, and emergency food distribution for Union County residents. We have made a lot of progress but we still have a long way to go.

As you may know, we got some good news from the Centers for Disease Control today. According to their data, we are one of just a few counties in the whole country – and the only one in New Jersey – to achieve the designation of "low transmission rate." That is a remarkable achievement that validates all of the hard work and extra precautions we have taken since the beginning of the outbreak. I would like to thank all of the volunteers and professional staff who have worked to ensure that tests and vaccines are available to all Union County residents. I would especially like to thank each and every resident who has already gotten their vaccination. And, I cannot emphasize enough how important it is for everyone to step up and get their COVID-19 vaccine as soon as they are eligible. Union County is not an island. We are all still at risk. That is especially true for many thousands in our community, who cannot be vaccinated due to their age or medical condition. COVID-19 will continue to be a matter of life and death until everyone who can get vaccinated, does get vaccinated.

So, as we celebrate our low transmission rate, let's all renew our commitment to using every resource at our disposal to stop the virus from spreading, until this pandemic is finally declared over.

He thanked County Manager Oatman for his leadership during the pandemic and for using all the resources at his disposal to help the residents of Union County. He also thanked Director Moran and Director Anderson as well as his Commissioner colleagues for all their efforts.

Chairman Mirabella asked County Clerk Rajoppi to provide an update on the upcoming election.

County Clerk Rajoppi advised that machine early-voting would start on Saturday, October 30<sup>th</sup>, noting that residents could visit one of the seven cited locations on the County website to cast their vote early. She added that residents could visit any of the locations, regardless of their town of residence. She also added there was still time to vote by mail through her office, recommending residents come in person to one of the County Clerk's locations to cast their vote on the spot on a paper ballot. She also advised that the voting-machines had been inspected earlier that day and that everything was working as expected. She also reminded residents that they could opt to vote on Election Day at their designated polling location.

Chairman Mirabella thanked County Clerk Rajoppi and her staff for their efforts relative to the election.

County Manager Oatman represented the Board of Elections.

Amy Crisp Wagner, Deputy County Manager/Director

Commissioner Hudak asked about the two-month extension.

Deputy County Manager Wagner advised that the previous contract had expired in October and the two-month extension would allow for the Department to finalize the contract details. She added that she expected the new contract to be finalized and presented at the next meeting for approval. She noted additional usage of the resource due to COVID-19 which contributed to the need for additional discussions relative to the new contract. She added that the Department would be using the same vendor as they had proved to be reliable and a great provider of this service to partnering agencies.

Commissioner Hudak asked how about the quantity of partnering agencies.

Deputy County Manager Wagner advised that the local police departments used this resource as well as many municipalities to alert residents via text message/phone via First Alert, noting it as a valuable resource.

Chairman Mirabella recognized Robert Charkowsky for his efforts relative to this resource and training users throughout the County.

3. Chairman Mirabella asked Deputy County Manager Wagner to elaborate on this item.

Deputy County Manager Wagner advised that this item related to action recently taken at the last Workforce Development meeting and would provide \$75,000 to the Plainfield Public Library to continue this resource. She noted that this item would fund a Microsoft Office Certification for 75 residents to obtain the necessary computer skills for various occupations.

Commissioner Hudak asked what this service would be specifically used for.

Director Graziano advised that this vendor had been awarded this contract for the last several years and related to snow removal services.

Commissioner Hudak asked if this was the only vendor secured for this service.

Director Graziano confirmed this to be the case.

Commissioner Granados asked Director Anderson to elaborate on this item.

Director Anderson advised that this item related to a youth shelter program through a state and federal mandate with Community Access Unlimited as the partnering agency. She noted

the County's shelter nights offered housing to court-appointed youth. She added that this was done throughout the year and the Department had served over 100 youth through this detention-alternative service.

- 3. Authorizing the County Manager to apply for and enter into agreement with the NJ Department of Community Affairs (NJDCA) to secure Recreation Opportunities for People with Disabilities (ROID) Program grant funding in the amount of \$35,000.00 with a required County Match of \$7,000.00 for a total program amount of \$42,000.00 for the period of July 1, 2021 through June 30, 2022. (Commissioner Kimberly Palmieri-Mouded)
- 4. Commissioner Hudak inquired about the effects of the state mandate on this program.

Director Anderson advised that the state mandate had increased the volume and the cited \$350,000 were monies the Commissioners approved for clients that did not qualify for this resource through social services benefits, noting that the state mandate would cover the costs associated with those that did qualify for the cited benefits. She added that Union County was the first county in NJ that offered the Code Blue Emergency Shelter resource and believed the new legislation to be a result of County's advocacy relative to the program. She noted that the resource had serviced 3,230 adults and 575 children during the 2021 Code Blue season.

Commissioner Hudak asked Director Anderson if she expected any funding challenges as a result of the COVID-19 pandemic.

Director Anderson advised that it was too early to tell. She advised that the Department was still assisting families displaced by Hurricane Ida. She added that the potential lifting of the eviction moratorium in January could also cause certain challenges moving forward. She advised that she expected to have additional information in December and would keep the Board abreast regarding any changes and or challenges.

Chairman Mirabella noted his approval of this item and the importance of this resource in proving Code Blue Emergency Shelter during the winter for the homeless population as well as other residents requiring shelter. He commended Director Anderson and her Department for the administration of this program over the last several years to help those in need.

Commissioner Garretson joined the meeting.

#### DEPARTMENT OF PUBLIC SAFETY

Andrew Moran, Director

- 1. Authorizing the County Manager to accept and expend the FY 2021 Urban Areas Security Initiative (UASI) grant funds from the NJ Office of Homeland Security and Preparedness to provide equipment and training to the UASI region to prepare for, respond to and recover from acts of terrorism in an amount not to exceed \$1,992.043.00. (Commissioner Sergio Granados)
- 2. Authorizing the County Manager to accept and expend an amount not to exceed \$306,789.59 from the Fiscal Year 2021 New Jersey Homeland Security Grant Program (HSGP) in order to enhance the County's ability to prepare for, respond to and recover from acts of terrorism. (Commissioner Sergio Granados)

Commissioner Granados inquired about these two items and whether or not they were recurring.

Director Moran advised that Item No. 1 was an annual UASI regional award that represented about 10% of the overall award. He added that the County acted as a purchasing agent for approximately 28 UASI projects. He also confirmed these two items were recurring.

1. Amending Resolution Number 2020-371, an agreement with PS&S, Warren, NJ, to perform a flood evaluation regarding the dispatch expansion project, Froehlich Building, Westfield, NJ in an additional amount of \$20,000.00 for a total contract amount not to exceed \$330,053.00 (Union County Engineering Project Number 2019-025). (Commissioner Sergio Granados)

Commissioner Granados asked Director Moran to elaborate on this item.

Director Moran advised that this item related to the dispatch expansion project contract on which construction had already begun. He noted that as a result of Hurricane Ida, the Department wanted to secure the services of an engineer to inquire about future flooding risks and potential steps that could be taken to prevent disruptions to the building as well as public safety operations during future storms.

County Manager Oatman advised that this was a 3-year contract that would cover a 2% increase and replace the holiday of Lincoln's Birthday with Juneteenth.

Commissioner Garretson left the meeting.
