THURSDAY, OCTOBER 21, 2021 REGULAR MEETING MINUTES

CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:30 P.M.

ROLL CALL

Roll call showed Chairman Alexander Mirabella, Vice Chair Rebecca Williams, Commissioner Sergio Granados, Commissioner Christopher Hudak, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. PRESENTATION BY THE BOARD

A presentation was made by the Board of County Commissioners accompanied by a video presentation from various municipalities relative to the Kids Recreational Trust grants, Greening Union County grants and Preserve Union County grants.

Open Space Trust Fund Chair Commissioner Palmieri-Mouded thanked her Commissioner colleagues, Commissioner Garretson, Commissioner Hudak, and Commissioner Leon for their work on this effort and also recognized the municipalities and non-profit partners for their continued work. She noted that the 2021 Kids Recreational Trust grants would be awarded this evening to 20 municipalities, totaling \$1,054,925.40 in funding. She also noted that the 2021 Greening Union County grants would also be presented to 10 municipalities for a total grant award of \$99,125. Relative to the 2021 Preserve Union County, she noted that 10 historic sites throughout the County would be awarded a total of \$299,730.

Chairman Mirabella thanked Commissioner Palmieri-Mouded for her efforts relative to these grants, noting these awards as an important resource for municipalities throughout the County.

ORDINANCES FOR ADOPTION

ORDINANCE AUTHORIZING THE GUARANTY BY THE COUNTY OF UNION, NEW JERSEY OF PAYMENT OF PRINCIPAL OF AND INTEREST ON THE COUNTY GUARANTEED REVENUE BONDS, SERIES 2021 (RENEWABLE ENERGY PROGRAM PROJECT) OF THE UNION COUNTY IMPROVEMENT AUTHORITY IN AN AGGREGATE PRINCIPAL AMOUNT NOT EXCEEDING \$5,500,000.

WHEREAS, the COUNTY OF UNION, New Jersey (the "County"), pursuant to the Improvement Authorities Law of the State of New Jersey (the "State"), constituting Chapter 183 of the Pamphlet Laws of the State of 1960, as amended and supplemented (N.J.S.A. 40:37A-44 et seq.) (the "Act"), has heretofore duly created a body corporate and politic known as The Union County Improvement Authority (the "Authority"); and

WHEREAS, pursuant to Section 80 of the Act, the County is authorized to guaranty unconditionally the punctual payment of the principal of and interest on any obligations of the Authority; and

WHEREAS, the County, in order to assist the Authority with refunding its County of Union Guaranteed Renewable Energy Program Lease Revenue Bonds, Series 2011 (Federally Taxable) and financing of certain renewable energy projects (the "Project"), has determined to provide for the guaranty of County Guaranteed Revenue Bonds, Series 2021 (Renewable Energy Program Project) of the Authority or the refunding of said bonds (the "Obligations") under the resolution of the Authority entitled "County Guaranteed Revenue Bond Resolution (Renewable Energy Program Project)" or the bond resolution(s) authorizing the refunding of said Obligations (the "Bond Resolution");

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF UNION, NEW JERSEY, (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

- **Section 1.** This guaranty shall be adopted by the governing body of the County in the manner provided for adoption of a bond ordinance as provided in the Local Bond Law, constituting Chapter 169 of the Pamphlet Laws of 1960 of the State, as amended and supplemented (the "Local Bond Law").
- Section 2. Pursuant to and in accordance with the terms of the Act, specifically Section 37 of the Act (N.J.S.A. 40:37A-80), the County is hereby authorized to and hereby shall fully, unconditionally and irrevocably guaranty the punctual payment of the principal of and interest on the Obligations in an aggregate principal amount not exceeding at any time \$5,500,000, which Obligations are to be issued to finance and/or refinance the Project, on such terms and conditions as may be agreed to by and between the County and the Authority and as are reflected in this guaranty and in the guaranty certificate on the face of each Obligation. Upon the endorsement of the Obligations referred to in Section 3 below, the County shall be fully, unconditionally and irrevocably obligated to pay the principal of and interest on the Obligations in the same manner and to the same extent as in the case of Obligations issued by the County, and, accordingly, the County shall be unconditionally and irrevocably obligated to levy ad valorem

taxes upon all the taxable property within the County for the payment thereof, without limitation as to rate or amount, when required under the provisions of applicable law. This full, unconditional and irrevocable guaranty of the County effected hereby to pay the principal of and interest on the Obligations when due, in accordance with the terms hereof, shall not be abrogated for any reason. Any Obligations which are no longer considered outstanding under the Bond Resolution shall not be counted for the purpose of the \$5,500,000 limitation contained in this guaranty.

Section 3. The Chairman of the Board of County Commissioners, Vice Chairman of the Board of County Commissioners or Director of Finance of the County shall, by manual or facsimile signature, execute an endorsement on each of the Obligations evidencing this guaranty by the County as to the punctual payment of the principal thereof and interest thereon. The endorsement on each Obligation shall be in substantially the following form, and absent the fully executed endorsement in such form on any such Obligation, such Obligation shall not be entitled to the benefits of this guaranty:

GUARANTY BY THE COUNTY OF UNION, NEW JERSEY

The payment of the principal of and interest on the within Bond shall be fully, irrevocably and unconditionally guaranteed by the County of Union, a body corporate and politic of the State of New Jersey (the "County"), in accordance with the provisions of N.J.S.A. 40:37A-80 and the guaranty ordinance of the County finally adopted pursuant thereto, and the County is fully, irrevocably and unconditionally liable for the payment, when due, of the principal of and interest on this Bond, and if necessary the County shall levy *ad valorem* taxes upon all the taxable property within the County, without limitation as to rate or amount, in order to make such payment.

IN WITNESS WHEREOF, the County of Union, New Jersey, has caused this guaranty to be executed by the signature of its Chairman of the Board of County Commissioners, Vice Chairman of the Board of County Commissioners or Director of Finance.

The Chairman of the Board of County Commissioners, Vice Chairman of the Board of County Commissioners or Director of Finance is hereby further authorized to execute such other certificates or agreements relating to this guaranty that may be required by the Authority to comply with the terms of the financing documents relating to the Obligations, including, without limitation, (i) any agreements or certificates detailing the time and method that payment under this guaranty shall be made by the County, (ii) any letters of representations or

similar undertakings to be executed in connection with the sale of the Obligations, setting forth certain representations, warranties and covenants of the County as an inducement to the purchase of the Obligations, (iii) any certificates deeming "final" (for the purposes of Rule 15c2-12 of the U.S. Securities and Exchange Commission) any Preliminary or final Official Statements of the Authority in connection with the Obligations, and (iv) any bond purchase agreement or continuing disclosure agreement executed in connection with the sale of the Obligations. Such further agreements or certificates shall not abrogate the County's responsibilities hereunder.

The Chairman of the Board of County Commissioners, Vice Chairman of the Board of County Commissioners or Director of Finance is hereby further authorized to execute one or more continuing disclosure agreement(s) or other instrument(s) undertaking the secondary disclosure obligations of the County required by Rule 15c2-12 of the United States Securities and Exchange Commission in connection with the issuance of any Obligations by the Authority.

Section 4. It is hereby found, determined and declared by the governing body of the County that:

- (a) This guaranty may be adopted notwithstanding any statutory debt or other limitations, including particularly any limitation or requirement under or pursuant to the Local Bond Law, but the aggregate principal amount of the Obligations that shall be entitled to the benefits of this guaranty, being an amount not to exceed \$5,500,000 outstanding at any time, shall after their issuance be included in the gross debt of the County for the purpose of determining the indebtedness of the County under or pursuant to the Local Bond Law.
- (b) The principal amount of Obligations entitled to the benefits of this guaranty and included in the gross debt of the County shall be deducted, and is hereby declared to be and to constitute a deduction, from such gross debt under and for all the purposes of the Local Bond Law (i) from and after the time of issuance of the Obligations until the end of the fiscal year beginning next after the completion of the acquisition or construction of the project to be financed from the proceeds of the Obligations, and (ii) in any annual debt statement filed pursuant to the Local Bond Law as of the end of said fiscal year or any subsequent fiscal year, if the revenues or other receipts or moneys of the Authority in such fiscal year are sufficient to pay its expenses of operation and maintenance in such fiscal year and all amounts payable in such fiscal year on account of the principal of and interest on all such guaranteed Obligations, all Obligations of the County issued as provided in Section 36 of the Act (N.J.S.A. 40:37A-79), and all Obligations of the Authority issued under the Act.
- **Section 5.** The following matters are hereby determined, declared, recited and stated:
- (a) The maximum outstanding principal amount of Obligations of the Authority that are hereby and hereunder guaranteed as to the punctual payment of the principal thereof and interest thereon at any time is \$5,500,000.

- (b) The purpose described in this guaranty is not a current expense of the County, and no part of the cost thereof has been or shall be assessed on property specially benefited thereby.
- (c) A supplemental debt statement of the County has been duly made and filed in the office of the Clerk of the Board, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State, and such debt statement shows that while the gross debt of the County, as defined in the Local Bond Law, is increased by this guaranty by \$5,500,000, in accordance with the provisions of the Act, the net debt of the County is not increased, and the obligation of the County authorized by or incurred pursuant to the terms of this guaranty is permitted by an exception to the debt limitations of the Local Bond Law, which exception is contained in the Act.
- (d) All other items to be contained in a bond ordinance adopted pursuant to the Local Bond Law are hereby determined to be inapplicable to the County's guaranty of the Obligations hereby.
- **Section 6.** Pursuant to N.J.S.A. 40:37A-56, the County hereby consents to the undertaking of the Project by the Authority and the entering into any agreement in connection therewith.
- **Section 7.** This guaranty shall take effect at the time and in the manner provided by law.

NOTICE OF PENDING GUARANTY ORDINANCE

The guaranty ordinance, the summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of the County of Union, State of New Jersey, on October 7, 2021. It will be further considered for final passage, after public hearing thereon, at a meeting of the governing body to be held at the County Administration Building, 10 Elizabethtown Plaza, in the City of Elizabeth, on October 21, 2021 at 5:30 o'clock PM. PUBLIC COMMENT PORTION

The meeting was open for the purpose of commenting on Ordinance Number 832-2021 only.

Bruce Paterson, of Garwood, inquired about how this Ordinance related to prior action taken by the Board relative to a solar panel project.

Director Taylor advised that Ordinance No. 832-2021 was directly related to bonds that were authorized in 2011 for the procurement, installation, operation, and

maintenance of solar energy projects at approximately 30 different sites in 15 different municipalities throughout the County. She noted that based on current market conditions, the County expected to save approximately \$400,000 in net present value savings or approximately \$8.07% of the refunded principle. She added that as a result of current market conditions, there was a request to refund the bonds in an amount not to exceed \$5.5 million. She advised that the proceeds from the sale and issuance of the bonds would be used to refund the authorities debt that remained outstanding as well as reinvest in the program itself. She noted that because the system was aging, the County was looking to reinvest in the solar panel program to ensure that towns could continue the program and continue to realize and generate electric revenues and reap savings to the municipalities. She confirmed the transaction itself was savings based upon current market conditions and did not deal with the prior action taken in 2011.

FINAL READING STATEMENT

Commissioner Christopher Hudak, Union County Improvement Authority Liaison, moved Ordinance Number 832-2021 for Final Reading and authorize the Clerk of the Board to advertise same in accordance with the law.

On a motion made by Commissioner Hudak and seconded by Commissioner Leon roll call showed nine members of the Board voted in the affirmative.

SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Commissioner Kowalski and seconded by Vice Chair Williams, roll called showed nine members of the Board voted in the affirmative.

John Bury, of Kenilworth, submitted comments to be read into the record by Clerk of the Board Pellettiere. Mr. Bury expressed his dissatisfaction that the comments he submitted for the October 7th Regular Meeting were partially censored for allegedly violating the meeting bylaws.

Counsel Bergen advised that Mr. Bury's previous remarks were not read into the record in their entirety based on his legal advice and renewed his opinion that there was no infringement on Mr. Bury's freedom of speech as a result of this action. He added that the appropriate action was taken by Chairman Mirabella and

the Clerk of the Board as a means to control and protect the nature of the meeting process.

Maria Echeverria, of Elizabeth, submitted comments to be read into the record by Clerk of the Board Pellettiere. Ms. Echeverria advised that the FDA would be hosting an online discussion related to the use of COVID-19 Pfizer vaccines on children 5-11 years of age and encouraged the Board to participate in the discussion.

Bruce Paterson, of Garwood, made comments and asked questions relative to several resolutions. Relative to Reso No. 2021-762, he inquired about the use of the program and its documented success. Relative to Reso No. 2021-766, he asked about the need for the cited parking spaces. Relative to Reso No. 2021-772, he inquired about this item and future mitigation costs that may be associated with the project. Relative to Reso No. 2021-789, Mr. Paterson asked for additional details related to the service. Relative to Reso Nos. 2021-795, 2021-796, and 2021-797, he inquired about the timing of these awarded grants. Relative to Reso No. 2021-798, he asked about additional details related to this item. Relative to Reso No. 2021-803, he asked for an update on this project, including when it would be completed. Relative to Reso No. 2021-805, he asked about the continuation of this service.

Relative to Reso No. 2021-762, Director Anderson advised that this resource would service the 16-24 year old population by providing invaluable resources that would help them develop necessary life-skills post high school as a means to help them succeed. She noted that the program would assist these individuals with budgeting and financial literacy as well as post high school education choices through the Division of Youth Services with the involvement of case managers. She added that 167 individuals had utilized this program, citing a 90% success rate in participants. She noted that this virtual program had proven an invaluable resource during the COVID-19 pandemic.

Relative to Reso No. 2021-766, Director Anderson advised that these parking spaces would be used to accommodate approximately 350 Social Services employees assigned to the Elizabeth site.

Relative to Reso No. 2021-772, Director Moran advised that the location had flooded during Hurricane Ida. He noted that it was in the County's best interest to conduct a study of the location to determine how the critical infrastructure could be protected in the event of more extreme and unprecedented weather events in the future. He added that this resource was heavily relied upon by residents, especially during emergencies, and that the County had a responsibility to take the necessary measures to preserve the site. He confirmed that dependent on the outcome of the study, additional capital projects could be forthcoming.

Relative to Reso No. 2021-789, Director Graziano advised that this item related to work performed by staff within the Departments of Engineering and Public Works and Parks and Recreation throughout the year. He noted that this work

could involve paving as well as cinder block and concrete deliveries. He added the Department has spent approximately \$300,000 on this contract last year.

Relative to Reso Nos. 2021-795, 2021-796, 2021-797, Open Space, Recreation & Historic Preservation Trust Fund Administrator Durbin-Drake advised that the timeline for these grants was very complex and that respective staff worked diligently to ensure these grant awards were received by the various municipalities in a timely fashion.

Relative to Reso No. 2021-798, Administrator Durbin-Drake advised that the property was purchased with the intention of continuing operations as a catering hall. She added that once purchased, the new owner had determined that the costs of repairs to the site were unfeasible and opted to resell the property instead which is how the County became involved.

Relative to Reso No. 2021-803, County Clerk Rajoppi advised that this item related to the awarding of a contract for the actual construction, renovation, and rebuilding of her department, noting a prior resolution that was passed to cover the preliminary architectural and designs services. She noted that the respective architect and County staff had recommended an asbestos study be done prior to construction which was why the contract was being revised to include additional monies. County Clerk Rajoppi added that the project would take approximately two years and would be done in phases to allow for the continuation of work by staff.

Relative to Reso No. 2021-805, County Manager Oatman advised that this item related to additional storage and transportation services required by the Board of Elections to conduct early voting.

Clerk of the Board Pellettiere confirmed that there were no additional members of the public wishing to speak and or he had no received any additional comments to be read into the record.


