THURSDAY, OCTOBER 7, 2021 AGENDA SETTING MEETING MINUTES

CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:03 P.M.

ROLL CALL

Roll call showed Chairman Alexander Mirabella, Commissioner Angela R. Garretson, Commissioner Sergio Granados, Commissioner Christopher Hudak, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, and Commissioner Kimberly Palmieri-Mouded were present; with Vice Chair Rebecca Williams and Commissioner Andrea Staten absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

Chairman Mirabella addressed the public:

Good evening and welcome to another remote meeting of the Commissioner Board. As always, we have a lot of ground to cover.

I would like to start with a brief reminder that we are continuing to respond to the COVID-19 pandemic with new opportunities for residents to get tested free of charge, and get vaccinated free of charge. We are also continuing our emergency food program for persons impacted by the pandemic. So please, if you need a test, if you need a vaccine, and if you need resources, please get in touch. You can call us, email us, follow us on social media, or visit us online at ucnj.org for the latest updates.

Moving on to other matters of concern, I want to encourage anyone in Union County with an unwanted gun in their possession, to participate in our next gun amnesty buyback program on Saturday, October 23.

Also, October is Fire Prevention Month, and we are reminding everyone that many types of household batteries can start fires if disposed with household trash.

So please remember, only single-use alkaline batteries are safe to dispose in trash. The others require special handling, and you bring them to our next Household Hazardous Waste event on October 23. For more details about the gun buyback and battery safety, visit us online at ucnj.org.

On a lighter note, the Sensory Friendly Theatre series is returning to the Union County Performing Arts Center in Rahway, beginning on Sunday, October 17 at 1:00 p.m. with the interactive "Bubble Trouble" show. Sensory Friendly Theatre aims to create a welcoming, judgement free environment for children with sensory sensitivities. We began sponsoring the series in 2012 as part of our inclusive recreation program and we are very happy to bring it back after a hiatus last year. And finally, I want to invite everyone to join us tomorrow afternoon, Friday October 8, at 1:00 p.m. in front of the Union County Courthouse to celebrate our residents of Italian heritage with the 13th annual Columbus Day Flag Raising. We are very proud to be joined by representatives from the national and local chapters of UNICO, which is the largest service organization of its kind in the U.S., and which has made so many contributions to our Union County community.

With that, let's turn to the business of tonight's meeting.

APPROVAL OF COMMUNICATIONS

Note and File

Chairman Mirabella advised that the Communications would be approved later during the Regular Meeting.

PRESENTATION TO THE BOARD

A presentation was made by the Board of Elections Administrator Nicole DiRado regarding New Jersey's Early Voting process for the 2021 General Election.

Commissioner Kowalski inquired about the early-voting option through the County Clerk's Office.

Administrator DiRado advised that anyone interested in voting early through the County Clerk's Office would be issued a mail-in ballot, identical to the mail-in ballots received through the mail upon request. She noted that voters interested in voting early using a voting machine would be required to visit one of the early-voting locations cited in the presentation. She added that voters wishing to vote in-person on November 2nd, Election Day, would have to report to their designated polling location.

Commissioner Garretson inquired about the schedule for poll workers on Election Day.

Administrator DiRado advised that poll workers were scheduled to work from 5:15 AM until after the polls close at 8 PM. She added that mandatory training was required especially due to the new digital equipment being used to capture voter signatures in place of the customary poll books. She noted that poll workers would learn how to open,

close, and activate voting machines and electronic poll books. They would also be tasked with determining voter eligibility and executing any required paperwork. Administrator DiRado also advised that poll workers were required to ensure the return of all resources and equipment to the Board of Elections or respective Municipal Clerks at the end of Election Night. She confirmed that poll worker training would be conducted prior to Election Day and new poll workers would be paired with more seasoned poll workers to assist in the transition. She added that poll workers would be paid \$300 for the day as prescribed by the State.

Chairman Mirabella asked if early-voting totals from the machines would be included in the unofficial election results posted that evening of Election Day.

Administrator DiRado confirmed that early-voting machine totals would be included. She advised that results would be read into the system when the polls close at 8 PM on Election Day and would be disclosed as unofficial results until all votes were counted and the election was certified.

Commissioner Leon inquired about the receipt deadline for mail-in ballots.

Administrator DiRado advised that vote-by mail ballots had to be postmarked by or on Election Day and be received by the Board of Elections within 6 days of Election Day in order to be accepted.

Chairman Mirabella thanked Administrator DiRado and her staff for their hard work leading up to the election and post-election.

OFFICE OF THE UNION COUNTY CLERK

Joanne Rajoppi, County Clerk

County Clerk Rajoppi advised that nothing had changed with regards to the vote-by mail ballot process on her end. She noted that there was an increase in the quantity of vote-by mail ballots issued, increasing the total from 35,000 to 43,000.

Chairman Mirabella thanked County Clerk Rajoppi and her staff for their hard work relative to the election.

There were no questions or comments by the Board.

- 1. Authorizing the County Manager to exercise its only option to extend the contract, obtained through advertised public bidding (BA 37-2019) in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq., with Ditto Copy Systems Inc., Linden, New Jersey to provide coin-operated copy machines for public use at five cents (\$0.05) per copy for an additional twenty-four (24) consecutive months beginning December 10, 2021 through December 9, 2023. This is not a revenue producing contract nor is there a cost to the County. The vendor is responsible for maintaining the machines as well as the paper supply. (Chairman Alexander Mirabella)
- 2. Authorizing the County Manager to enter into a contract with Wisolmerski Associates, Inc., Boca Raton, Florida, for the purpose of providing technical

support to the recording, indexing and accounting systems of the Office of the County Clerk for the contract period of January 1, 2022 through December 31, 2022 in an amount not to exceed \$44,350.00. (Chairman Alexander Mirabella)

- 3. Amending Resolution Number 2020-896, a contract with Full Service Mailers, Hackensack, New Jersey, to add grant account G-02-21-310-312-734. No change in contract value. (Chairman Alexander Mirabella)
- 4. Amending Resolution Number 2021-631, a contract with Royal Printing Services, West New York, New Jersey to add grant account G-02-21-310-312-734. No change in contract value. (Chairman Alexander Mirabella)

Assistant Prosecutor Doreen Yanik represented the Office.

Amending Resolution Number 2021-459 to reflect the following required data elements: Authorizing the County Manager, through the Office of the Union County Prosecutor's office, to apply for and accept funding for the purpose described in the application from the State of New Jersey, Office of the Attorney General, Division of Administration, Department of Law and Public Safety for FFY19 Victims of Crime Act (VOCA) Grant Program for the project titled County Sexual Assault Response Team/Forensic Nurse Examiner Program; The total project cost reflects the full grant award of \$86,427.00 in federal funds and not to exceed \$139,082.00 in match (Required match amount of \$21,607.00 and existing operating budget salary and fringe cost of \$117,475.00) for a total project cost of \$225,509.00 for the period of October 1, 2021 through September 30, 2022 (Subaward number VS-85-19). DEPARTMENT OF ECONOMIC DEVELOPMENT

- 1. Authorizing the County Manager to award a contract to MicroSystems-NJ.com LLC, Bridgewater, NJ, by way of RCCP #6-2021, to provide online tax system services to the County of Union, for a period of five (5) years from November 11, 2021 through November 10, 2026 in an amount not to exceed \$254,500.00. - 2. Authorizing the County Manager to utilize Cares Act Mainstream Vouchers in the amount, not to exceed \$479,232.00 from the Union County Housing Voucher Program (Section 8), to service 40 non-elderly disabled families on a monthly basis through Federal Department of Housing & Urban Development Housing Development Directions LLC. Commissioner Granados asked Deputy County Manager Wagner to elaborate on this item.

Deputy County Manager Wagner advised that the County had been awarded 40 Housing Vouchers, noting the Department had 28 people from a waiting list ready to receive this housing assistance. She added that in 2013 when applications opened for this assistance the Department received 21,000 applications in 24 hours. She indicated that the 28 people had been selected from this previous list that has been reduced to 5,788. She added that the Department had also done mailings to find eligible residents that met the criteria. She advised that funding for this program had been secured for two years, noting that she anticipated that the Department of Housing and Urban Development would extend the funding once that time expired.

DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT Joseph Graziano, Director
