## THURSDAY, OCTOBER 07, 2021 REGULAR MEETING MINUTES

### CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:30 P.M.

### ROLL CALL

Roll call showed Chairman Alexander Mirabella, Commissioner Angela R. Garretson, Commissioner Sergio Granados, Commissioner Christopher Hudak, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, and Commissioner Kimberly Palmieri-Mouded were present; with Vice Chair Rebecca Williams and Commissioner Andrea Staten absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

### PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

#### **ORDINANCES FOR INTRODUCTION**

ORDINANCE AUTHORIZING THE GUARANTY BY THE COUNTY OF UNION, NEW JERSEY OF PAYMENT OF PRINCIPAL OF AND INTEREST ON THE COUNTY GUARANTEED REVENUE BONDS, SERIES 2021 (RENEWABLE ENERGY PROGRAM PROJECT) OF THE UNION COUNTY IMPROVEMENT AUTHORITY IN AN AGGREGATE PRINCIPAL AMOUNT NOT EXCEEDING \$5,500,000.

WHEREAS, the COUNTY OF UNION, New Jersey (the "County"), pursuant to the Improvement Authorities Law of the State of New Jersey (the "State"), constituting Chapter 183 of the Pamphlet Laws of the State of 1960, as

amended and supplemented (N.J.S.A. 40:37A-44 et seq.) (the "Act"), has heretofore duly created a body corporate and politic known as The Union County Improvement Authority (the "Authority"); and

WHEREAS, pursuant to Section 80 of the Act, the County is authorized to guaranty unconditionally the punctual payment of the principal of and interest on any obligations of the Authority; and

WHEREAS, the County, in order to assist the Authority with refunding its County of Union Guaranteed Renewable Energy Program Lease Revenue Bonds, Series 2011 (Federally Taxable) and financing of certain renewable energy projects (the "Project"), has determined to provide for the guaranty of County Guaranteed Revenue Bonds, Series 2021 (Renewable Energy Program Project) of the Authority or the refunding of said bonds (the "Obligations") under the resolution of the Authority entitled "County Guaranteed Revenue Bond Resolution (Renewable Energy Program Project)" or the bond resolution(s) authorizing the refunding of said Obligations (the "Bond Resolution");

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF UNION, NEW JERSEY, (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

**Section 1.** This guaranty shall be adopted by the governing body of the County in the manner provided for adoption of a bond ordinance as provided in the Local Bond Law, constituting Chapter 169 of the Pamphlet Laws of 1960 of the State, as amended and supplemented (the "Local Bond Law").

**Section 2.** Pursuant to and in accordance with the terms of the Act, specifically Section 37 of the Act (N.J.S.A. 40:37A-80), the County is hereby authorized to and hereby shall fully, unconditionally and irrevocably guaranty the punctual payment of the principal of and interest on the Obligations in an aggregate principal amount not exceeding at any time \$5,500,000, which Obligations are to be issued to finance and/or refinance the Project, on such terms and conditions as may be agreed to by and between the County and the Authority and as are reflected in this guaranty and in the guaranty certificate on the face of each Obligation. Upon the endorsement of the Obligations referred to in Section 3 below, the County shall be fully, unconditionally and irrevocably obligated to pay the principal of and interest on the Obligations in the same manner and to the same extent as in the case of Obligations issued by the County, and, accordingly, the County shall be unconditionally and irrevocably obligated to levy ad valorem taxes upon all the taxable property within the County for the payment thereof, without limitation as to rate or amount, when required under the provisions of applicable law. This full, unconditional and irrevocable guaranty of the County effected hereby to pay the principal of and interest on the Obligations when due, in accordance with the terms hereof, shall not be abrogated for any reason. Any Obligations which are no longer considered outstanding under the Bond Resolution shall not be counted for the purpose of the \$5,500,000 limitation contained in this guaranty.

Section 3. The Chairman of the Board of County Commissioners, Vice Chairman of the Board of County Commissioners or Director of Finance of the County shall, by manual or facsimile signature, execute an endorsement on each of the Obligations evidencing this guaranty by the County as to the punctual payment of the principal thereof and interest thereon. The endorsement on each Obligation shall be in substantially the following form, and absent the fully executed endorsement in such form on any such Obligation, such Obligation shall not be entitled to the benefits of this guaranty:

### GUARANTY BY THE COUNTY OF UNION, NEW JERSEY

The payment of the principal of and interest on the within Bond shall be fully, irrevocably and unconditionally guaranteed by the County of Union, a body corporate and politic of the State of New Jersey (the "County"), in accordance with the provisions of N.J.S.A. 40:37A-80 and the guaranty ordinance of the County finally adopted pursuant thereto, and the County is fully, irrevocably and unconditionally liable for the payment, when due, of the principal of and interest on this Bond, and if necessary the County shall levy *ad valorem* taxes upon all the taxable property within the County, without limitation as to rate or amount, in order to make such payment.

IN WITNESS WHEREOF, the County of Union, New Jersey, has caused this guaranty to be executed by the signature of its Chairman of the Board of County Commissioners, Vice Chairman of the Board of County Commissioners or Director of Finance.

The Chairman of the Board of County Commissioners, Vice Chairman of the Board of County Commissioners or Director of Finance is hereby further authorized to execute such other certificates or agreements relating to this guaranty that may be required by the Authority to comply with the terms of the financing documents relating to the Obligations, including, without limitation, (i) any agreements or certificates detailing the time and method that payment under this guaranty shall be made by the County, (ii) any letters of representations or similar undertakings to be executed in connection with the sale of the Obligations, setting forth certain representations, warranties and covenants of the County as an inducement to the purchase of the Obligations, (iii) any certificates deeming "final" (for the purposes of Rule 15c2-12 of the U.S. Securities and Exchange Commission) any Preliminary or final Official Statements of the Authority in connection with the Obligations, and (iv) any bond purchase agreement or continuing disclosure agreement executed in connection with the sale of the Obligations. Such further agreements or certificates shall not abrogate the County's responsibilities hereunder.

The Chairman of the Board of County Commissioners, Vice Chairman of the Board of County Commissioners or Director of Finance is hereby further authorized to execute one or more continuing disclosure agreement(s) or other instrument(s) undertaking the secondary disclosure obligations of the County required by Rule 15c2-12 of the United States Securities and Exchange Commission in connection with the issuance of any Obligations by the Authority.

- **Section 4.** It is hereby found, determined and declared by the governing body of the County that:
- (a) This guaranty may be adopted notwithstanding any statutory debt or other limitations, including particularly any limitation or requirement under or pursuant to the Local Bond Law, but the aggregate principal amount of the Obligations that shall be entitled to the benefits of this guaranty, being an amount not to exceed \$5,500,000 outstanding at any time, shall after their issuance be included in the gross debt of the County for the purpose of determining the indebtedness of the County under or pursuant to the Local Bond Law.
- (b) The principal amount of Obligations entitled to the benefits of this guaranty and included in the gross debt of the County shall be deducted, and is hereby declared to be and to constitute a deduction, from such gross debt under and for all the purposes of the Local Bond Law (i) from and after the time of issuance of the Obligations until the end of the fiscal year beginning next after the completion of the acquisition or construction of the project to be financed from the proceeds of the Obligations, and (ii) in any annual debt statement filed pursuant to the Local Bond Law as of the end of said fiscal year or any subsequent fiscal year, if the revenues or other receipts or moneys of the Authority in such fiscal year are sufficient to pay its expenses of operation and maintenance in such fiscal year and all amounts payable in such fiscal year on account of the principal of and interest on all such guaranteed Obligations, all Obligations of the County issued as provided in Section 36 of the Act (N.J.S.A. 40:37A-79), and all Obligations of the Authority issued under the Act.
- **Section 5.** The following matters are hereby determined, declared, recited and stated:
- (a) The maximum outstanding principal amount of Obligations of the Authority that are hereby and hereunder guaranteed as to the punctual payment of the principal thereof and interest thereon at any time is \$5,500,000.
- (b) The purpose described in this guaranty is not a current expense of the County, and no part of the cost thereof has been or shall be assessed on property specially benefited thereby.
- (c) A supplemental debt statement of the County has been duly made and filed in the office of the Clerk of the Board, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State, and such debt statement shows that while the gross debt of the County, as defined

in the Local Bond Law, is increased by this guaranty by \$5,500,000, in accordance with the provisions of the Act, the net debt of the County is not increased, and the obligation of the County authorized by or incurred pursuant to the terms of this guaranty is permitted by an exception to the debt limitations of the Local Bond Law, which exception is contained in the Act.

- (d) All other items to be contained in a bond ordinance adopted pursuant to the Local Bond Law are hereby determined to be inapplicable to the County's guaranty of the Obligations hereby.
- **Section 6.** Pursuant to <u>N.J.S.A.</u> 40:37A-56, the County hereby consents to the undertaking of the Project by the Authority and the entering into any agreement in connection therewith.
- **Section 7.** This guaranty shall take effect at the time and in the manner provided by law.

#### NOTICE OF PENDING GUARANTY ORDINANCE

The guaranty ordinance, the summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of the County of Union, State of New Jersey, on October 7, 2021. It will be further considered for final passage, after public hearing thereon, at a meeting of the governing body to be held at the County Administration Building, 10 Elizabethtown Plaza, in the City of Elizabeth, on October 21, 2021 at 5:30 o'clock PM. ### FIRST READING STATEMENT

Commissioner Hudak, Union County Improvement Authority Liaison, moved Ordinance Number 832-2021 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The public hearing was scheduled to be held on October 21, 2021.

On a motion made by Commissioner Hudak and seconded by Commissioner Kowalski roll call showed seven members of the Board voted in the affirmative; with Vice Chair Williams and Commissioner Staten absent.

### SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Commissioner Granados and seconded by Commissioner Palmieri-Mouded, roll called showed seven members of the Board voted in the affirmative; with Vice Chair Williams and Commissioner Staten absent.

### **PUBLIC COMMENT PORTION**

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

Bruce Paterson, of Garwood, made comments and asked questions relative to several resolutions. Relative to Reso No. 2021-738, Mr. Paterson asked how this Resolution was related to Ordinance No. 832-2021. Relative to Reso No. 2021-739, he asked if the UCIA was involved in this project and whether or not more change orders were expected. Relative to Reso No. 2021-744, he asked who the principle of Ditto Copy Systems Inc. was and inquired about the location of the cited machines. Relative to Reso Nos. 2021-746, 2021-747, & 2021-748, Mr. Paterson inquired about the costs of each contract. Relative to Reso No. 2021- 754, he asked how much Development Directions LLC would be receiving and how long these monies were expected to last. Relative to Reso No. 2021-755, Mr. Paterson asked for an overview of the case. Relative to the upcoming Executive Session, he asked about the location of the cited real property.

Relative to Reso No. 2021-738, Director Taylor advised that this Resolution was related to Ordinance No. 832-2021, and authorized the County to enter into a guarantee agreement, a deficiency agreement, and a disclosure agreement all associated with the 2011 renewable energy bond project. She added that coupled with Ordinance No. 832-2021, this item would allow the County to refund existing bonds in order to pay off existing debt and utilize proceeds in order to make equipment purchased in 2010 functional. She added that equipment had been installed as a result of the bond deal in 2011 and was used by 30 entities. She noted that the County anticipated to yield approximately 8.07% savings which was equal to \$407,000 new present value savings as a result of the transaction.

Relative to Reso No. 2021-739, Director Graziano advised that the parking deck project had not been awarded to a vendor yet. He noted that change orders could not be anticipated until the project had been awarded to a vendor. He confirmed that the Union County Improvement Authority was not involved in the project.

Relative to Reso No. 2021-744, Clerk Rajoppi advised that the vendor was located in Linden, noting the principle of the company as Mr. Nicola Moriello. She noted that the copy machines were located in the public record room for use by the public as well as title searchers and that the service was of no cost to the Department.

Relative to Reso Nos. 2021-746, 2021-747, and 2021-748, Clerk Rajoppi advised that these Resolutions were related to the Rahway Special School Election held the previous week. She noted that the City of Rahway would be paying for this expense and these Resolutions were meant to assign an account number for the expenses.

Relative to Reso No. 2021-754, Deputy County Manager Wagner advised that funding for this item had been secured for two years and the County would not know until those two years were expended whether or not the initiative would continue to receive funding. She also advised that Development Directions LLC would receive an administration fee for their services dictated by the Department of Housing & Urban Development. She added that in this case the agency would receive \$79.10 per voucher, per month.

Relative to Reso No. 2021-755, Counsel Bergen advised that this matter involved the County's lease at the Albender Building in Elizabeth, noting that H.C. Equities was the owner of that property, and litigation had been ongoing for over three years. He advised that in July, the County had received a unanimous decision from the NJ Supreme Court upholding their position in the case. He added that because the County was the defendant in the matter, they were forced to continue their defense as long as H.C. Equities continued to pursue the matter. He noted that the monies expended for litigation was minimal in comparison to the tens of millions in damages the County would suffer if the case were lost.

Relative to the Executive Session, Counsel Bergen advised that he could not release the address of the cited property because the matter was being negotiated and doing so would compromise the County's position in the negotiations. He added that if public monies were to be spent on the property the information would then be made public.

John Bury, of Kenilworth, made comments relative to the new Government Complex.

Clerk of the Board Pellettiere confirmed that there were no additional members of the public wishing to speak and or he had not received any additional comments to be read into the record.

2021-736 COMMISSIONER CHRISTOPHER HUDAK & THE ENTIRE BOARD: Resolution sponsoring the Queen City Film Festival's 4th Annual Film Festival held on October 22-24, 2021 in the total amount of not to exceed \$2,500.00.

### **COMMISSIONER REPORTS AND COMMENTS**

Commissioner Palmieri-Mouded reminded residents that October was Breast Cancer Awareness Month and encouraged residents to keep up with their breast health by making an appointment for their mammograms and by conducting self-exams at home. She added that the County Administration Building had changed the lights in the lobby to pink to bring awareness to the cause, adding that the lights would be changed to teal on October 13 to bring awareness to metastatic breast cancer.

Commissioner Kowalski spoke relative to the flooding in Union County as a result of Hurricane Ida. She advised that she and Counsel Bergen had attended a meeting with the Rahway River Watershed Association and the Department of Environmental Protection to discuss the flooding that had occurred. She also advised that they participated in discussions regarding the status of the study/project through the Army Corps of Engineers. She noted the seriousness of flooding in certain areas as well as the increasing frequency and severity of these occurrences and the need to have this matter addressed in a timely fashion. On another note, Commissioner Kowalski spoke relative to the upcoming annual Four Centuries in a Weekend event on October 16<sup>th</sup> & 17<sup>th</sup>, hosted by the County and partially funded by the NJ Historical Commission. She added that tour would allow residents to visit more than 30 houses, museums, and historical sites throughout the County, including the Wallace Chapel in Summit, the former home of Reverend Florence Spearing Randall.

Chairman Mirabella recognized Commissioner Kowalski for her leadership relative to flood-management and control over the years. He noted that he was confident in her leadership and her ability to push the Army Corps of Engineers and the Federal Government to take action to mitigate these events and the subsequent damage. He reminded residents that FEMA was on-site in Scotch Plains through Saturday to assist residents throughout the County in making claims for damages, checking on the status of a claim, and or for general inquiries.

Commissioner Hudak had no comments.

Commissioner Granados noted the County's continued celebration of Hispanic Heritage Month and encouraged residents to attend the first ever Hispanic Heritage flag raising ceremony on October 15<sup>th</sup>. He also recognized the efforts of Commissioner Leon, Parks & Recreation, and the Departments of Economic Development and Human Services and all the County employees that facilitated the Family Fun Day, noting the celebration highlighted Hispanic and Latin culture as well as the inclusion of all those that participated. Commissioner Granados reminded residents that the County would be hosting a Concert In the Park event on October 16<sup>th</sup> at Warinanco Park with a performance by the Hector Morales Salsa Band, noting that free food would also be available for the first 150 participants. He thanked the County of Union for ensuring that all ethnicities were recognized and celebrated.

Commissioner Leon expressed her gratitude for all the support she received in facilitating the Family Fun Day during Hispanic Heritage Month. She added that it was the first time she participated in this event as a Commissioner and thanked her Commissioner colleagues Commissioner Garretson, Commissioner Granados, and Commissioner Hudak for their support relative to the event. She closed by reminding residents that there would be an Emergency Food Distribution on Saturday at Kean University.

Commissioner Garretson joined Commissioner Palmieri-Mouded in reminding residents to schedule their breast exams and conduct self-exams at home. She also spoke relative to her recent participation in the First Annual Pink Shuffle on the Hillside at Conant Park in Hillside. She noted that it was a wonderful gathering and thanked everyone involved for organizing and participating in the event, in particular Prestige Auto. On another note, she spoke relative to her participation in Scotch Plains Day alongside Commissioner Hudak as well as Family Fun Day in celebration of Hispanic Heritage alongside Commissioner Leon. She also spoke relative to the Institute of Music for Children and thanked the Board for supporting this organization and their efforts. She noted the previous day's event celebrating the curing of the land now owned by the organization.

Chairman Mirabella acknowledged Commissioner Garretson's participation in several of the events throughout the County, including her efforts relative to the Institute of Music for Children joined by Lieutenant Governor Sheila Y. Oliver, and thanked her for her hard work over the last month. On another note, he

recognized Commissioner Hudak for his leadership and efforts relative to the Polish Flag Raising event a few weeks back. He added that other municipalities throughout the County would also be celebrating Columbus Day with weekend activities, including an Italian Festival in Clark.
