

UNION COUNTY BOARD OF COUNTY COMMISSIONERS

THURSDAY, DECEMBER 16 2021 REGULAR MEETING MINUTES

CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:55 P.M.

ROLL CALL

Roll call showed Chairman Alexander Mirabella, Vice Chair Rebecca Williams, Commissioner Angela R. Garretson, Commissioner Sergio Granados, Commissioner Christopher Hudak, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, Commissioner Kimberly Palmieri-Mouded, and Commissioner Andrea Staten were present.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

APPROVAL OF COMMUNICATIONS

Note and File

Chairman Mirabella called for a motion to approve the Communications. On a motion made by Vice Chair Williams and seconded by Commissioner Garretson roll call showed nine members of the Board voted in the affirmative.

SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Vice Chair Williams and seconded by Commissioner Palmieri-Mouded, roll called showed nine members of the Board voted in the affirmative.

PUBLIC COMMENT PORTION

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

Inaudible name, spoke relative to the ongoing labor negotiations that have been taking place between the County and the CWA Labor Union.

Imani Humphrey, spoke on behalf of colleague Valerie Donofrio relative to the labor negotiations between the County and the CWA Labor Union.

Jennifer Colon, spoke relative to her experience as a County employee, noting that she wished to make enough money to support her family without receiving social services assistance.

Bruce Paterson, of Garwood, made comments and asked questions relative to several Resolutions. Mr. Paterson made comments relative to the County's budget and the running fund balance, suggesting these monies should be used to off-set municipal taxes. Relative to Reso No. 2021-954, he asked who would be overseeing this service. Relative to Reso No. 2021-956, he asked for additional information relative to the transfer. Relative to Reso No. 2021-971, he asked if the cited cost included the cost of title insurance. Relative to Reso Nos. 2021-985 through 2021-9995, he asked why these election-related Resolutions could not be introduced all at once. Relative to Reso No. 2021-1001, Mr. Paterson asked why this task could not be completed by County personnel. Relative to Reso No. 2021- 1004, he asked about the vendor's involvement with this item as there was no Reso ever executed for the cited vendor. Relative to Reso No. 2021-1005, Mr. Paterson asked if there were restrictions regarding how these settlement monies would be spent. Relative to Reso No. 2021-1006, he asked for an overview. To close, he wished everyone Happy Holidays.

Relative to Reso No. 2021-954, Director Taylor advised that someone had been designated through mass mutual to monitor the fees to make sure they were consistent with industry standards. She confirmed this was of no cost to the County.

Relative to Reso No. 2021-956, Director Taylor advised that the total transfer was \$45,000 and monies were being transferred from Social Security to cover various control accounts within the Departments of Administrative Services and Engineering as well as the Board of Taxation.

Relative to Reso No. 2021-971, Counsel Bergen confirmed that the cited costs would cover the title search, title insurance, and closing costs. He added that the cost of title insurance was dependent on the sale price.

Relative to Reso Nos. 2021-985 through 2021-995, Administrator DiRado advised that these items related to mandated costs associated with ensuring a secure and transparent election. She added that changes to costs and or contracts were often necessitated by legislative changes.

Relative to Reso No. 2021-1001, Deputy County Manager Wagner advised that grant writing and the procurement of grant opportunities was an incredibly elaborate process that often required extensive research. She added that this resource was also used by six municipalities throughout the County, allowing them to apply for grants for municipal initiatives.

Relative to Reso No. 2021-1004, Counsel Bergen advised that the County was a member of a state-wide insurance fund as a means to curb related expenses. He added that the vendor was not hired directly by the County, but rather by the joint insurance fund.

Relative to Reso No. 2021-1005, Counsel Bergen advised that the monies from the settlement could only be used on future expenses related to treating and preventing opioid addiction as a means to combat the damage done by the defendants.

Relative to Reso No. 2021-1006, County Manager Oatman advised that the agreement included a 3-year contract with a 2% annual increase.

Clerk of the Board Pellettiere confirmed that there were no additional members of the public wishing to speak.
