# THURSDAY, JUNE 10, 2021 REGULAR MEETING MINUTES

#### CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:20 P.M.

# ROLL CALL

Roll call showed Chairman Alexander Mirabella, Vice Chair Rebecca Williams, Commissioner Sergio Granados, Commissioner Christopher Hudak, Commissioner Bette Jane Kowalski, Commissioner Lourdes Leon, and Commissioner Kimberly Palmieri-Mouded, and Commissioner Andrea Staten were present; with Commissioner Angela R. Garretson absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

#### PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

# STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

#### APPROVAL OF COMMUNICATIONS

Note and File

Chairman Mirabella called for a motion to approve Communications. On a motion made by Commissioner Hudak and seconded by Vice Chair Williams, roll call showed eight members of the Board voted in the affirmative; with Commissioner Garretson absent.

### **ORDINANCE FOR ADOPTION**

AN ORDINANCE TO AMEND PART 1-THE UNION COUNTY ADMINISTRATIVE CODE, CHAPTER 1, UNION COUNTY GOVERNMENT STRUCTURE BY AMENDING ARTICLE XIV-DEPARTMENTS. DIVISIONS, BUREAUS §1-71. DEPARTMENTS ENUMERATED; DELETING ARTICLE XX-DEPARTMENT OF CORRECTIONS; and, AMENDING CHAPTER 140, CONTRACTED OFF-DUTY EMPLOYMENT OF LAW ENFORCEMENT OFFICERS.

County Counsel Bruce Bergen advised that Ordinance 829-2021 was introduced for first reading during the Board's last meeting on May 20, 2021 and related to the closing of the UC

Jail and the elimination of the Department of Corrections. He further advised that since then it became necessary to amend the pending ordinance to comply with requests from the civil service commission and labor unions. He added that the County had decided to withdraw the initial Ordinance, rather than amend and reintroduce a more comprehensive item to maintain transparency and ensure that the public was properly informed.

Chairman Mirabella asked for a motion to withdraw Ordinance 829-2021. On a motion made by Vice Chair Williams and seconded by Commissioner Kowalski, roll call showed eight members of the Board voted in the affirmative; with Commissioner Garretson absent.

#### **ORDINANCE FOR INTRODUCTION**

AN ORDINANCE TO AMEND PART 1-THE UNION COUNTY
ADMINISTRATIVE CODE, CHAPTER 1, UNION COUNTY
GOVERNMENT STRUCTURE BY AMENDING ARTICLE XIVDEPARTMENTS. DIVISIONS, BUREAUS §1-71. DEPARTMENTS
ENUMERATED; DELETING ARTICLE XX-DEPARTMENT OF
CORRECTIONS; and, AMENDING CHAPTER 140, CONTRACTED OFFDUTY EMPLOYMENT OF LAW ENFORCEMENT OFFICERS.

#### FIRST READING STATEMENT

Vice Chairman Rebecca Williams, Policy Chair, moved Ordinance Number 830-2021 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The Public Hearing and Final Reading will be held on June 24, 2021.

On a motion a motion made by Vice Chair Williams and seconded by Commissioner Kowalski, roll call showed eight members of the Board voted in the affirmative; with Commissioner Garretson absent.

#### SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Chairman Mirabella and seconded by Vice Chair Williams roll called showed eight members of the Board voted in the affirmative; with Commissioner Garretson absent.

#### **PUBLIC COMMENT PORTION**

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

Maria Echeverria, of Elizabeth, expressed her concerns relative to the COVID-19 vaccines as well as Bill S3866 which had recently passed the NJ Legislature and allowed Governor Murphy to retain fourteen executive orders relative to the COVID-19 pandemic even after the public health emergency was rescinded.

Chairman Mirabella thanked Ms. Echeverria for her comments, noting the Board's commitment to science and sense and consequently the COVID-19 vaccination efforts.

Bruce Paterson, of Garwood, thanked fellow Union County resident Maria Echeverria for her comments, noting the importance of respecting alternative perspectives and opposing viewpoints. Relative to Ordinance 830-2021, he inquired about the fashion by which this ordinance had been presented. Additionally, Mr. Paterson inquired about several Resolutions. Relative to Reso No. 2021-427 and Reso Nos. 430-439, he inquired if these pandemic-related monies were already included in the 2021 Budget. Relative to Reso 2021-458, he asked who the cited advocates were. Relative to Reso No. 2021-461, he asked for additional information relative to the cited agreements. To close, he made comments related to Acting Prosecutor Lyndsay Ruotolo and her new position at the State with the Juvenile Justice Division.

Relative to Reso No. 2021-427 and Reso Nos. 430-439, Director Taylor advised that these would items did modify the 2021 Budget in the amount of \$10,211,930.08. Additionally, she noted that the related grants also modified the adopted budget and would include items as revenue appropriating the same amount in the general ledger.

Relative to Reso No. 2021-458, Acting Prosecutor advised that this item related to a grant which was secured annually through the federal government to cover direct victim witness services. She added that these funds would cover the salary of six victim witness advocates, a program assistant, and a victim notification clerk as well as resources related to referral services, relocation services, and food insecurity among other services.

Relative to Reso No. 2021-461, County Counsel Bergen advised that this item related to specialized counseling services, noting that the vendor had been working with the County since the previous year relative to the UC Jail closure and the elimination of the Department of Corrections. He added that the help from the civil service commission and unions relative to this change had been invaluable.

Chairman Mirabella noted his approval and the Board's approval of the work done by Acting Prosecutor Ruotolo during her time with the County of Union and wished her well on her new position.

Commissioner Garretson joined the meeting.

Clerk of the Board Pellettiere confirmed there were no remaining members of the public wishing to comment.
