THURSDAY, AUGUST 12, 2021 AGENDA SETTING MEETING MINUTES

CALL TO ORDER

Vice Chair Williams presided over the meeting and called the meeting to order at 5:06 P.M.

ROLL CALL

Roll call showed Vice Chair Rebecca Williams, Commissioner Angela R. Garretson, Commissioner Sergio Granados, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, and Commissioner Kimberly Palmieri-Mouded were present; with Chairman Alexander Mirabella, Commissioner Christopher Hudak, and Commissioner Andrea Staten absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

Vice Chair Williams addressed the public:

Good evening, and welcome to another remote meeting of the Commissioner Board.

My name is Rebecca L. Williams. I am the Vice Chair of the Union County Board of County Commissioners. As Chairman Mirabella is not with us tonight, I will be conducting tonight's meeting.

Let's start with an update on our COVID-19 response efforts. We have mobile vaccination clinics visiting neighborhoods throughout Union County, with free vaccines for everyone. Free vaccines are also available at our permanent clinics in Elizabeth, Union Township, and Plainfield. We also offer free testing. You can book an appointment at any of these sites, by going online at ucnj.org/vax. If you need help with the online system, you can call the Union County COVID-19 Call Center, at 908-613-7829 for assistance. It's simple. Now is not the time to sit on the sidelines. This is the time to step up, and take action.

Also, if you have been impacted financially by the pandemic, please be aware that we are still continuing to distribute emergency food supplies. Earlier this month we also launched a rental assistance program. For information about these programs and other resources, please visit us online at ucnj.org/covid19.

Turning now to other matters, on behalf of the Commissioner Board I want to thank U.S. Transportation Secretary Pete Buttigieg for coming to Union County for a roundtable discussion on our infrastructure. And, I would like to thank U.S. Representative Tom Malinowski, who also attended. There was much to discuss, including the Gateway tunnel project and the one-seat ride. The Commissioner Board has spent many years advocating for these projects and we will continue to work with our local Mayors, Secretary Buttigieg, and Congressman Malinowski, to keep them moving forward.

We also continue to provide outdoor activities in County parks, consistent with public health guidelines during the pandemic.

We strive to be inclusive, so if you are a special needs family, we have a number of upcoming events and activities. We'll be hosting an outdoor art project, a fishing derby, and spray park sessions for people with special needs in this month. We are also gathering a contingent of Red Bulls fans for the Special Needs Night at Red Bulls Arena on August 28. Visit the Office for People with Disabilities and Special Needs on the County website for more information, at ucnj.org.

I would also like everyone to know that Union County is a sponsor of the upcoming Rahway RiverFest, in Rahway.

RiverFest is a weeklong series of outdoor activities, from August 21 to August 28, organized by the Rahway River Watershed Association. Many of the events take place in Union County parks, and it sounds like lots of fun. We are very proud to support the event. Commissioner Kowalski inquired how residents would be able to know of additional information relative to the new early-voting option in New Jersey.

Deputy Clerk Fernandez advised that additional information could be found on the Board of Elections website relative to locations offering early-voting options. She also advised that residents could also visit unioncountyvotes.com for location details.

OFFICE OF THE UNION COUNTY PROSECUTOR

William Daniel, Prosecutor

Prosecutor Daniel advised that the two items offered for adoption would have no financial impact on Union County as these items were covered by grant funding.

- 1. Authorizing the County Manager, through the Union County Prosecutor's Office, to enter into a Shared Services Agreement with Essex County for the utilization of the Union County Forensic Laboratory by an Essex County Forensic Scientist for a period of three (3) years commencing upon execution of the Agreement. (Chairman Alexander Mirabella)
- 2. Amending Resolution Number 2020-704, to increase the rate for the on-call exam fee (adult cases performed) of Sexual Assault Nurse Examiners/Forensic Nurse

Examiners who serve as Independent Contractors as part of the Union County Sexual Assault Response Team (SART) for the period of October 1, 2020 through September 30, 2021 (no change in contract amount). (Chairman Alexander Mirabella)

BOARD OF ELECTIONS

Nicole DiRado, Administrator

- 1. Amending Resolution Number 2021-108, a contract with West Publishing Corporation, a Thomson Reuters Business, Eagan, MN, to include an additional account number and increase the not to exceed amount by \$1,254.00 to provide statute books for the Union County Board of Elections. (Chairman Alexander Mirabella)
- 2. Authorizing the County Manager to enter into contract with ES&S, Omaha, Nebraska, to provide voting equipment, including electronic poll books and voting machines, project management and onsite services for early voting and Election Day pursuant to PL 2021 Ch. 40 in an amount not to exceed \$3,060,085.00. Vice Chair Williams asked Administrator DiRado to elaborate on this item.

Administrator DiRado advised that for the first time ever, New Jersey would allow for early-voting options this year. She further advised that the cited vendor was the BOE's current voting tabulator provider and this item would fund the purchase of over 1,000 electronic poll books and an additional 99 voting machines, reserved for early-voting. She added that this item would also fund electronic poll books to be used in all elections going forward. She advised that voters would no longer sign an actual book on Election Day, but rather would sign a tablet with a stylus starting this General Election.

Commissioner Garretson inquired about other Counties/Municipalities that would be employing a tablet to capture voters' electronic signatures.

Administrator DiRado advised that the directive to employ this resource was pursuant to state statute and was required statewide.

3. Authorizing the County Manager to enter into a lease agreement with the Liberty Group, Berkeley Heights, for the purpose of leasing warehouse space for the Union County Board of Elections new early voting and Election Day equipment for a period of 24 months for an amount not to exceed \$318,600.00. Commissioner Granados asked Deputy County Manager Wagner to elaborate on this item.

Deputy County Manager Wagner advised about a recently opened portal which could be used by income-eligible residents to apply for rental assistance for both tenants and landlords that were delinquent. She added that the resource would cover 12 months of back rental payments and three additional months of prospective rent. She noted that it would also cover arrearages relative to electric and gas utility bills. She advised that interested residents could use the County website to apply.

Commissioner Leon asked Deputy County Manager Wagner if this assistance was available for both tenants and landlords.

Deputy County Manager Wagner advised that both tenants and their respective landlords would have to participate in order to determine arrearages. She added that back rent would get paid directly to the landlord upon approval.

Vice Chair Williams advised that she had seen a commercial earlier advertising the assistance, noting it as a great and effective resource relative to outreach.
