

UNION COUNTY BOARD OF COUNTY COMMISSIONERS

THURSDAY, SEPTEMBER 23, 2021 REGULAR MEETING MINUTES

CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:25 P.M.

ROLL CALL

Roll call showed Chairman Alexander Mirabella, Vice Chair Rebecca Williams, Commissioner Angela R. Garretson, Commissioner Sergio Granados, Commissioner Christopher Hudak, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, and Commissioner Kimberly Palmieri-Mouded were present; with Commissioner Andrea Staten absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

APPROVAL OF COMMUNICATIONS

Note and File

Chairman Mirabella called for a motion to approve the Communications. On a motion made by Commissioner Kowalski and seconded by Vice Chair Williams, roll call showed eight members of the Board voted in the affirmative; with Commissioner Staten absent.

SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Vice Chairman Williams and seconded by Commissioner Leon, roll called showed eight members of the Board voted in the affirmative; with Commissioner Staten absent.

PUBLIC COMMENT PORTION

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

Bruce Paterson, of Garwood, made comments and asked questions relative to several resolutions. Relative to Reso 2021-701, he asked what types of vehicles were being purchased and what services would be provided. Relative to Reso 2021-707, Mr. Paterson asked why type of financial services would be provided. Relative to Reso No. 2021-714, he asked for additional information relative to the cited engineering project. Relative to Reso No. 2021-715, Mr. Paterson asked when this project would be completed. Relative to Reso No. 2021-725, he asked if this item was related to the ransomware attack suffered by the County in 2019. Regarding general comments, he spoke about the Union County Improvement Authority.

Relative to Reso No. 2021-701, Director Anderson advised that these custom vehicles would serve as on-the-go offices for the Department of Human Services, equipped with computers and internet access to provide residents with resources in a more convenient fashion.

Relative to Reso No. 2021-707, Director Taylor advised that this request was made on behalf of the Administration in order to study subsidies associated with the psychiatric facility at Cornerstone Behavioral Health Hospital. She added that there were several sources of funding relative to Medicaid as well as other back date payments, state aid and private insurance providers. She advised that consequently there was need for outside assistance from the cited vendor to quantify subsidies associated with various sources of revenue.

Relative to Reso No. 2021-714, Director Graziano advised that Engineering Project Number 2020-014 was the assigned name of the project requiring the on-call services. He noted that this particular change related to certain environmental issues involving asbestos and mold remediation in the County Surrogate office.

Relative to Reso No. 2021-715, Director Graziano advised that he expected to complete the close out of this project in January or February of next year. He added that ten floors of the stairwell had been completed thus far and expected the remaining floors to be complete by December. He added that this project was needed to ensure the safety of those accessing the building. He noted that this project had come in under 20% relative to change orders.

Relative to Reso No. 2021-725, Deputy County Manager Wagner confirmed that the County had fallen victim to a ransomware attack in November of 2019, but a forensic investigation had concluded that no systems had been breached. She added that this item would allow the county to conduct vulnerability and risk assessment for its entire data network as well as look for additional security and protective measures.

Carolyn Brink, of Fanwood, spoke relative to her husband, a former employee of the UCIA, receiving a termination notice on September 9th via County messenger.

Counsel Bergen advised that the County had followed all appropriate and required procedures relative to this matter. He noted that because this was a private personnel matter, he could not offer additional comments in public because it was unlawful.

John Bury, of Kenilworth, cited state statutes regarding contributions from business entities doing business with the County.

Counsel Bergen assured Mr. Bury that both the Purchasing Division and County Counsel Office were familiar with the rules and regulations he cited and were careful to ensure compliance as prescribed by law.

RESOLUTIONS FOR ADOPTION

On a motion made by Vice Chair Williams and seconded by Commissioner Palmieri-Mouded roll call showed eight members of the Board voted in the affirmative; with Commissioner Staten absent.

COMMISSIONER REPORTS AND COMMENTS

Commissioner Leon noted that she had recently participated in the County's first Hispanic Heritage Month flag raising event alongside her colleague, Commissioner Granados. She added that it was a lovely event and hoped the celebration would continue annually. She thanked City of Rahway Mayor Giacobbe for the invitation to the celebration. She also thanked the United Way of Union County for honoring her with a Certificate of Recognition. On another note, she offered her deepest sympathies to the family and friends of Ms. Damarys Vazquez, of Elizabeth, that died tragically in a house fire. Commissioner Leon noted that Ms. Damarys Vazquez was a prominent figure in the community, having taught ballet for over 30 years at her studio Damarys Dance Studio in Elizabeth.

Commissioner Kowalski thanked the County's administrative body and all of the Union County family for their efforts relative to Hurricane Ida. She also thanked Chairman Mirabella, County Manager Oatman and Deputy County Manager Wagner for facilitating meetings with the various Mayors throughout the area to keep communities informed about these efforts. She noted the efforts of the Departments of Public Safety, Parks and Recreation, and Human Resources for their continued efforts in providing County residents with essential resources during this time.

Commissioner Hudak referenced Bruce Paterson's comments, noting the speaker was very familiar with the stairwell project and the essential nature of this project as a means to ensure the safety of employees and the public alike. He added that he was pleased with the direction the County was going in, noting that the County was in a much better financial position now than it had been previously. He also recognized Finance Director Taylor for her efforts related to these financial improvements. On another note, he spoke

about his recent attendance of the Polish Flag Raising ceremony that took place at the UC Courthouse in Elizabeth.

Commissioner Garretson noted that she had the pleasure of visiting her hometown of Hillside, alongside many state officials, including Governor Murphy, to participate in the ribbon-cutting ceremony for the new Hillside Innovation Academy. On another note, she highlighted the need for additional educational resources relative to the spotted lantern flies.

Commissioner Palmieri-Mouded advised residents about an upcoming mobile paper shredding event in Westfield, tomorrow September 24th. She also reminded residents about an upcoming diaper drive collection event on Saturday in New Providence to assist families throughout the community by providing diapers. On another note, she welcomed the new Executive Director of the UC Performing Arts Center in Rahway, Mr. Craig Sumberg noting his many years of experience at the helm of the South Orange Performing Arts Center. She added that the UC Performing Arts Center would be reopening on September 25th with a performance by Bowling for Soup. To close, she reminded residents about a job fair in Westfield on September 29th and encouraged those interested to attend the event.

Vice Chair Williams echoed the sentiments of her colleague, Commissioner Hudak, and recognized Finance Director Taylor for her leadership and efforts. On another note, she spoke relative to the Plainfield House Music Festival sponsored by the County and the City of Plainfield to raise awareness for prostate cancer. She noted that the event was a success and hoped to continue this partnership in the future. She also spoke relative to a Hispanic Heritage Celebration she attended alongside Commissioner Leon, adding that it was a wonderful celebration. To close, she reminded residents that October was Arts and Humanities Month.

Chairman Mirabella recognized County Manager Oatman, Deputy County Manager Wagner, as well as, all the Directors throughout the County, including Directors Moran and Anderson for their efforts relative to Hurricane Ida and its aftermath, including establishing a helpline for residents affected by the storm. He also recognized Director Graziano, County Police and the local fire departments for their efforts. He noted that he had the opportunity to attend a recent help fair in Cranford, offering services and resources to residents in need through FEMA, The American Red Cross, and United Way. On another note, he spoke relative to his sister-in-law being honored with Summit's Good Scout Award, adding that Commissioner Kowalski has also been recognized by a separate scout organization. He also spoke relative to Anthony Russo for being honored with a Lifetime Achievement Award by the Italian Tribune. To close, Chairman Mirabella spoke about the UC Performing Arts Center and several upcoming shows, thanking County Manager Oatman and Victoria Durbin-Drake for their efforts relative to serving as Board Member and President of UCPAC respectively.

Vice Chair Williams asked for a motion to adjourn the meeting. On a motion made by Vice Chair Williams and seconded by Commissioner Kowalski, roll call showed seven members of the Board voted in the affirmative; with Commissioner Granados and Commissioner Staten absent.
