CALL TO ORDER

Chairman Mirabella presided over the meeting and called the meeting to order at 5:37 P.M.

ROLL CALL

Roll call showed Chairman Alexander Mirabella, Freeholder Angela R. Garretson, Freeholder Sergio Granados, Freeholder Christopher Hudak, Freeholder Bette Jane Kowalski, Freeholder Kimberly Palmieri-Mouded, Freeholder Andrea Staten, and Freeholder Rebecca Williams were present.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

Chairman Mirabella called for a motion to approve the Minutes. On a motion made by Freeholder Williams and seconded by Freeholder Palmieri-Mouded, roll call showed eight members of the Board voted in the affirmative for the August 13th Agenda Setting and Regular Meeting Minutes.

ORDINANCE FOR ADOPTION

817-2020 CAPITAL ORDINANCE OF THE COUNTY OF UNION, NEW JERSEY AUTHORIZING THE DEMOLITION OF THE EXISTING COUNTY

PARKING DECK ON ELIZABETHTOWN PLAZA AND THE CONSTRUCTION OF A NEW PARKING DECK ON SUCH SITE IN, BY AND FOR THE COUNTY, APPROPRIATING THEREFOR THE SUM OF \$13,500,000 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM CAPITAL SURPLUS OF THE COUNTY.

BE IT ORDAINED by the Board of Chosen Freeholders of the County of Union, New Jersey, as follows:

Section 1. The County of Union, New Jersey (the "County") is hereby authorized to demolish the existing County Parking Deck on Elizabethtown Plaza and construct a new Parking Deck on such site in, by and for the County. Said improvement shall include all work, materials and appurtenances necessary and suitable therefore.

Section 2. The sum of \$13,500,000 is hereby appropriated to the payment of the cost of the improvement authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from Capital Surplus of the County as hereinafter provided. The sum of \$13,500,000 is hereby appropriated from Capital Surplus of the County to the payment of the cost of said purpose.

Section 3. Said improvement is a lawful capital improvement of the County having a period of usefulness of at least five (5) years. Said improvement shall be made as a general improvement, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Clerk of the Board of Chosen Freeholders and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.

PUBLIC COMMENT PORTION.

The meeting was opened for the purpose of commenting on Ordinance No. 817-2020 only.

Clerk Pellettiere advised there were two members of the public in the cue. He added that he had not received any correspondence from any other member of the public wishing to speak.

Bruce Paterson, of Garwood, made comments relative to how the project was being funded and inquired about Reso No. 2020-484 from June which he claims cited demolition costs.

County Manager Oatman confirmed that the cited Resolution from June did not include demolition costs.

Michael Carvallo from the public cue had no comments.

FINAL READING STATEMENT

Freeholder Sergio Granados, Fiscal Chairman, moved Ordinance Number 817-2020 for Final Reading and authorized the Clerk of the Board to advertise same in accordance with the law.

On a motion made by Freeholder Granados and seconded by Freeholder Williams, roll call showed eight members of the Board voted in the affirmative.

ORDINANCE FOR INTRODUCTION

AN ORDINANCE TO AMEND THE UNION COUNTY SOLID WASTE MANAGEMENT PLAN BY INCLUDING A CLASS "C" RECYCLING FACILITY TO BE OWNED AND OPERATED BY LINDEN RENEWABLE ENERGY, LLC LOCATED AT 4900 TREMLEY POINT, LOT 8.02, BLOCK 587, LINDEN, NEW JERSEY TO ACCEPT ORGANIC WASTE OR ORGANIC SUBSTRATE AND UTILIZE ANAEROBIC DIGESTION TO CREATE RENEWABLE NATURAL GAS, A MARKETABLE SOIL AMENDMENT, AND LIQUID DIGESTATE THAT WILL BE PROCESSED ON SITE TO PRODUCE LIQUID ORGANIC FERTILIZER.

WHEREAS, pursuant to the Solid Waste Management Act, N.J.S.A 13:1E-1 et seq., the County of Union is designated as a Solid Waste Management District and by law did develop and prepare a District Solid Waste Management Plan ("County Plan") that was adopted by the Union County Board of Chosen Freeholders on June 7, 1979, pursuant to and in accordance with the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq.; and

WHEREAS, the County Plan was approved, with modifications, by the Department of Environmental Protection ("NJDEP") on August 13, 1980, and has since been amended and modified from time to time; and

WHEREAS, on December 11, 1986, the Union County Board of Chosen Freeholders designated the Union County Utilities Authority ("UCUA") as the agency responsible for the implementation of the County Plan, as amended from time to time, and the UCUA is empowered to plan, acquire, construct, maintain and operate facilities for the processing, disposal and/or recycling of solid waste generated in the County; and

WHEREAS, the UCUA has formulated a Plan Amendment, and recommends that this Board set a public hearing for the purpose of taking public testimony on the proposed plan amendment, and review and enact said amendment that is now on file with the Clerk of this Board and available for public inspection and is made a part hereof by reference; and

WHEREAS, the subject amendment is summarized as follows:

This Plan Amendment is prepared as a result of a determination by the UCUA to:

TO MODIFY THE UNION COUNTY SOLID MANAGEMENT PLAN BY INCLUDING A CLASS RECYCLING FACILITY TO BE OWNED AND OPERATED BY LINDEN RENEWABLE ENERGY, LLC LOCATED AT 4900 TREMLEY POINT, LOT 8.02, BLOCK 587, LINDEN, **JERSEY** TO ACCEPT **ORGANIC** WASTE **ORGANIC** SUBSTRATE **AND** UTILIZE ANAEROBIC DIGESTION TO CREATE RENEWABLE NATURAL GAS, A MARKETABLE SOIL AMENDMENT, AND LIQUID DIGESTATE THAT WILL BE PROCESSED ON SITE TO PRODUCE LIQUID ORGANIC FERTILIZER.

WHEREAS, pursuant to the Solid Waste Management Act, the County's Solid Waste Advisory Committee ("SWAC") must be consulted with respect to amendment to the County Plan; and

WHEREAS, by Resolution No. 33-2020, duly adopted June 17, 2020, the UCUA approved the Plan Amendment and recommended that the Plan Amendment be approved by the Board of Chosen Freeholders of the County, after public hearing in accordance with the Solid Waste Management Act; and

WHEREAS, pursuant to and in accordance with the provisions of the Solid Waste Management Act, the Plan Amendment was presented to SWAC:

NOW, THEREFORE, BE IT ORDAINED, by the Board of Chosen Freeholders of the County of Union, that:

1. The aforesaid recitals are incorporated herein as though fully set forth at length.

- 2. The Plan Amendment, as prepared and recommended by the Union County Utilities Authority, is hereby adopted as an Amendment to the Union County District Solid Waste Management Plan.
- 3. Any provision of the County Plan that is inconsistent with the Plan Amendment is hereby repealed to the extent of said inconsistency and the provisions of the Plan Amendment shall be fully effective and shall control.
- 4. A certified copy of this Ordinance, as finally adopted, together with the Plan Amendment, shall be forwarded to the New Jersey Department of Environmental Protection, the County Clerk of the County of Union, and the Union County Utilities Authority.
- 5. The Clerk of this Board shall publish and disseminate notice of this Ordinance as provided by law.
- 6. The aforesaid Plan Amendment and a copy of the transcript of the public hearing to be held at such time as may be scheduled by said Board of Chosen Freeholders, and the necessary deliberations shall be submitted to the Commissioner of the New Jersey Department of Environmental Protection.
- 7. This Ordinance shall take effect in the manner prescribed by law.

FIRST READING STATEMENT

Freeholder Christopher Hudak, Freeholder Liaison to the Union County Utilities Authority, moved Ordinance Number 818-2020 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The public hearing and final reading will be scheduled to be held on October 1, 2020.

Clerk Pellettiere advised that Ordinance No. 818-2020 was being reintroduced, despite having been initially introduced on June 18th and adopted on July 23rd, due to new requirements relative to COVID-19. He noted that the NJDEP had requested the Ordinance be reintroduced to include the quantity of liquid organic food waste that would be processed in the public notice.

On a motion made by Freeholder Hudak and seconded by Freeholder Granados, roll call showed eight members of the Board voted in the affirmative.

ORDINANCE FOR INTRODUCTION

819-2020 AN ORDINANCE TO AMEND ORDINANCE NO. 799-2018 ENTITLED "AN ORDINANCE TO AMEND ORDINANCE NO. 506-99 ENTITLED 'AN ORDINANCE ESTABLISHING LAND DEVELOPMENT STANDARDS FOR THE COUNTY OF UNION' ADOPTED BY THE UNION COUNTY BOARD OF CHOSEN FREEHOLDERS ON SEPTEMBER 9, 1999".

- WHEREAS, in accordance with the County Planning Enabling Act (N.J.S.A. 40:27 et seq.), the Board of Chosen Freeholders of the County of Union did Amend Ordinance No. 506-99 adopted September 23, 1999, by way of Ordinance No. 799-2018 adopted on October 11, 2018 to amend the Land Development Standards Fee Schedule; and
- WHEREAS, the Union County Planning Board ("UCPB") considered a need to update the 2018 Fee Schedule as it found that the exemption review was not clearly addressed in the fee schedule as revised by Ordinance 799-2018; and
- **WHEREAS**, the UCPB considered various options that could be used in relation to applicants seeking exemption from County Planning-Board Review; and
- **WHEREAS**, the UCPB requested staff review potential exemption review cost as the current fee schedule did not specify this cost; and
- WHEREAS, the UCPB reviewed and discussed the comparative information requested of staff over three board meetings; and
- **WHEREAS**, the UCPB recommends the adoption of the attached 2020 Land Development Application Fee Schedule update adding an exemption review fee:
- **NOW, THEREFORE, BE IT ORDAINED** by the Board of Chosen Freeholders of the County of Union that:
- A. Ordinance No. 799-2018 is hereby amended by adding an Application Exemption Review Fee schedule as approved by the County Planning Board.
- B. That the Clerk of the Board is hereby authorized to publish a notice in the appropriate newspaper of such introduction and of a public hearing on October 1, 2020 and shall forward one certified copy, upon final passage, to each Clerk of all Municipalities located within the County of Union.
- C. That the Clerk shall give notice of the Public Hearing and a copy of this Ordinance by certified mail or delivery to the Municipal Clerk and Secretary of the Municipal Planning Board in each Municipality in the County of Union at least 10 days prior to the date set for public hearing.
- D. That this Ordinance shall take effect at the time and in the manner provided by law.

FIRST READING STATEMENT

Freeholder Rebecca Williams, Policy Committee Chairman, moved Ordinance Number 819-2020 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The public hearing and final reading will be scheduled to be held on October 1, 2020.

On a motion made by Freeholder Williams and seconded by Freeholder Kowalski, roll call showed eight members of the Board voted in the affirmative.

SUSPENSION OF RULES

Suspension of the rules to allow for the joining of both Public Comments on resolutions being offered for adoption, and Public Comments on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Chairman Mirabella called for a motion to Suspend the Rules. On a motion made by Freeholder Kowalski and seconded by Freeholder Granados roll called showed eight members of the Board voted in the affirmative.

PUBLIC COMMENT PORTION

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

Bruce Paterson, of Garwood, made comments and asked questions relative to several Resolutions. Relative to Reso Nos. 2020-633 and 2020-634, he asked for additional information relative to the expense. Relative to Reso Nos. 2020-622, 2020-623, and 2020-624, he asked about the increase in spending. Relative to Reso No. 2020-632, Mr. Paterson commented on the UCIA and how the money would be spent. Relative to Reso No. 2020-642, he congratulated former Vice Chairman Angel G. Estrada on his retirement and recognized his many years of service to the Board and community as a whole. To close, Mr. Paterson inquired about the upcoming COVID-19 mobile-testing unit in Garwood, in particular what kind of exam would be offered.

Relative to Reso Nos. 2020-633 & 2020-634, County Manager Oatman advised that these items would furnish a variety of resources and services including PPE gear. Director Taylor added that funds would also be used to lessen the financial strain on parents in light of distance learning, noting that funds would be used to offset unanticipated child care costs as well as furnish lunches for children who would otherwise be eligible for free or reduce-meal plans through school.

Relative to Reso Nos. 2020-622, 2020-623, and 2020-624, County Clerk Rajoppi advised that much of the increase was relative to the additional resources needed for an all-mail General Election, as mandated by Executive Order 177. She noted that the only miscellaneous expense related to a "How to Vote" brochure she had opted to include with the mailing to offer additional guidance to voters unfamiliar with the vote-by-mail process. She added that postage would be covered as an additional convenience to voters, noting a reasonable charge of \$0.42 per envelope.

Relative to Reso No. 2020-632, County Manager Oatman advised that funding would be used for some of the costs associated with the new government complex project, including the hiring of an architect.

Relative to the mobile-testing unit in Garwood, County Manager Oatman confirmed the saliva testing would be conducted.

Michael Carvallo, also in the public cue, had no comments.

Clerk Pellettiere read a comment into the record for Maria Echeverria, of Elizabeth. She expressed her concerns relative to Legislative Bill A4576 and mandatory flu vaccinations for children K-12.

Clerk Pellettiere confirmed there were no additional public comments.
