# CALL TO ORDER

Chair Williams presided over the meeting and called the meeting to order at 6:23 P.M.

#### ORDINANCE FOR ADOPTION

AN ORDINANCE TO AMEND "THE LAWS OF UNION COUNTY:
ADMINISTRATIVE CODE AND POLICIES AND GENERAL
LEGISLATION" BY ADOPTING THE 2022 DEPARTMENT OF PARKS
AND RECREATION FEES FOR RECREATION FACILITIES AND THE
UNION COUNTY OFFICE OF HEALTH MANAGEMENT FOOD AND
BEVERAGE FEE SCHEDULE.

**BE IT ORDAINED** by the Board of County Commissioners of the County of Union as follows:

- 1. That the schedule of fees attached hereto, hereby amends the official fees for the Department of Parks and Recreation Facilities for 2022. All fees not included herein will remain as previously adopted.
- 2. That the schedule of fees attached hereto, hereby amends the official fees for the Union County Office of Health Management Food and Beverage for 2022. All fees not included herein will remain as previously adopted.

- 3. That this Ordinance shall take effect at the time and manner provided by law.
- 4. That the Clerk of the Board be and is hereby authorized and directed to publish the required notice in the appropriate newspaper of such introduction and of a public hearing on March 3, 2022 and shall forward one certified copy, upon final passage, to each Clerk of all Municipalities located within the County of Union.
- 5. That the fee schedules pertinent to this Ordinance are on file in the Clerk of the Board's Office.

# FIRST READING STATEMENT

Vice Chair Christopher Hudak, Policy Committee Chair, moved Ordinance Number 836-2022 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The public hearing was scheduled to be held on March 3, 2022.

#### **PUBLIC COMMENT PORTION**

The meeting was opened to the public for the purpose of commenting on Ordinance No. 836-2022 being offered for adoption only.

There were no comments or questions from the public related to Ordinance No. 836-2022.

Chair Williams called for a motion to adopt Ordinance No. 836-2020. On a motion made by Vice Chair Hudak and seconded by Commissioner Kowalski, roll call showed nine members of the Board voted in the affirmative.

#### **PUBLIC COMMENT PORTION**

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption and any governmental issue that a member of the public feels may be of concern to the residents of the county.

John Bury, of Kenilworth, asked questions related to the budget. He also asked why group health insurance costs had increased by 20%. Regarding the Department of Corrections, he asked if jail costs were now included under another department's budget. Regarding the Union County Improvement Authority, he inquired about the amount being allocated to the UCIA and why it was substantially less than years prior.

Related to group health insurance, County Manager Oatman advised that health insurance costs had increased as did hospital visit costs, adding that some of the increase was due to COVID-19.

Related to the Department of Corrections, County Manager Oatman advised that the remnants of the Correction's Department budget, which included various costs and salaries was now included under the Sheriff's Office.

Regarding the UCIA, County Manager Oatman confirmed that aid to that organization had gone down.

Dan Smith, of Clark, spoke relative to Mohawk Park and thanked the County and Board for the continued improvements to the County Park Systems. He inquired about additional improvements as some of the areas of the cited park seemed incomplete, noting an issue with parking. He also noted that there was no identifying signage on one side of the park and inquired about future plans for the structure currently on site. On another note, he spoke about construction being done throughout the County and inquired about damage being done to County roads and who would be responsible for those repairs. To close, he thanked Lamar Mackson, Director of Video Services, for providing the Commissioner meetings to be aired on Clark TV 36.

Relative to the construction on County roads, Director Graziano advised that the Bureau of Inspections was responsible for overseeing permit projects on County roads. He noted that patches were used as a temporary repair and the vendor was responsible for returning to the site at a later time and bringing the road repair upto-grade. He added that he was willing to talk to the resident to address immediate areas of concern. Regarding the parks system, Director Graziano advised that he would work with the Parks Department to remedy the signage issue at Mohawk Park.

Regarding Homestead Farm, County Manager Oatman advised that the structure would be addressed under an agreement with the UCIA and the State to rehabilitate the area and build a field at that location. He added that he expected the project to move forward sometime this year.

Director Zuber advised that parking was an ongoing issue at Mohawk Park, adding that he would work with Director Graziano relative to signage.

There were no additional questions or comments from the public.

She encouraged interested residents to attend the event, noting that representatives from Walgreens would be available to speak to residents regarding employment opportunities. She closed by reminding residents that they could visit the Union County Works Portal for more information on employment services offered by the County.

Commissioner Granados recognized March as Women's History Month, noting that his female Commissioner colleagues made history when Union County became the first County in the State to elect a female-majority Board. On another note, he advised that Union County's Emergency Rental Assistance Program portal would open on March 7<sup>th</sup> at 9am. He encouraged qualifying residents in need to apply for the service that would provide up to 12 months of assistance for unpaid back rent and utilities as well as three additional months of forthcoming assistance. He noted that the monies allocated for this program were part of a total of \$16 million in funding received from the federal government. He advised that once approved, these grant monies would be issued directly to landlords and utility providers on behalf of the approved tenants. He added that assistance was available for all qualifying Union County residents regardless of

immigration status. He noted that the Commissioner Board was committed to providing significant economic relief to low to moderate income households facing housing instability by providing this temporary, financial relief. To close, he recognized Deputy County Manager Wagner and Deana Mesaros for being an integral part of the rental assistance program.

Commissioner Palmieri-Mouded spoke relative to COVID-19 vaccines and advised that moderately to severely immune-compromised individuals 12 years old and up were now eligible to receive a 2<sup>nd</sup> booster of any approved COVID-19 vaccine twelve weeks after their third dose or eight weeks after their 2<sup>nd</sup> dose, if they received the Johnson & Johnson vaccine. She further advised that these individuals were especially vulnerable to COVID-19 and could possibly not achieve the same level of immunity from the vaccine series in comparison to individuals with healthy immune systems. On another note, she spoke relative to an upcoming gun turn-in event at Calvary Assembly Church in Springfield, on April 23<sup>rd</sup> hosted by the County in partnership with the U.C. Prosecutor's Office, Sheriff's Department, and Police Department as well as the Springfield Police Department. She noted that this event would allow residents to safely dispose of firearms, ammunition, and certain prescription drugs to ensure they don't fall into the wrong hands. She noted that this event was part of an ongoing effort by the County to keep the community safe for residents of all ages.

Commissioner Kowalski recognized the St. Patrick's Day Committee, noting that she appreciated the efforts of the Irish-American community. On another note, she spoke relative to the Ukrainian flag raising that took place earlier that day at the Union County Courthouse, adding that the Board stood in solidarity with the people of Ukraine against the attacks of Russia. She noted that she was proud of Poland, Moldova, and other countries that were accepting Ukrainian refugees fleeing the violence, adding that she hoped a peaceful resolution could be reached soon. She also spoke relative to the many events that took place last month in honor of Black History Month, noting her attendance alongside colleague Commissioner Palmieri-Mouded of the field house groundbreaking ceremony for the new athletic field on Chestnut Street in Roselle. She also spoke about a historic presentation made by members of the 24th infantry of the U.S. Army in Roselle relative to the Buffalo soldiers and the history of black soldiers within the various branches of military. She thanked Roselle Mayor Donald Shaw and the Roselle Recreation Department for organizing the event. On another note, Commissioner Kowalski advised that during the week, in honor of Read Across America, the Commissioners had been visiting various classrooms throughout the County to read to students, adding that the County has also organized a virtual reading event for children with disabilities through the Division of Human Services. To close, she noted the resident's comments about Mohawk Park and encouraged residents to take advantage of the upcoming archery program at Oakridge Park as well as visit Trailside Nature and Science Center for their upcoming spring break programs in April for children ages 7-12.

Commissioner Baker commended County Manager Oatman and all the staff that worked diligently and was able to propose a budget with a zero increase, noting the difficulties of achieving such a feat. He added that he hoped the residents of Union County understood the arduous effort that goes into presenting a budget with a zero increase, particularly for the third year in a row, noting that this would benefit all Union County residents regardless of their political affiliation, race, color, or creed.

Commissioner Mirabella noted that he was proud to participate in this year's budget process that once again yielded a zero increase for the third year in a row while also maintaining its triple a bond rating. He advised that a triple a bond rating was awarded to less than 10% of governmental agencies and that accolade was indicative of the successful leadership within Union County amongst the Board of Commissioners and County Administration. He added that he was looking forward to the budget process and finalizing the budget in the coming months. On another note, he spoke relative to Read Across America, during which time, he had the opportunity to read to 2<sup>nd</sup> grade and 4<sup>th</sup> grade classes in Scotch Plains. He noted his conversation with the students regarding the work he did as a County Commissioner. To close, he noted the Ukrainian flag raising event at the Union County Courthouse, adding that he was happy and proud to be able to honor the Ukrainian people during these difficult times. He commended Ukrainian President Zelenskyy, noting that his bravery and unyielding support for his Country was inspiring. He expressed his hope that the conflict between Ukraine and Russia would subside quickly.

Vice Chair Hudak echoed the sentiments of Commissioner Baker and Commissioner Mirabella in commending County Manager Oatman for introducing a budget with a zero increase, adding that he looked forward to the budget process and learning more about the priorities highlighted within the budget. He noted that despite the ongoing pandemic and several outside pressures, the County was able to introduce a budget with a zero increase for the third year in a row while also reforming the size and scope of County government. On another note, he spoke relative to the war in Ukraine, noting it as an unnecessary and unfathomable conflict. He encouraged residents to make donations through various charitable organizations like the Red Cross, and Doctors Without Borders, among others to assist with the crisis. He also noted the upcoming St. Patrick's Day Parade, adding that it was a milestone to have the parade return following a two-year hiatus as a result of the COVID-19 pandemic. To close, he spoke relative to Read Across America, including the virtual reading event organized through the Office of Disabilities and Special Needs, adding that it was a nice treat to be able to share in this pastime with students.

Chair Williams spoke relative to Black History Month, noting a past performance of Fences at Union County Performing Arts Center on February 18th, adding that all nine Commissioners attended the production in addition to a large crowd. She noted the presentation of the Chester Holmes Humanitarian Award to Dr. Inez P. Durham and added that Dr. Durham had sent of letter of gratitude to the Commissioners for the recognition. On another note, she spoke relative to her participation in Read Across America alongside Commissioner Mouded and Vice Chair Hudak, adding that she enjoyed the experience and being able to interact with the children. She also spoke relative to Women's History Month and a series of interviews had taken place at various libraries throughout the County, noting her interview of Plainfield Public Library Director Mary Ellen Rogan. She advised residents that these recorded interviews would be shared on the County's social media outlets. On another note, she also spoke relative to her recent visit to Josephine's Place in Elizabeth, joined by Commissioner Leon and County Clerk Joanne Rajoppi, to kick-off Women's History Month, adding that the nonprofit organization was instrumental in providing resources skills and training for women. Chair Williams provided some history related to the creation of Women's History Month, noting the month as an opportunity to support the contributions made by women in the U.S. and in Union County. She noted the upcoming annual Women of Excellence Awards, awarded to women in Union County that lead, serve, and inspire, adding that

this award have been given for over 35 years. She advised that this year, eight women from Union County had been selected to receive this prestigious award for their outstanding contributions to their communities and the County as a whole. She further advised that the event would be held virtually on March 25<sup>th</sup>. To close, she spoke relativeto the conflict in Ukraine and reiterated the Board's condemnation of Russia's attacks and their steadfast commitment to the people of Ukraine and the preservation of democracy in their country.

# **ADJOURNMENT**

Chair Williams asked for a motion to adjourn the meeting. On a motion made by Commissioner Mirabella and seconded by Commissioner Kowalski, roll call showed nine members of the Board voted in the affirmative.

The meeting was adjourned at 7:09 P.M.
