CALL TO ORDER

Vice Chair Hudak presided over the meeting and called the meeting to order at 6:14 P.M.

ROLL CALL

Roll call showed, Vice Chair Christopher Hudak, Commissioner James E. Baker Jr., Commissioner Lourdes M. Leon, Commissioner Alexander Mirabella, and Commissioner Kimberly Palmieri-Mouded were present, with Chair Rebecca Williams, Commissioner Angela R. Garretson, Commissioner Sergio Granados and Commissioner Bette Jane Kowalski absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

Vice Chair Hudak called for a motion to approve the June Minutes. On a motion made by Commissioner Mirabella and seconded by Commissioner Palmieri-Mouded roll call showed five votes in the affirmative for the June 9th Agenda Setting and Regular Meeting Minutes, with Chair Williams, Commissioner Garretson, Commissioner Granados and Commissioner Kowalski absent; and four votes in the affirmative for the June 23rd Agenda Setting and

Regular Meeting Minutes, with Vice Chair Hudak abstaining and Chair Williams, Commissioner Garretson, Commissioner Granados, and Commissioner Kowalski absent.

PUBLIC COMMENT PORTION

The meeting was opened for the purpose of commenting on resolutions being offered for adoption and on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Bruce Paterson, of Garwood, asked for additional information relative to Reso No. 2022-365. He also made comments relative to the vendor MV Strategies, the Union County Improvement Authority and the UC Government Complex slated for 61-99 West Grand St. in Elizabeth.

Relative to Reso No. 2022-365, Counsel Bergen advised that this item related to an OPRA case that has been on-going for several years. He added that at the time, the County had followed the Attorney General's guidelines on the release of police investigation records, but that the law had changed during the 2 ½ years of litigation and the County had been caught in the middle. He further advised that from a legal standpoint, even though the County had followed the law at the time, County Counsel was of the opinion that a settlement would be the best course of action.

Relative to the comments about the UC Government Complex, Vice Chair Hudak added that since 1992 when the local redevelopment housing law was passed by the legislature, there was an interpretation of the law that the UCIA had the ability to do a project of this type. He noted that a few years later an Appellate Judge had interpreted the law differently and Union County had been caught in the crosshairs. He added that he had the utmost confidence in Counsel Bergen and Director Taylor relative to this matter.

Danny O'Sullivan asked for an update relative to a new permanent dog park at the Municipal Transfer Station. He also inquired about Reso Nos. 2022-596 – 2022-604, and asked if these monies could be used to maintain a 0% tax levy in 2023.

Relative to the dog park, County Manager Oatman advised that he would look into the matter and discuss with the respective Directors.

Relative to the tax levy, Vice Chair Hudak noted the County's aim to keep the levy as low as possible, resources permitting.

Director Taylor advised that these items were not CARES ACT related, adding that these items supported ongoing programs. Relative to the tax levy, she confirmed the County's commitment to providing a levy within reasonable costs that would also maintain the financial conditions in the County.

Vice Chair Hudak thanked Director Taylor for her leadership.

There were no additional questions or comments from the public.
