



**PART II - POLICIES AND GENERAL LEGISLATION**

**Chapter 115, SAFETY CODE**

**ARTICLE XI, BAN ON CARRYING CONCEALED WEAPONS**

**§ 115-56. Findings.**

**§ 115-57. Restrictions; penalties.**

(A.) No person shall be permitted to carry any firearm concealed or otherwise, in any Sensitive Area within Union County, New Jersey.

(B.) This restriction shall not apply to law enforcement officers, on or off duty, in the course of their lawful and official duties, *or to any person granted a permit pursuant to N.J.S.A. 2C:39-6 (l)*.

(C.) A person who violates or causes to be violated a provision of this article shall be subject to a penalty of imprisonment for a term not exceeding 90 days, or to a fine, or both, of \$500.00, for the first offense and \$1,000.00 for each subsequent offense.

**§ 115-58. Sensitive Area.**

**AND, BE IT FURTHER ORDAINED**, in case any section, subsection, paragraph, subdivision, clause or provision of this ordinance shall be judged invalid by a court of competent jurisdiction, such order or judgment shall not affect or invalidate the remainder of any section, paragraph, subdivision, clause or provision of this ordinance, and to this end, the provisions of each section, paragraph, subdivision, clause or provision of this ordinance are hereby declared to be severable;

**AND, BE IT FURTHER ORDAINED**, that each section of this ordinance shall take effect at the time and in the manner provided by law, unless otherwise indicated.
