CHAPTER 115 SAFETY CODE, CHAPTER 132 TOWING, AND CHAPTER 140 CONTRACTED OFF-DUTY EMPLOYMENT OF LAW ENFORCEMENT OFFICERS.

BE IT ORDAINED. by the Union County Board of County Commissioners that the "Laws of Union County" are hereby amended, to be as follows:

PART I - ADMINISTRATIVE CODE

Chapter 1, UNION COUNTY GOVERNMENT STRUCTURE

ARTICLE XVI, Departments of Human Services

§ 1-92. Division of Children and Youth Services.

- A. Under the direction and supervision of the Director of Human Services, the functions and responsibilities of the Division of Children and Youth Services shall include:
 - (1) Coordinating, integrating, modifying and developing services for children and youth and administering select service programs, including but not limited to those mandated by law and rules and regulations appertaining thereto, including the Youth Service Bureau and temporary shelter services.
 - (2) Providing information and referral services for the children and youth of Union County.
 - (3) Identifying and assessing the needs of the children and youth in order to plan for and stimulate, in cooperation with governmental and voluntary agencies and citizens groups, solutions for present or potential problems of children and youth.
 - (4) Striving to minimize children and youth involvement with the juvenile justice system.
 - (5) Facilitating the development, extension, expansion and coordination of programs for children and youth, including but not limited to those children and youth that have been, are or have a high probability for becoming involved with the juvenile justice system.
 - (6) Providing select services for children and youth, including but not limited to maintenance of crisis intervention capabilities, advocacy, and narcotics and drug abuse prevention and education.
 - (7) Providing temporary shelter services for the care (shelter), without physical restriction, of juveniles who are homeless or abandoned awaiting court disposition, in accordance with state law and rules and regulations appertaining thereto.

- (8) Actively engaging in the Children's Interagency Coordinating Counsel and serving as the liaison with the New Jersey Department of Children and Families, Children's System of Care.
- (9) Conducting community based planning, including updating needs assessment for the New Jersey Department of Children and Families.
- (10)Performing such other duties as may be required by the Director of Human Services.
- A. Division head. The Director of the Division of Children and Youth Services shall be the head of the Division and shall be responsible to the Director of Human Services for its operation.
- B. Subdivisions. Within the Division of Children and Youth Services shall be the following subdivisions:
 - (1) Family Crisis Intevention Union (FCIU)
 - (2) Client Services & Community Outreach
 - (3) Youth Services Commission
 - (4) Union County Juvenile Expediting Team (UCJET)
 - (5) Children's Mental Health Unit

ARTICLE XVII, Department of Administrative Services

§ 1-98. General purpose; departmental organization.

There shall be a Department of Administrative Services for the purpose of conducting personnel management and labor relations, purchasing, coordinating and monitoring the administration of all County insurance programs, motor vehicle fleet management, mailroom messenger services telecommunication services. The Director of Administrative Services shall be the head of the Department and shall be responsible to the County Manager for its operation. There may be a Deputy Director of the Department of Administrative Services who shall under the direction and supervision of the Director of the Department of Administrative Services assist in the orderly and efficient administration of the Department, performing whatever supervisory or administrative duties the Director deems necessary and proper.

- A. The Department of Administrative Services shall include the following:
 - (1) The Division of Personnel Management and Labor Relations.
 - (2) The Office of Affirmative Action.
 - (3) The Division of Purchasing.
 - (4) The Division of Motor Vehicles and Telecommunications.
 - (5) The Bureau of Asset Management and Labor Compliance.

§ 1-99. UNCHANGED.

§ 1-99.1 The Office of Affirmative Action.

- A. The Affirmative Action Officer shall head the Office, under the supervision of the Director of Administrative Services.
- B. The Office of Affirmative Action shall:
- (1) Develop and monitor a productive affirmative action/equal employment opportunity program to meet requirements under federal and state law and regulations.
- (2) Interpret and monitor the County's performance and compliance with equal employment opportunity laws and regulations and implementation of the County's AA/EEO Program.
- (3) Prepare and submit the County's equal employment opportunity forms to federal authorities on a biennial basis (every odd-numbered year).
- (4) Perform all other duties as required under Chapter 6 hereof, Affirmative Action.
- (5) Perform such other duties as may be required by the Director of Administrative Services.

[This Article shall be effective January 1, 2023.]

ARTICLE XXI, Department of Public Safety

§ 1-127. Division of Emergency Services.

A., B. UNCHANGED.

- C. Division organization. Within the Division there shall be the following Bureaus:
 - (1) The Bureau of Operations.
 - (2) The Bureau of Logistics.
 - (3) The Bureau of Communications.
 - (4) The Bureau of Fire Marshall.

D. - G. UNCHANGED.

- H. The Bureau of Communications shall maintain the radio communication capabilities for the County of Union.
- I. The Bureau of Fire Marshall

- (1) The County Fire Marshall shall be the head of the Bureau and shall report to the Director of Public Safety.
- (2) The Bureau of Fire Marshall, pursuant to N.J.S.A. 40A:14-2, shall:
 - (a.) Enforce the provisions of the "Uniform Fire Safety Act" (N.J.S.A. 52:27D-192 et seq.).

Agenda

- (b.) Provide for the appropriate training of fire personnel from the municipalities of the County of Union, continuing education in the field of fire science and such other assistance in fire-science-related matters that may be deemed appropriate through the Fire Service Training Academy.
- (c.) Assist units of government including law enforcement, mental health agencies and families and individuals, with intervention in juvenile fire setting incidents.
- (d.) Provide for the prevention of fire hazards and initiate programs for public awareness.
- (e.) Perform such other duties as may be required by the Director of Public Safety.
- J. Coordinator of Emergency Management. There shall be a Coordinator of Emergency Management appointed by the Board of County Commissioners, subject to the approval of the State Director of Emergency Management and subject to his orders, as required by law.
- K. Deputy Coordinator of Emergency Management. There shall be a Deputy Coordinator of Emergency Management appointed by the Board of County Commissioners, subject to the approval of the State Director of Emergency Management and subject to his orders, as required by law.
- L. State Director to exercise supervision and control. The State Director of Emergency Management shall exercise supervision and control of the Coordinator of Emergency Management and Deputy, who may be removed by the State Director for cause. The Coordinator of Emergency Management and Deputy shall perform their duties in accordance with the provisions of N.J.S.A. App. A: Ch. 9, and rules and regulations promulgated by the Governor.

ARTICLE VIII- Encroachment of County Property

§ 115-51. Enforcement.

The Director of Park and Recreation, or a designee, is hereby charged with the responsibility for the enforcement of this ordinance and may serve notice to any person in violation thereof, however, such notice shall not be a prerequisite for an issuance of a summons. The Union County Police or other enforcement agency, may be notified of any violations and shall investigate said violations. The Union County Police Department is independently authorized to issue any appropriate summonses for violations of this ordinance. The County Counsel and/or municipal prosecutors are hereby authorized to prosecute any legal proceedings as may be required.

ARTICLE XI, BAN ON CARRYING CONCEALED WEAPONS

[NEW SECTION]

§ 115-56. Findings.

In New York Rifle & Pistol Assn. Inc. v. Bruen, the United States Supreme Court invalidated New York's "proper cause" requirement for obtaining a permit to carry a handgun in public, thereby impacting New Jersey's "justifiable need" requirement, an important part of New Jersey's common-sense firearms safety laws. These laws have resulted in New Jersey having one of the lowest firearm mortality rates in the country. Nonetheless, gun violence remains a public health crisis in Union County, throughout New Jersey and across the nation.

The vast majority of New Jersey residents do not support the relaxing of restrictions on who may carry a gun in public. Protecting the residents and visitors of Union County from gun violence continues to be of paramount importance to the Union County Board of County Commissioners and is a compelling government interest.

This law is written with the intent to enact restrictions to the full extent allowed by the U.S. Constitution and case law thereunder.

§ 115-57. Restrictions; penalties.

- (A.) No person shall be permitted to carry any firearm concealed or otherwise, in any Sensitive Area within Union County, New Jersey.
- (B.) This restriction shall not apply to law enforcement officers, on or off duty, in the course of their lawful and official duties.
- (C.) A person who violates or causes to be violated a provision of this article shall be subject to a penalty of imprisonment for a term not exceeding 90 days, or to a fine, or both, of \$500.00, for the first offense and \$1,000.00 for each subsequent offense.

§ 115-58. Sensitive Area.

"Sensitive Area" shall be defined as:

- (A.) All buildings or portion thereof, owned, controlled, leased or otherwise under the jurisdiction of the County, whether open to the public or not;
- (B.) Any Courthouse or building containing judicial functions of the state or County;
- (C.) Any building or portion thereof, which is the location of any program operated or funded by the County; including but not limited to Union County Vocational-Technical Schools and Union College;
- (D.) All recreational facilities and parks owned or operated by the County (excluding anyone driving a motor vehicle through a park on a public thoroughfare);
- (E.) Any vehicle owned or operated by or on behalf of the County while used for public transportation;
- (F.) Any polling place or location while open and operating for purposes of voting; and
- (G.) Any location, building or function of a similar nature to the above, owned or occupied by the County.

Chapter 132, TOWING

Sets forth standards, regulations and rates for police-requested and nonpreference towing and storage services. A complete copy of this ordinance, all rules and

regulations, and any future amendments, are on file in the Office of the Clerk of the Board and the headquarters of the County Police.

Chapter 140, CONTRACTED OFF-DUTY EMPLOYMENT OF LAW ENFORCEMENT OFFICERS

§ 140-1. OFF-DUTY WORK BY LAW ENFORCEMENT OFFICERS

The County establishes the following policy and procedures relating to the performance of services by off-duty law enforcement officers.

- B. Costs and Fees
- 1. 3. UNCHANGED.
- 4. For services performed on County property or otherwise requested for directly with the County, officers shall be paid, at a rate of \$65.00 per hour. Payment to officers for such work shall be made through the County's payroll process in accordance with its regular practices. No officer shall be paid directly by any applicant. Any job that requires more than 4 officers shall include an assigned Officer in Charge, who shall be paid at a rate of \$75.00 per hour.
- 5. UNCHANGED.
- 6. The County shall charge an additional 10% administrative fee payable to the County for such work performed by its employees; and the TPA may thereafter charge an additional fee on a percentage basis, as authorized by the County.
- 7. UNCHANGED.

AND, BE IT FURTHER ORDAINED, in case any section, subsection, paragraph, subdivision, clause or provision of this ordinance shall be judged invalid by a court of competent jurisdiction, such order or judgment shall not affect or invalidate the remainder of any section, paragraph, subdivision, clause or provision of this ordinance, and to this end, the provisions of each section,

paragraph, subdivision, clause or provision of this ordinance are hereby declared to be severable;

AND, BE IT FURTHER ORDAINED, that each section of this ordinance shall take effect at the time and in the manner provided by law, unless otherwise indicated.

FIRST READING STATEMENT

Vice Chair Christopher Hudak, Policy Subcommittee Chairman, moved Ordinance Number 840-2022 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The Public Hearing and Final Reading will be held on November 10, 2022.

On a motion made by Vice Chair Hudak and seconded by Commissioner Mirabella, roll call showed nine members of the Board voted in the affirmative.

PUBLIC COMMENT PORTION

The meeting was opened for the purpose of commenting on resolutions being offered for adoption and on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Summit Councilman Danny O'Sullivan noted his support of several Resolutions presented by the Board that aimed to help families dealing with a variety of issues including addiction and shelter insecurity, adding that these Resolutions underscored the fact that families throughout the County were struggling. He applauded the County's investment in these initiatives, noting that more affordable housing resources were desperately needed throughout the state to combat homelessness. On another note, he recognized the County's Parks and Recreation Department, in particular Director Ronald Zuber and Division of Park Maintenance Director Michael Brennan, and thanked them for their efforts relative to Briant Park in Summit. He closed by thanking the County of Union and the Board for the great work they continue to do.

Michael Breunig, President of Union Council 8 I.F.P.T.E., noted his concerns relative to the process and pace of the collective bargaining agreement negotiations currently underway, adding that members have been without a contract since the end of 2020. He noted the financial challenges faced and sacrifices made by members in Council 8, adding that the union had always made reasonable financial proposals related to contract negotiations.

Chair Williams confirmed that the Board could not comment on on-going collective bargaining agreement negotiations.

Bruce Paterson, of Garwood, congratulated Commissioner Garretson on being honored by the NAACP Hillside Branch at their upcoming Inaugural Freedom Fund Awards Gala. Mr. Paterson inquired about Reso No. 2022-916. He also refuted

comments and accusations made against him during the Commissioners' October 6, 2022. To close, he noted his concerns relative to Vice Chair Hudak serving as UC Surrogate.

There were no additional questions or comments from the public.

She noted his 40 years of public serve, adding that he had left an indelible mark on Union County. On another note, she thanked all the event organizers for their efforts during Breast Cancer Awareness Month, noting her participation at a Breast Cancer Awareness Walk in Newark on Sunday. She also congratulated Union College on their 89th Founders Day as well as their 30th Annual Scholarship Gala that took place the previous week, adding that Union College became the first county college in NJ in 1933. He advised that residents of Fanwood, Rahway, and Scotch Plains now fell under the 7th Congressional District. He further advised that residents of Cranford, Garwood, Kenilworth, and Union would fall under the 10 Congressional District. He noted Linden was also affected by redistricting, but would be split, noting the wards and districts that now fell under the 7th and 10th Congressional Districts respectively. He encouraged residents with additional questions or concerns to contact the County Clerk's Office.

Commissioner Mirabella echoed the sentiments of his Commissioner colleagues, noting that he too was pleased with the various events and activities that took place in Union County in honor of Hispanic Heritage Month. He thanked Commissioner Granados and Commissioner Leon for their efforts, noting that he was pleased to see former Freeholder Angel Estrada and his family at the Family Fun Day event at Rahway River Park and honor him with a Community Leadership Award. On another note, he invited residents with children with autism and other sensory sensitivities to attend the County's sensory-friendly theater presentations at Union County Performing Arts Center in Rahway. He added that performances included Jeff Boyer's Big Bubble Bonanza on November 13th and the NJ Ballet's The Nutcracker on November 30th. He noted that the County's

sensory-friendly theater was created to provide entertainment opportunities to individuals with sensory sensitives and other related conditions. On another note, he spoke relative to the upcoming election, noting that he looked forward to voting for Vice Chair Hudak for the position of UC Surrogate as well as voting for his colleagues Chair Williams, Commissioner Granados and Commissioner Kowalski for another term as UC Commissioners. Commissioner Mirabella noted Reso No. 2022-925, adding that this item served to illustrate the Board's appreciation of and commitment to supporting Veterans throughout the County and the nation. He also spoke of his recent attendance to Union College's Founders Day event, joined by Commissioner Leon, and thanked her for her comments in Spanish at the event. To close, Commissioner Mirabella noted his participation in a zoom call alongside Commissioner Kowalski relative to the Rails to Trails initiative. He recognized County Manager Oatman and Deputy County Manager Wagner for their efforts to this end, noting that he believed this initiative would be a great asset and resource for Union County.

Prior to his comments, Vice Chair Hudak requested a motion to reconsider the Board's vote on Reso No. 2022-921.

Counsel Bergen advised that it would now be appropriate for the Board to vote on a motion to reconsider the aforementioned resolution. He added that should the motion to reconsider pass, a member of the Board would have to move Reso No. 2022-921 again so that a second vote could cast.

On a motion made by Vice Chair Hudak and seconded by Commissioner Leon, roll call showed eight members of the Board voted in the affirmative, with Commissioner Mirabella abstaining, to reconsider the vote on Reso No. 2022-921.

Counsel Bergen advised that a Member of the Board could now move for a new vote on Reso No. 2022-921.

Vice Chair Hudak made the motion to re-vote on Reso No. 2022-921. On a motion made by Vice Chair Hudak and seconded by Commissioner Palmieri-Mouded, roll call showed eight members of the Board voted in the affirmative on Reso No. 2022-921, with Commissioner Mirabella abstaining.

Vice Chair Hudak recognized and thanked all the sites that participated in the County's Four Centuries in a Weekend, noting that he and his family enjoyed the tour. He also recognized former Freeholder Estrada and congratulated him on being honored during Hispanic Heritage Month's Family Fun Day celebration at Rahway River Park. On another note, he advised that the Division on Aging would be offering a new program called Social 60+ for County residents 60 and older where qualifying residents could receive a warm meal and an opportunity to socialize with other older adults. He further advised that qualifying residents could now exchange a voucher, provided through the Division on Aging, at The Garden Restaurant in Union for a meal option designated by the restaurant. He advised that in order to qualify for the meal voucher for The Garden, residents had to be 60 years of age or older and reside within Union County as well as participate in a mandatory Nutrition and Education Program offered through the Division of Aging at least once quarterly. To close, Vice Chair Hudak reminded everyone about Election Day on November 8th, and wished his colleagues well on their respective runs.

Chair Williams spoke relative to the recent 8 million check presentation made to the County of Union by NJ Senate President Nicholas Scutari on behalf of the State of New Jersey to be used towards a new indoor skating rink at Warinanco Sports Center. She thanked the State and NJ Senate President Scutari for providing Union County with the monies to fund this project. She advised that the new facility would lend itself to yearround use, in comparison to the current facility which could only be used seasonally. Chair Williams noted several features to be incorporated in the upcoming state-of-the-art facility, noting that these features allowed for increased capacity and would likely attract more visitors to the sports center year-round. She advised that construction was slated to begin by the end of 2023, adding that the County expected the facility to be completed by 2025. She recognized the County's partnership with The Cranford Hockey Club and the State of NJ in getting the project underway, adding that in addition to being a good resource, the new facility would result in cost savings for families involved in hockey. On another note, she reminded residents of the upcoming Women Mean Business Summit on Tuesday, October 25th at Galloping Hill Golf Course in Kenilworth. She noted that the event would feature a series of workshops geared towards career women, adding that NJ's Commissioner of Health, Judith M. Persichilli, would be the keynote speaker for the event. To close, she echoed the sentiments of her colleagues, noting that she too enjoyed the recent Four Centuries in a Weekend tour as well as the Hispanic Heritage Month celebrations.

ADJOURNMENT

Chair Williams asked for a motion to adjourn the meeting. On a motion made by Commissioner Mirabella and seconded by Vice Chair Hudak, roll call showed nine members of the Board voted in the affirmative.

The meeting was adjourned at 7:27 P.M.
