CALL TO ORDER

Chair Williams presided over the meeting and called the meeting to order at 6:09 P.M.

ROLL CALL

Leon, Commissioner Alexander Mirabella and Commissioner Kimberly Palmieri-Mouded were present, with Commissioner Bette Jane Kowalski, absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

ORDINANCE FOR ADOPTION

839-2022 BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY, NEW ADDITIONAL FURNISHINGS, NEW COMMUNICATION AND SIGNAL SYSTEMS EQUIPMENT, NEW INFORMATION TECHNOLOGY AND TELECOMMUNICATIONS EQUIPMENT AND NEW AUTOMOTIVE VEHICLES, INCLUDING ORIGINAL APPARATUS AND EQUIPMENT, IN, BY AND FOR THE COUNTY OF UNION, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$62,381,711 TO PAY THE COST THEREOF, TO APPROPRIATE STATE GRANTS, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

Chair Williams advised that Ordinance No. 839-2022 would be presented for adoption later during the Regular Meeting.

PRESENTATIONS BY THE BOARD

A video presentation was made by the Board relative to the 2022 Open Space, Recreation & Historical Preservation Trust Fund Grant Programs: 2022 Kids Recreation Trust Grant and 2022 Greening Union County Grants.

2022 Kids Recreation Trust Grant

Berkeley Heights received \$40,000 to replace tennis and pickleball court lights and poles with LED lights and create a walking/biking path to connect Robbins and Lawrence Avenues.

Clark received \$45,000 to repurpose a basketball court into three pickleball fields and upgrade a jungle gym area.

Cranford received \$60,000 to renovate the Hillside Avenue Tennis Courts, beautify Lincoln Park, and resurface various playground areas with rubber surfaces.

Elizabeth received \$150,000 for upgrades at Lynch Memorial Playground with the incorporation of new ADA equipment and a new spray park.

Fanwood received \$50,000 for new playground equipment for LaGrande Park.

Garwood received \$35,000 for improvements to the Recreation Sport Complex, including a new video security system, a shuffleboard court, and a picnic pavilion.

Kenilworth received \$50,000 for various improvements to the Borough's parks and facilities.

Linden received \$65,0000 for upgrades and to make Milkosky Park ADA compliant.

Mountainside received \$35,000 to develop a new park on Mountain Ave and New Providence Road and for updates of the baseball and softball fields at Deerfield School

New Providence received \$35,000 to create a more accessible playground structure as well as a bathroom building and picnic patio at Lions Park.

Plainfield received \$65,000 to rehabilitate and resurface five tennis courts at Berzinec Park.

Roselle received \$50,000 to repair and resurface Pine Street Park and Chandler Street Park.

Roselle Park received \$45,000 to renovate Acker Park and include new playground structures with ADA accessible features.

Scotch Plains received \$60,000 for equipment and new signage for various park locations.

Summit received \$45,000 to rehabilitate Mabie Playground and make it ADA compliant and sensory friendly.

Union received \$55,000 for playground equipment and improvements for Jerome Petti Park.

Westfield received \$36,477.23 for the replacement of fencing and new equipment for the basketball courts at Windsor Park.

- 3. Authorizing the County Manager to enter into a Master Service Agreement and Addendum No. 1 thereto, with the State of New Jersey, Administrative Office of the Courts for Mailroom Services for a five-year period retroactive to July 1, 2021 and ending on June 30, 2026, (revenue generating). DEPARTMENT OF ECONOMIC DEVELOPMENT

Amy Crisp Wagner, Deputy County Manager/Director

Commissioner Garretson asked Deputy County Manager Wagner about forthcoming changes to fringe benefits.

County Manager Oatman advised that since the County of Union was self-insured, employees would not be affected by the slated increases. He added that Union County had its own rates and had been budgeting accordingly and would not face the same increase as state employees.

- 1. Authorizing the County Manager to accept funding from the Department of Community Affairs, Division of Local Government Services for the Local Efficiency Achievement Program (LEAP) County Coordinator Fellowship Grant in an amount not to exceed \$50,000.00 to support the County hiring a full-time Shared Services County Coordinator Fellow for a period of one-year. (Chair Rebecca Lynne Williams)
- 2. Authorizing the County Manager to exercise the second and final option to extend a contract with Development Directions, LLC, Rahway, NJ for consulting services for the administration of the Union County Home Improvement and Senior Home Grants for the period of September 1, 2022 through August 31, 2023 in an amount not to exceed \$340,000.00. (Chair Rebecca Lynne Williams)

Commissioner Baker asked Deputy County Manager Wagner to elaborate on this item.

Deputy County Manager Wagner advised that this item would award another contractextension to the cited vendor to manage the County's Home Improvement and Senior Home Grant programs. She advised that income-eligible seniors could receive up to \$5,000 in Senior Home Grant funding as well potentially qualify for the Home Improvement grant for a maximum of \$24,999 in aid, adding that no interest or payments would be due on the grant funding until the homeowner sold the property.

Commissioner Baker asked if this program was exclusively for seniors.

Deputy County Manager Wagner advised that the Home Improvement program was open to all income-eligible residents with the exception of residents living in Linden, Plainfield, and Rahway, adding that those municipalities offered their own program. She further advised that Elizabeth and Union also received their own allocations of CDBG monies directly, which funded this program on the county-level.

- 3. Concurring with Resolution No. 2022-34 of the Union County Workforce Development Board to insert additional funding as pass-through funding in an amount of \$12,971.00, to support FutureWork Systems, LLC, for WIOA Data Reporting and Analysis services to the Union County American Job Center. (Chair Rebecca Lynne Williams)
- 4. Concurring with Resolution No. 2022-32 of the Union County Workforce Development Board to award a contract to the Plainfield Public Library in an amount not to exceed \$60,000.00 for the period of July 1, 2022 through June 30, 2023. (Chair Rebecca Lynne Williams)

Commissioner Granados asked Deputy County Manager Wagner to elaborate on this item

Deputy County Manager Wagner advised that this item related to a literacy program run through Plainfield Public Library. She noted the benefits of said resource, adding that the cited monies would be used to fund training for 60 individuals.

5. Amending Resolution Number 2021-348, entering into an agreement with and accept funding from the State of New Jersey, Department of Community Affairs, Division of Local Government Services, under the Local Efficiency Achievement Program (LEAP) Challenge Grant to support the Union County Emergency Services

Regional Dispatch Center, to reflect a change in scope reducing the grant participants from four (4) to two (2): the Borough of Fanwood and the Borough of Roselle and reimburse the County for high tech communications allocated to the two (2) grant participants for \$126,405.35. (Chair Rebecca Lynne Williams)

Commissioner Baker asked Deputy County Manager Wagner to elaborate on the cited change in scope.

Deputy County Manager Wagner advised that when the County originally applied for the grant there were four communities included. She added that Garwood and Kenilworth decided not to participate and as a result, the grant award was decreased by approximately \$24,000

6. Authorizing the County Manager to apply for and accept funding from the NJ Department of Transportation, Transportation Alternatives Set-Aside Program for a project to convert sections of the Rahway Valley Railroad Right-of-Way that traverses the Borough of Kenilworth and the Borough of Roselle Park into a Railsto-Trails off-road pedestrian and bicycle greenway. (Chair Rebecca Lynne Williams)

Chair Williams asked Deputy County Manager to elaborate on this item.

Deputy County Manager Wagner advised that this item related to a new, competitive grant that the County was interested in pursuing. She noted several Rails-to-Trails programs the County was currently working on, noting certain issues that had arisen from the potential Conrail Line project. She further advised that the County would be pursuing the Rails-to-Trails project through the Rahway Valley Line, adding that communications were already underway with the Mayors of Kenilworth and Roselle Park relative to the project. She noted that the project through the Rahway Valley Railroad would travel through Kenilworth and Roselle Park, connecting to certain portions of the Conrail Line, adding that the project had the potential to provide a path of interconnectivity throughout various communities in Union County.

DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT Joseph Graziano, Director

Commissioner Baker asked Director Graziano to elaborate on this item.

Director Graziano advised that this item related to a recycling contract with the cited vendor that was erroneously renewed last year for a one-year term instead of a two-year term. As a result, he advised that a changed order was necessary to add the additional year. He noted that the cited \$140,000 reflected the charges for the remaining year, adding that the total two-year contract total was approximately \$323,000 and was covered by REA grant funding.

Commissioner Granados asked Deputy County Manager Wagner to elaborate on pool operations over the course of the summer.

Deputy County Manager Wagner advised that this item would allow the County to include the cited vendor in the existing Co-Op, adding that they were used to open and close both pools as well as the County spray park this past summer. She further advised that these resources had been quite profitable this summer, noting that the spray park had seen approximately 48,000 visitors, with another 46,000 visiting the pool. She added that in addition to the completed upgrades, Director Zuber and his staff were inspecting the facilities to address any potential issues before the next summer season.

Commissioner Granados noted his approval of the spray parks, including the activities hosted on Wednesday nights for children with special needs through the Department for Persons with Disabilities and Special Needs.

Vice Chair Hudak asked Director Moran to elaborate on this item.

Director Moran advised that these monies would fund the salary for a risk-mitigation planner that would be working out of the County's Prosecutor's Office as well as cover costs for hazmat training, decon training, and the purchase of regional urban search and rescue equipment. He noted that the training would also incorporate urban search and rescue using boats in preparation for future emergency situations similar to those evoked by Hurricane Ida.

Vice Chair Hudak noted the importance of this resource in assisting Union County residents and supporting the region during emergency situations.

Director Moran agreed, adding that this resource allowed for the standardization of response, training, and equipment amongst the different UASI regions.
