ORDINANCE FOR ADOPTION

839-2022 BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY, NEW ADDITIONAL FURNISHINGS, NEW COMMUNICATION AND SIGNAL SYSTEMS EQUIPMENT, NEW INFORMATION TECHNOLOGY AND TELECOMMUNICATIONS EQUIPMENT AND NEW AUTOMOTIVE VEHICLES, INCLUDING ORIGINAL APPARATUS AND EQUIPMENT, IN, BY AND FOR THE COUNTY OF UNION, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$62,381,711 TO PAY THE COST THEREOF, TO APPROPRIATE STATE

GRANTS, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

BE IT ORDAINED by the Board of County Commissioners of the County of Union, State of New Jersey, as follows:

Section 1. The County of Union "County"), State of New Jersey is hereby authorized to make various public improvements and to acquire new additional or replacement equipment and machinery, new additional furnishings, new communication and signal systems equipment, new information technology and telecommunications equipment automotive and new vehicles, including original apparatus and equipment, in, by and for said County, as more particularly described in Section 4 hereof. The cost of the and acquisitions includes all work, improvements materials and appurtenances necessary and suitable therefor.

Section 2. There is hereby appropriated to the payment of the cost of making the improvements and acquisitions described in Sections 1 and 4 hereof (hereinafter referred to as "purposes"), the respective amounts of money hereinafter stated as the appropriation for said respective purposes. Said

appropriation shall be met from the proceeds of the sale of the bonds authorized, and the State grants and the down payment appropriated, by this ordinance. Said improvements and acquisitions shall be made as general improvements and no part of the cost thereof shall be assessed against property specially benefitted.

Section 3. It is hereby determined and stated that the making of such improvements and acquisitions is not a current expense of said County.

Section 4. The several purposes hereby authorized for the financing of which said obligations are to be issued are set forth in the following "Schedule of Improvements, Purposes and Amounts" which schedule also shows (1)the amount appropriation and the estimated cost of each purpose, and (2) the amount of each sum which is to be provided by the State grants hereinafter appropriated, and (3) the amount of each sum which is to be provided by the down payment hereinafter appropriated to finance such purposes, and (4) the estimated maximum amount of bonds and notes to be issued for each such purpose, and (5) the period of usefulness of each such purpose, according to its reasonable life, computed from the date of said bonds:

Section 6. The aggregate sum of \$9,081,850 received or to be received as grants from the New Jersey Department of Transportation ("NJDOT") is hereby appropriated to the payment of the cost of the infrastructure improvements authorized in Section 4.C above.

Section 7. The sum of \$2,238,853 received or to be received as a grant from the NJDOT is hereby appropriated to the payment of the cost of the equipment acquisition authorized in Section 4.H above.

Section 8. It is hereby determined and stated that moneys exceeding \$2,200,474, appropriated for down payments on capital improvements or for the capital improvement fund in budgets heretofore adopted for said County, are now available to finance said purposes. The sum of \$2,200,474 is hereby appropriated from such moneys to the payment of the cost of said purposes.

Section 9. To finance said purposes, bonds of said County of an aggregate principal amount not exceeding \$48,860,534 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds

shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted.

Section 10. To finance said purposes, bond anticipation notes of said County of an aggregate principal amount not exceeding \$48,860,534 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issuance of said bonds. issued pursuant to this that bonds are event ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.

Section 11. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance and shall be payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter

determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within limitations prescribed by the Local Bond Law. Each of said bond anticipation notes shall be signed by the Chairman of the Board of County Commissioners, by the County Manager and by the County Treasurer and shall be under the seal of said County and attested by the Clerk or Deputy Clerk of the Board of County Commissioners. Said officers are hereby authorized to execute said notes in such form as they may adopt in The power to determine any conformity with law. matters with respect to said notes not determined by this ordinance and also the power to sell said notes, is hereby delegated to the County Treasurer who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.

Section 12. It is hereby determined and declared that the average period of usefulness of said purposes, according to their reasonable lives, taking into consideration the respective amounts of bonds or notes authorized for said purposes, is a period of 16.36 years computed from the date of said bonds.

Section 13. It is hereby determined and stated that the Supplemental Debt Statement required

by the Local Bond Law has been duly made and filed in the office of the Clerk of the Board of County Commissioners of said County, and that such statement so filed shows that the gross debt of said County, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$48,860,534 and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by said Local Bond Law.

Section 14. Any funds received private parties, the State of New Jersey or any of its agencies or any funds received from the United States of America or any of its agencies in aid of such purposes (other than the State grants hereinbefore appropriated which shall be applied to the cost of such purposes, but shall not be applied to the payment anticipation notes of outstanding bond reduction of the amount of bonds authorized), shall be applied to the payment of the cost of such purposes, or, if bond anticipation notes have been issued, to the payment of the bond anticipation notes, and the amount of bonds authorized for such purposes shall be reduced accordingly.

Section 15. The County intends to issue the bonds or notes to finance the cost of the

improvements and acquisitions described in Sections 1 and 4 of this bond ordinance. If the County incurs such costs prior to the issuance of the bonds or notes, the County hereby states its reasonable expectation to reimburse itself for such expenditures with the proceeds of such bonds or notes in the maximum principal amount of bonds or notes authorized by this bond ordinance.

Section 16. The full faith and credit of the County are hereby pledged to the punctual payment principal of and the interest on obligations authorized by this ordinance. Said obligations shall be direct, unlimited and general obligations of the County, and the County shall levy ad valorem taxes upon all the taxable real property within the County for the payment of the principal of and interest such bonds and notes. limitation as to rate or amount.

Section 17. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on

file with the Clerk of the Board of County

Commissioners and is available for public inspection.

Section 18. This ordinance shall take effect twenty days after the first publication thereof after fi

PUBLIC COMMENT PORTION

The meeting was opened for the purpose of commenting on Ordinance Number 839-2022 only.

Bruce Paterson, of Garwood, asked for additional information relative to the monies being spent. He also asked how much money was being applied as a down-payment as well as how much monies were available through grant funding to offset costs.

Director Taylor advised that Ordinance 839-2022 would fund maintenance of County's infrastructure including: underground storage tank and above-ground storage tank upgrades for the entire County fleet; emergency generators at the Ruotolo Center as well as a mobile forensic laboratory; and would continue to fund roadway and bridge projects annually, as needed. She further advised that the \$62.3 million would be offset by \$11.3 million in grant funding. She added that the County had appropriated the amount required by law and had put down a 5% down-payment, totaling approximately \$2.2 million. She noted that the total aggregate debt to be issued under the Ordinance would be \$48.8 million. She also noted that the County's net debt as of year's end was the lowest it had been in five years and that the County would continue to pay this debt down in accordance with principle and interest schedules.

There were no additional questions or comments from the public relative to Ordinance No. 839-2022.

FINAL READING STATEMENT

Commissioner Sergio Granados, Fiscal Subcommittee Chairman, moved Ordinance Number 839-2022 for Final Reading and authorized the Clerk of the Board to advertise same in accordance with the law.

On a motion made by Commissioner Granados and seconded by Commissioner Mirabella, roll call showed eight members of the Board voted in the affirmative with Commissioner Kowalski absent.

PUBLIC COMMENT PORTION

The meeting was opened for the purpose of commenting on resolutions being offered for adoption and on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Bruce Paterson, of Garwood, made comments and asked questions relative to several resolutions. Relative to Reso Nos. 2022-811-2022-813, he asked if these items would modify the previously-approved budget. Relative to Reso No. 2022-824, he made comments relative to the increase and asked for additional information on the item. Relative to Reso No. 2022-829, Mr. Paterson made comments relative to the cited vendor and their contracts with the County and Scotch Plains. Relative to Reso No. 2022-833, he asked for clarification on who owned the property. Relative to Reso No. 2022-839, he suggested the County eliminate the 100% match from the various municipalities receiving grant monies from the Kids Recreation Trust. Relative to Reso Nos. 2022-846 & 200-847, Mr. Paterson asked for details regarding the terms of the collective bargaining agreements. Relative to Reso No. 2022-850, he asked for a detailed explanation of the services being provided. Relative to Reso No. 2022-855, Mr. Paterson made comments about former Acting Prosecutor Lyndsay Ruotolo and Finance Director Taylor. He closed by congratulating Commissioner Granados on being recognized by Kean University with the 2022 Kean University Distinguished Alumna Award.

Relative to Reso No. 2022-818, Director Taylor advised that grant revenues did increase the overall budget, adding that both the revenue and appropriations had to be increased as a result. She noted that these increases did not off-set any of the tax levy.

Relative to Reso No. 2022-824, Director Anderson advised that Community Access provided wraparound resources to over 300 youths between the ages of 14-24, adding that an increase in funding would allow for more people to benefit from this service. She thanked the Board for their continued support of this resource.

Relative to Reso No. 2022-829, County Manager Oatman confirmed that Zimmerman Parking Lot was located in Union Township, not Scotch Plains as noted by Mr. Paterson.

Relative to Reso No. 2022-833, County Manager Oatman confirmed that the County did not own 40 Parker Rd.

Relative to Reso Nos. 2022-846 & 847, County Manager Oatman advised that the agreements included 2% raises. He added that the 469-Primary Supervisors contract was for a five-year term and the Supervisors Association was for two years.

Relative to Reso No. 2022-850, Deputy County Manager Wagner advised that Development Directions was always listed as a consultant as they handled the logistics of this program on behalf of the County. She noted that the vendor was responsible for processing applications, establishing applicant-eligibility, securing contractors, inspect work being done, and maintain all related paperwork for said. She added that the total would fund administrative and repair costs, noting that grant funding was included in the \$340,000.

Relative to Reso No. 2022-855, County Manager Oatman advised that the Board had no control over Acting Prosecutor/Prosecutor appointments as they were done by the Governor.

Jean Linbergh, of Westfield, made comments relative to artificial turf fields She asked the Board to consider a moratorium on new turf fields in favor of natural grass.

Jonathan Yurnise, of Westfield, expressed his concerns regarding the proposed development at the former site of William's Nursery, specifically as it relates to flooding. He also thanked Commissioner Kowalski and Palmieri-Mouded for listening to his concerns on the matter previously.

County Manager Oatman advised that Mr. Yurnise's concerns had been brought to his attention by Commissioners Kowalski and Palmieri-Mouded earlier in the year. He further advised that the County and Board's powers were limited given that Westfield had approved this plan through the town zoning board. He added that Westfield would appear before the UC Planning Board next Wednesday.

There were no additional questions or comments from the public.

COMMISSIONER REPORTS AND COMMENTS

Vice Chair Hudak reminded residents about several upcoming seasonal recreation activities including the County's Haunted Hayride and Campfire series at the Deserted Village, noting that tickets were still available for this activity. He also noted the upcoming Four Centuries in a Weekend Tour on Saturday, October 15th and Sunday, October 16th, adding that the tour would be packed with special exhibits and activities at

more than 30 house museums and historic sites throughout Union County. He also reminded residents about the County's annual Great Pumpkin Sail on November 1st at Echo Lake Park and two events for special needs families, including Rahway's Halloween Bash on October 21st and a Country Barn Dance at the Deserted Village on November 5th. On another note, he refuted Mr. Paterson's claims and comments relative to County personnel, noting that the County's financial health continued to improve thanks in part to Director Taylor's leadership. He added that the County continued to maintain its AAA bond rating and managed to reduce its capital budget by approximately \$15 million from previously funded projects. He also advised that former Acting Prosecutor Ruotolo had left the County to assume the role of First Assistant Attorney General for the State of NJ.

Commissioner Granados congratulated Vice Chair Hudak on being nominated by Governor Murphy for the position of UC Surrogate.

Commissioner Garretson reminded residents that the voter registration deadline was on October 18th, adding that the November General Election would be held on Tuesday, November 8th. She encouraged voters to contact the Board of Elections and or County Clerk's Office for additional information.

Commissioner Leon spoke relative to Hispanic Heritage Month, noting that the celebration would conclude with Family Fun Day on October 15th at Rahway River Park. She advised that the event was free and the celebration would include food trucks, dancing, music, and other activities. She added that the Board would also be presenting its Hispanic Heritage Awards during the event in honor of the contributions and achievements of Hispanics throughout Union County. She thanked the Office of Community Engagement and Diversity for their efforts relative to the event.

Commissioner Granados also spoke relative to Hispanic Heritage Month, noting an upcoming informative panel discussion in collaboration with Telemundo 47 in reference to Hispanic media connections that would be taking place on October 12th at Kean University. He added that the event would include a discussion on Spanish-language media and provide information to Kean students on how to apply for internships.

Commissioner Palmieri-Mouded thanked Vicki Durbin and Angelica Cedeño from Open Space for their efforts relative to the 2022 Kids Recreation Trust Grant awards. She noted that as a mother of five she often frequented the County parks and playgrounds and was looking forward to the prospective upgrades facilitated by this funding. On another note, she reminded residents that October was Breast Cancer Awareness month and she encouraged women to get regular check-ups and mammograms as a means to maintain their health.

Commissioner Baker reminded residents that the Board of Elections was still looking for poll workers for the General Election on Tuesday, November 8th. He advised that poll workers would receive \$300 to work from 5:15AM -8:15PM when the polls close. He advised that UC residents 18 years of age and older that were registered to vote could apple through the Board of Elections. He added that new poll workers would be required to attend a mandatory, in-person training prior to working on Election Day. He advised that the application could be completed online or through the Board of Elections.

Commissioner Mirabella invited residents to Union County's 14th Annual Columbus Day Flag Raising. He noted that the event provided an opportunity to recognize the contributions, achievements and hard-work of Italian Americans throughout Union County and across the nation. He invited everyone to come and join the celebration of Italian-American pride. He also advised that on October 7th – October 9th Clark UNICO would be hosting its Annual Feast at Clark's Municipal Building. Chair Williams noted her attendance to a Union County Means Business event earlier in the week which featured a strategic resilience panel discussion for small business owners focused on bouncing back from the economic challenges evoked by the COVID-19 pandemic. To close, she expressed her distaste for Mr. Paterson's comments about former Acting Prosecutor Ruotolo and Finance Director Taylor, noting that Director Taylor's work spoke for itself as the County's financial outlook was bright thanks in part to her efforts.
