

# UNION COUNTY BOARD OF COUNTY COMMISSIONERS

### THURSDAY, APRIL 13, 2023 AGENDA SETTING MEETING MINUTES

### CALL TO ORDER

Chairman Granados presided over the meeting and called the meeting to order at 6:05 P.M.

### ROLL CALL

Roll call showed Chairman Sergio Granados, Vice-Chairwoman Kimberly Palmieri-Mouded, Commissioner James E. Baker, Jr., Commissioner Joseph C. Bodek, Commissioner Angela R. Garretson, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, Commissioner Alexander Mirabella, and Commissioner Rebecca Williams were present.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

### PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

### STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

Chairman Granados asked for a moment of silence for the victims of the Old National Bank shooting in Louisville, Kentucky on April 10<sup>th</sup>...

#### PRESENTATIONS BY THE BOARD

A resolution presentation was made by the Board to the NJ Sharing Network & the NJ Sharing Network Foundation in recognition of April, 2023 as "National Organ Donation Month" throughout the County of Union.

Chairman Granados asked Commissioners Mirabella and Williams to join him for the presentation.

Chairman Granados advised that April 2023 was National Organ Donation Month, adding that the County's Administration Building would be lit blue and green to raise awareness for organ and tissue donation. He spoke relative to the NJ Sharing Network organization and their efforts in the recovery and placement of donated organs and tissue, noting 4,000 NJ residents were currently awaiting transplants. He advised that the Sharing Network was part of a National Recovery System in place for 115,000 individuals on the national waiting list. He noted that the Sharing Network's efforts increased the number of lives saved through innovative transplant

research, family support services, and raising public awareness relative to the life-saving benefits of donations and transplants. On behalf of the Board, Chairman Granados noted that he was proud to present a Resolution to the NJ Sharing Network & the NJ Sharing Network Foundation for their life-saving efforts.

Commissioner Mirabella advised that the NJ Sharing Network deserved a lot of credit for their amazing work. He noted that last year he had an opportunity to tour their facility, alongside Commissioner Williams, adding that he was always impressed by the organization's commitment to saving lives and helping others. Commissioner Mirabella added that he was looking forward to participating in the NJ Sharing Network's upcoming 5K Celebration of Life.

Commissioner Williams thanked the NJ Sharing Network for their life-saving efforts.

Amanda Tibok, Executive Director of the NJ Sharing Network Foundation, thanked the Board for the recognition. She noted the organizations upcoming 5K Celebration of Life, noting that this was the 13<sup>th</sup> year the event would be held. She added that the 5K Celebration of Life was a day to honor and remember as well as give hope. She advised that a single organ donor could save the lives of 8 people, while a tissue donor could help 75 people. She thanked the organizations community partners for their efforts as well as the Board for the recognition.

### OFFICE OF THE UNION COUNTY PROSECUTOR

William Daniel, Prosecutor

1st Assistant Prosecutor James O. Tansey represented the Office.

- 1. Authorizing the County Manager to apply for and accept funding for the State of New Jersey, Office of the Attorney General's FFY21 Victims of Crime Act (VOCA) Grant Program for project titled County Office of Victim Witness Advocacy in the amount of \$446,688.00 in federal funds with a required match of \$111,672.00 for a project total cost in the amount of \$558,360.00 for the period of July 1, 2023 through June 30, 2024. (Chairman Sergio Granados)
- 2. Authorizing the County Manager to apply for and accept funding for the State of New Jersey, Office of the Attorney General's FFY22 STOP Violence Against Woman Act (VAWA) Grant Program in the amount of \$34,495.00 in federal funds with a required match of \$11,498.00 for a total project cost in the amount of \$45,993.00 for the period of July 1, 2023 through June 30, 2024. (Chairman Sergio Granados)
- 3. Authorizing the County Manager to apply for and accept funding for the State of New Jersey, Office of the Attorney General's Edward Byrne Memorial Justice Assistance Grant (JAG) Program to support the Multi-Jurisdictional Gang, Gun, and Narcotics Task Forces for the period of July 1, 2021 through June 30, 2022 in the amount of \$105,150.00. (Chairman Sergio Granados)

Regarding Item Nos. 1-3, Commissioner Kowalski commended the Prosecutor's Office for their efforts in pursuing and securing grant funding for various important programs as noted above. She noted the importance of cooperation among the various levels of government as a means to improve the lives of the residents they serve. She thanked the Office for being proactive in securing available grants and in turn offsetting County costs for these invaluable resources.

First Assistant Prosecutor Tansey noted that his Office devoted time to researching grant opportunities that could help better serve the residents of Union County and provide them with essential resources.

4. Amending Resolution 2022-567, a contract with Thermo Fisher Scientific Inc., (D/B/A/ Life Technologies), Waltham, MA, to reflect a change/addition of account number only. (Chairman Sergio Granados)

### **BOARD OF ELECTIONS**

Nicole DiRado, Administrator

1. Amending Resolution 2021-205, a contract with SOE Software Corporation d/b/a Scytl, Tampa, FL, for the purposes of providing additional updates for the Union County Virtual Poll Worker Training platform in the amount of \$3,450.00 for a new contract amount not to exceed \$87,082.00. (Chairman Sergio Granados)

Commissioner Kowalski asked Administrator DiRado to elaborate on this item and asked if it was related to forthcoming changes in the next Primary Election.

Administrator DiRado advised that pending legislation, sponsored by Assembly Speaker Craig Coughlin, would dictate new reporting requirements on Election night, including the quantity of provisional ballots issued. She further advised that this information was customarily not available until all the provisional ballots were retrieved from the supply bag from the various polling locations once the polls closed on Election night. She noted that in

order to comply with the proposed legislation, the BOE would have to issue a provisional ballot from the electronic poll books and have it marked on the Express Vote XL, adding that this was similar to the procedure for early-voting. She added that the provisional ballot card would be inserted into the voting machine and subsequently marked by the voter at which time the ballot card would be removed from the machine and sealed in the provisional certificate envelope. She noted that the voter would then complete the attached certification before submitting their vote. Administrator DiRado noted that she hoped to implement these changes in the upcoming Primary Election in preparation for the legislation change which would take effect in the 2023 General Election. Relative to the cited Resolution, Administrator DiRado advised that she was amending the initial Resolution to include additional monies for edit hours that would be used to update the existing program. She noted that the cited vendor currently provided the BOE's virtual poll worker training program, which including 20 edit hours under the initial contract. As a result of the forthcoming legislation, Administrator DiRado advised that the BOE would require additional edit hours to make the necessary changes and updates. She added that she was hopeful the program would be ready by May 15th. Relative to poll worker training, Administrator DiRado advised that she was encouraging poll workers to familiarize themselves with the new procedure now in preparation for the forthcoming changes in the 2023 General Election. She closed by noting that once the legislation took effect, poll workers could no longer provide paper provisional ballots to voters on Election day, unless an emergency circumstance arose, citing machine failure as an example.

### DEPARTMENT OF ADMINISTRATIVE SERVICES

Laura Scutari, Director

- 1. Authorizing the County Manager to sign any and all documents necessary to enter into a Collective Bargaining Agreement with the IBEW Local 1158, effective January 1, 2022 through December 31, 2024. (Chairman Sergio Granados)

Commissioner Williams asked Director Scutari to elaborate on this item.

Director Scutari advised that this item was an annual resolution required by that state in conjunction with the introduction of the County's budget. She noted that the purpose of the item was to confirm the County's compliance with the Equal Employment Opportunity Commission's hiring practices.

### DEPARTMENT OF ECONOMIC DEVELOPMENT

Amy Crisp Wagner, Deputy County Manager/Director

1. Authorizing the County Manager to sponsor the Union County Educational Services Commission and Overlook Hospital, by providing monetary assistance for the Union

County Project SEARCH Program to cover travel and training for nine (9) students with NJTIP at Rutgers, NJ Transit tickets, and Licenses for Virtual Job Shadow.com, in an amount not to exceed \$30,000.00. (Chairman Sergio Granados)

- 2. Authorizing the County Manager to award a contract to Business Automation Technologies (D/B/A Data Network Solutions), Little Silver, NJ, through the Educational Services Commission of NJ #65MCESCCPS, for Internet Services for Data Network for the period of January 1, 2023 through December 31, 2023 in an amount not to exceed \$11,865.00. (Chairman Sergio Granados)
- 3. Amending Resolution Number 2023-0325, authorizing an application for and to accept funding from the State of New Jersey, Department of Community Affairs, Division of Local Government Services, under the Local Efficiency Achievement Program (LEAP) Implementation Grant, to reflect a reduced amount requested from \$400,000.00 to \$373,000. Commissioner Baker asked Deputy County Manager Wagner to elaborate on this item.

Deputy County Manager Wagner advised that this item would authorize her Department to apply for a Shared Service Grant and incorporate two additional municipalities under the County's Dispatch Shared Services. She further advised that the initial Resolution was being amended to reflect the correct amount of \$373,000.

Assistant Director Karen Dinsmore represented the Department.

- 2. Amending Resolution 2023-285, a contract with Community Access Unlimited for Supportive Services for customers of the American Job Center, to reflect account number changes only; all other terms and conditions of the prior resolutions and contract remain the same. (Chairman Sergio Granados)
- 3. Amending Resolution 2022-1077, a resolution authorizing individual agreements with various agencies to deliver the activities, programs and services under the Union County Youth Services Commission Spending Plan, to reflect a change in account numbers only. Commissioner Baker asked Assistant Director Dinsmore to elaborate on this item.

Assistant Director Dinsmore advised that Resolution No. 2022-1099 was being amended due to a need for additional administrative staff at Cornerstone Behavioral Health Hospital. She noted that the initial contract included funding for a hospital administrator and was being revised to include funding for two more positions.

### DEPARTMENT OF PARKS AND RECREATION

Victoria Durbin-Drake, Director

1. Amending Resolution Number 2021-138, an agreement with the United States Department of Agriculture, the Animal Plant, Health Inspection Service, Wildlife Services (USDA, APHIS, WS) for the purpose of reducing wildlife damage to human health and safety, property, and natural resources in Union County, to reflect a change in account numbers only. (Commissioner Rebecca Lynne Williams)

Commissioner Leon asked Director Durbin-Drake to elaborate on this item.

Director Durbin-Drake advised that the Board had previously voted on a Resolution authorizing her Department to execute a two-year contract with the United States Department of Agriculture, noting that the USDA oversaw the County's Geese Management

Program in addition to addressing issues with other species of wildlife. She added that the County had been partnering with the USDA for the last 15 years. She further advised that the original Resolution was being amended to adjust the appropriations as they had to come from three different years.

2. Authorizing the County Manager to execute a License Agreement with DEWLAX, Inc. to hold a Girls' Lacrosse Tournament at Oak Ridge Park on May 7, 2023. (Commissioner Rebecca Lynne Williams)

Commissioner Garretson asked Director Durbin-Drake to elaborate on this item.

Director Durbin-Drake advised that DEWLAX Inc. had been hosting a Girls' Lacrosse Tournament in the County's Parks for many years, noting that this year the tournament would be held in Oak Ridge Park. She added that an average of 50 to 100 teams comprised of girls 12 years of age and under participated in the tournament.
