

# UNION COUNTY BOARD OF COUNTY COMMISSIONERS

# THURSDAY, JULY 13, 2023 REGULAR MEETING MINUTES

#### CALL TO ORDER

Chairman Granados presided over the meeting and called the meeting to order at 7:45 P.M.

#### ROLL CALL

Roll call showed Chairman Sergio Granados, Vice-Chairwoman Kimberly Palmieri-Mouded, Commissioner James E. Baker, Jr., Commissioner Joseph C. Bodek, Commissioner Angela R. Garretson, Commissioner Lourdes M. Leon, Commissioner Alexander Mirabella, and Commissioner Rebecca Williams were present, with Commissioner Bette Jane Kowalski absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

#### PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

### STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

Clerk Pellettiere advised that as a result of action taken by the Board during Executive Session, his Office had prepared and distributed new agendas for the Board's Regular Meeting.

#### **APPROVAL OF COMMUNICATIONS**

Note and File

Chairman Granados called for a motion to approve the Communications. On a motion made by Commissioner Mirabella and seconded by Commissioner Williams, roll call showed eight members of the Board voted in the affirmative, with Commissioner Kowalski absent.

#### **PUBLIC COMMENT PORTION**

The meeting was opened for the purpose of commenting on resolutions being offered for adoption and on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Bruce Paterson, of Garwood, asked questions and made comments relative to several resolutions. Relative to Reso No. 2023-628, Mr. Paterson asked for an update relative to NJ Department of Health Public Employees Occupational Safety & Health Act (PEOSH) violations at the Union County Courthouse. Relative to Reso No. 2023-655, he asked about the size of the warehouse space being rented and inquired about this item being secured through public bidding. Relative to Reso No. 2023-677, he asked about the action taken during Executive Session. Mr. Paterson also made comments relative to Finance Director Taylor recently earning her Doctorate in Education. He also noted that he was still waiting for an answer relative to the total monies spent on the matter of Figueroa v. County of Union. To close, Mr. Paterson recognized Clerk Rajoppi and her staff for providing quality service during his passport renewal.

Relative to Reso No. 2023-628, Director Graziano advised that the noted PEOSH violations were being addressed, adding that remediations were a priority and would be completed as soon as possible. He noted that the County would never knowingly put their employees at risk.

Relative to Reso No. 2023-655, Administrator DiRado advised that the lease agreement with Liberty Transportation & Storage Company Inc. was for 3,218 feet of office space as well as 2,500 square feet of warehouse space. She highlighted the importance of securing a trusted vendor to provide said service. She added that pursuant to NJSA 4A:11-5(1)(a)ii the Board of Elections was allowed to secure a contract for extraordinary unspecifiable services without the need for a competitive bid.

Relative to Reso No. 2023-667, Counsel Bergen advised that the item added to the agenda as a result of action taken by the Board during Executive Session, was related to a settlement for a long-standing lawsuit the County had been involved in.

There were no additional questions or comments from the public.

#### **COMMISSIONER REPORTS AND COMMENTS**

Commissioner Baker invited senior residents and their caregivers to attend the County's ASK events taking place during the month of July. He advised that these events would provide residents with an opportunity to learn about the various programs and resources available for aging adults, including adult day care, respite care, and home-delivered meals, among other services. He noted that no appointment or registration was necessary to attend, adding that bilingual assistance would also be available. He advised that the Aging Services Kiosk would be visiting the Elizabeth Public Library on July 19<sup>th</sup>, the Plainfield Library on July 24<sup>th</sup>, and the Roselle Public Library on July 28<sup>th</sup>. He encouraged interested residents to visit the County website for more information.

Commissioner Mirabella announced a partnership between Union County's Prosecutor's Office and the Police Chiefs' Association relative to U.C. Crime Stoppers. He noted that this resource would assist efforts to reduce car thefts, burglaries and other crimes in Union County by providing a resource for residents to anonymously report crimes. He added that this resource in addition to license plater readers and related technology could be used to reduce crime in Union County. Commissioner Mirabella advised that residents could be rewarded up to \$10,000 for information that would lead to an arrest and indictment, adding that anonymous tips could be reported by phone or on the Crime Stoppers website. He recognized Prosecutor Daniel and First Assistant Prosecutor Tansey for their proactive approach to fighting crime in Union County.

Commissioner Williams congratulated Finance Director Taylor on her recent academic accomplishment, noting the slanderous remarks made by Mr. Paterson. On another note, she announced that the County was currently seeking residents to volunteer at the Union County Rape Crisis Center. She noted the important role played by volunteers in providing guidance and support to victims and survivors of sexual violence. She advised that interested residents had to be 18 or older, possess a valid driver's license and a personal vehicle as well as complete a 40+ hour state-mandated training program. She further advised that training would take place in Westfield from September 12<sup>th</sup> – November 2<sup>nd</sup>, adding that upon the completion of training, volunteers would be certified as sexual violence advocates that could provide support and in-person guidance to victims of sexual abuse.

Commissioner Garretson spoke relative to the various summer activities and programs taking place throughout Union County. She encouraged residents to visit the County website to learn more about these offerings. On another note, she noted a recent demonstration that took place last week in support of Haiti, adding that the event was well attended and she was happy to see the participation. She thanked Charlene for her efforts to this end.

Commissioner Bodek invited residents to attend the County's Choose Your Cover Program on August 5<sup>th</sup> at Ponderosa Farm Park in Scotch Plains. He noted that this free skin cancer screening aimed to educate residents on sun safety and precautions that can be taken to reduce the risk of skin cancer. He added that the event was free, but a prescreening survey was required. He noted that personnel from the Union County's Office on Health Management in partnership with Memorial Sloan Kettering Cancer Center would be on site to provide screenings and important information on lowering the risk of skin cancer.

Commissioner Leon noted her recent attendance, alongside Chairman Granados, of the 2023 Lions Charity Run fundraiser that took place recently at Mattano Park. She recognized the Lions Club as an organization committed to serving the community by raising funds and awareness for charitable causes, including for those affected by war and natural disasters. She advised that the 2023 Lions International Convention would be held in Boston, noting the importance of building a strong network of individuals and organizations for the betterment of society. She closed by thanking the Elizabeth Lions Cuban Club and the Elizabeth Portuguese Lions Club as well as NJ's Multicultural Lions Club and the Hillside Lions Club.

Vice-Chairwoman Palmieri-Mouded advised that the Union County's Office for Persons with Disabilities and Special Needs, in conjunction with the Town of Westfield would be hosting a Paint by the Pond event on August 12<sup>th</sup> at Mindowaskin Park in Westfield. She noted that the event was free, but pre-registration was required, noting that all residents of all abilities and ages were welcome to attend. She encouraged interested residents to visit the County's website to register.

Chairman Granados wished everyone a Happy summer.
