THURSDAY, JUNE 29, 2023 AGENDA SETTING MEETING MINUTES

CALL TO ORDER

Chairman Granados presided over the meeting and called the meeting to order at 6:08 P.M.

ROLL CALL

Roll call showed Chairman Sergio Granados, Vice-Chairwoman Kimberly Palmieri-Mouded, Commissioner James E. Baker, Jr., Commissioner Joseph C. Bodek, Commissioner Lourdes M. Leon, and Commissioner Rebecca Williams were present, with Commissioner Angela R. Garretson, Commissioner Bette Jane Kowalski, and Commissioner Alexander Mirabella absent.

Also present were County Manager Edward T. Oatman, 1st Deputy County Counsel Moshood Muftau, Esq., and Assistant Clerk Marlena Russo.

PRESENTATIONS BY THE BOARD

Commissioner Baker asked Prosecutor Daniel to elaborate on this item.

Prosecutor Daniel confirmed the Prosecutor's Office annual participation in the Operation Helping Hands program in collaboration with various community agencies and partners. He added that these efforts included pop-up tents in strategic locations to intercept drug transactions and offer mental health screening as well as treatment referrals in place of arrest. He advised that approximately 36 individuals had been arrested in three days, adding that 13 of those individuals had been referred to out-patient treatment. Prosecutor Daniel advised that the grant monies would fund the cost of medical screeners and overtime.

Chairman Granados recognized Prosecutor Daniel for his efforts in the Arrive Together initiative. He also recognized the efforts of Governor Murphy and NJ Senate President Nicholas Scutari for facilitating the largest expansion of this program in Union County.

Prosecutor Daniel recognized the Board and the NJ Attorney General's Office for their efforts.
