# THURSDAY, MARCH 30, 2023 AGENDA SETTING MEETING MINUTES

#### CALL TO ORDER

Chairman Granados presided over the meeting and called the meeting to order at 6:00 P.M.

### ROLL CALL

Roll call showed Chairman Sergio Granados, Vice-Chairwoman Kimberly Palmieri-Mouded, Commissioner Joseph C. Bodek, Commissioner Angela R. Garretson, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, Commissioner Alexander Mirabella, and Commissioner Rebecca Williams were present, with Commissioner James E. Baker, Jr. absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

#### PRESENTATIONS BY THE BOARD

Chairman Granados noted that he was proud to be able to recognize the efforts and contributions of the aforementioned agencies and community organizations during Autism Acceptance Month in April. He noted the Board's commitment to ensuring all individuals in Union County, including individuals with autism feel accepted, supported and seen as well as have access to the resources and services they may need to thrive. He noted that the County

also offered a variety of programs year-round for individuals with Disabilities and Special Needs. Chairman Granados called upon Commissioner Leon to join him for the presentation.

Commissioner Leon noted that Autism Acceptance Month was a cause that was near-and-dear to her heart, adding that she was happy to be able to recognize these individuals and entities for their unyielding efforts in supporting individuals with autism year-round. 1. Commissioner Mirabella asked Director Graziano to elaborate on this item.

Director Graziano advised that the contract for the Lenape Park Dam Rehabilitation Project was being closed-out, noting that the County had revised the contract which resulted in the cited decrease of \$108,504.62. He noted that the vendor had originally been contract to complete the work, but due to certain concerns related to the use of Tandem dump trucks, the County opted to revise the contract and complete the paving using single-axels trucks.
