CALL TO ORDER

Chairman Granados presided over the meeting and called the meeting to order at 6:03 P.M.

ROLL CALL

Roll call showed Chairman Sergio Granados, Commissioner James E. Baker, Jr., Commissioner Joseph C. Bodek, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, , and Commissioner Rebecca Williams were present, with Vice-Chairwoman Kimberly Palmieri-Mouded, Commissioner Angela R. Garretson, Commissioner Alexander Mirabella absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

PRESENTATIONS BY THE BOARD

Commissioner Kowalski recognized all the recipients of the 2023 Empowering Union County Libraries Initiative and welcomed them to that evening's meeting. The municipal representatives thanked the Board for their generosity and helping them enhance and expand on the resources they provide their residents through their local libraries.
