

UNION COUNTY BOARD OF COUNTY COMMISSIONERS

THURSDAY, MAY 25 2023 AGENDA SETTING MEETING MINUTES

CALL TO ORDER

Chairman Granados presided over the meeting and called the meeting to order at 6:02 P.M.

ROLL CALL

Roll call showed Chairman Sergio Granados, Vice-Chairwoman Kimberly Palmieri-Mouded, Commissioner James E. Baker, Jr., Commissioner Joseph C. Bodek, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, and Commissioner Rebecca Williams were present, with Commissioner Angela R. Garretson and Commissioner Alexander Mirabella absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

PRESENTATIONS BY THE BOARD

A resolution presentation was made by the Board to representatives of Moms Demand Action for Gun Sense in America in recognition of June 2, 2023 as the 9th Annual Gun Violence Awareness Day.

Chairman Granados advised that the County Commissioner Board was honored to present a Resolution to representatives from the Moms Demand Action organization in recognition of the 9th Annual Gun Violence Awareness Day on June 2nd for their continued efforts and advocacy relative to gun safety and promoting meaningful change. He added that the Board was committed to working with organizations like Moms Demand Action to create a safer, more peaceful future.

Chairman Granados asked Vice-Chairwoman Palmieri-Mouded to join him for the resolution presentation.

On behalf of the Board, Vice-Chairwoman Palmieri-Mouded noted that she was pleased to be able to recognize the Moms Demand Action organization and thanked

them for their continued efforts, adding that everyone's life depended on changes to existing gun legislation.

Kathleen Doland, of Moms Demand Action, thanked the Board for their recognition of the Moms Demand Action organization and for allowing them to continue raising awareness on gun safety. She invited residents to attend the Moms Demand Action Peace Walk on June 3rd at Rahway River Park to honor victims and survivors of gun violence.

OFFICE OF THE UNION COUNTY PROSECUTOR

William Daniel, Prosecutor

First Assistant Prosecutor James O. Tansey represented the Office.

- 1. Authorizing the County Manager to apply for and accept funding for the State of New Jersey, Office of the Attorney General's Edward Byrne Memorial Justice Assistance Grant (JAG) Program to support the Multi-Jurisdictional Gang, Gun, and Narcotics Task Forces for the period of July 1, 2022 through June 30, 2023 in the amount of \$135,835.00. (No cost to the County of Union) (Chairman Sergio Granados)
- 2. Authorizing the County Manager to apply for and accept funding from the State of New Jersey, Office of the Attorney General, Division of Administration, Department of Law and Public Safety through the American Rescue Plan (ARP) Act Coronavirus State Fiscal Recovery Fund, FY 2021, Gunshot Detection Technology Initiative for the period of December 1, 2022 through November 30, 2024 in the amount of \$355,500.00. (No cost to the County of Union) (Chairman Sergio Granados)

Commissioner Kowalski asked First Assistant Prosecutor Tansey to elaborate on this item.

First Assistant Prosecutor Tansey advised that this item related to a federal grant funded through the American Rescue Plan Act. He noted that if awarded, the grant would be used towards gunshot detection technology in the form of a shot-spotter to be used in conjunction with license plate readers. He added that this item would be of no cost to the County.

Commissioner Baker inquired about existing gunshot detection technology and asked if this was comparable.

First Assistant Prosecutor Tansey advised that shot spotters were placed in various locations to detect the sound of gunshots, adding that in such an instance, law enforcement would respond to the disturbance. He added that license plate reading technology could be used in conjunction with shot spotters to identify vehicles within the vicinity of a gunshot.

DEPARTMENT OF ECONOMIC DEVELOPMENT

Amy Crisp Wagner, Deputy County Manager/Director

1. Authorizing the County Manager to apply for and accept funding from the NJ Department of Transportation, Local Transportation Projects Fund 2023 for the NY Connects to Union County NJ East Coast Greenway Bikeway Project to create a safe bikeway corridor from the Goethals Bridge to connect to the East Coast Greenway at Centennial Avenue in Cranford, NJ. (Chairman Sergio Granados)

Commissioner Williams asked Deputy County Manager Wagner to elaborate on this item.

Deputy County Manager Wagner advised that this item related to applying for and hopefully receiving grant funding from the NJ's Department of Transportation to fund the NJ East Coast Greenway Bikeway Project, adding that this greenway would connect Goethals Bridge to Cranford, running through the City of Elizabeth and Borough of Roselle. She noted that she was looking forward to the opportunity to provide residents with a safe bikeway corridor from Goethals Bridge to portions of Union County.

- 2. Approving the by-laws of the Union County Transportation Advisory Board (UC TAB), approved at the May 3, 2023 meeting of the Union County Transportation Advisory Board. (Chairman Sergio Granados)
- 3. Authorizing the County Manager to apply for and to receive funds from the Department of Housing and Urban Development for the 2023-2024 Annual Action Plan on behalf of the Union County Community Development Block Grant Program, HOME Investment Partnerships Program and the Emergency Solutions Grant Program. (Chairman Sergio Granados)
- 4. Authorizing the County Manager through the Union County Department of Economic Development to provide required documentation to the US Department of Housing and Urban Development to ensure the County's continued participation in the CDBG, HOME and ESG programs. (Chairman Sergio Granados)
- 5. Authorizing the County Manager to transfer \$25,000.00 in Plainfield Program Income from Plainfield account in association with the successful administration of the Community Development Block Grant Program by the City of Plainfield, to help offset the cost of demolition for two properties destroyed in a fire. (Chairman Sergio Granados)
- 6. Authorizing the County Manager to award a contract to Lighthouse Collaborative LLC, Hillside, NJ for the implementation of a 2023/2024 School Gender and Sexuality Alliances (GSAs) Program in an amount not to exceed \$38,800.00. (Chairman Sergio Granados)

Commissioner Williams asked Deputy County Manager Wagner to provide an update on this program.

Deputy County Manager Wagner advised that last year, as part of Chair William's initiatives, the County had selected four schools to receive grant funding to implement a Gender and Sexuality Alliance program. She further advised that the vendor would be expanding the program to an additional four schools and creating a network of Union County schools with

GSA Programs. She noted that the program had been tremendously successful and well-received, adding that the County looked forward to expanding these programs throughout Union County schools to provide children with a safe, accepting space.

Chairman Granados recognized Commissioner Williams for her efforts in launching this initiative during her tenure as Chair of the Board.

DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT Joseph Graziano, Director

1. Amending Resolution Number 2023-247 adopted March 16, 2023, BA# 1-2021, a contract awarded through advertised public bidding in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., to Railroad Construction Company, Inc., of Paterson, New Jersey, approving Change Order Number 4 for the Gordon Street Bridge over "Out of Service" Conrail structure 2050150, Boroughs of Roselle and Roselle Park, County of Union, New Jersey. This change order will increase the original contract amount by \$154,151.60 for a new contract amount not to exceed \$7,859,502.33. Subject to the approval of the New Jersey Department of Transportation. (Commissioner Bette Jane Kowalski)

Commissioner Bodek asked about the completion date for this project.

Director Graziano advised that the project was on schedule to be completed by late August of this year, adding that the sidewalks would be poured in the next few weeks.

Commissioner Kowalski inquired about the increase.

Director Graziano confirmed that this project was being funded by the NJ Department of Transportation. He advised that the increase was related to additional materials, labor, waterproofing, and disposal needed as a result of a minor adjustment to the original placement of the bridge.

Commissioner Kowalski noted that this project had been on-going for quite some time, adding that she anticipated an increase as a result of rising prices.

- 2.
