

UNION COUNTY BOARD OF COUNTY COMMISSIONERS

THURSDAY, JANUARY 25, 2024 REGULAR MEETING MINUTES

CALL TO ORDER

Chairman Granados presided over the meeting and called the meeting to order at 6:32 P.M.

ROLL CALL

Roll call showed Chairwoman Kimberly Palmieri-Mouded, Vice-Chairwoman Lourdes M. Leon, Commissioner James E. Baker, Jr, Commissioner Joseph C. Bodek, Commissioner Michèle S. Delisfort, Commissioner Alexander Mirabella, and Commissioner Rebecca Williams were present, with Commissioner Sergio Granados and Commissioner Bette Jane Kowalski absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

EXECUTIVE SESSION

To the extent known, the following item was discussed in Executive Session:

1) Litigation strategy in the matter of Kenilworth Republican Committee Members v. Union County Clerk, Union County Board of Elections and Union County.

County Counsel Bergen stated that pursuant to provisions of the Open Public Meetings Act, a public body could enter into Executive Session for the purpose of discussing certain enumerated subjects.

He stated that the Board wished to enter into Executive Session for the purpose of discussing a litigation strategy in the matter of Kenilworth Republican Committee Members v. Union County Clerk, Union County Board of Elections and Union County.

He stated that the minutes of the Executive Session would be separated from the minutes of the Open Public Session and that the minutes of the Executive Session, redacted as appropriate and necessary, would be available in approximately 30 days. He stated that the Clerk of the Board would retain the original minutes until

such time as the confidential limitations have been removed, at which time they shall be made available.

He stated that upon affirmative vote of the majority of the members present, the Board could enter Executive Session and upon the Board's return may or may not take formal action on the matters discussed.

Chairwoman Palmieri-Mouded called for a motion to enter into Executive Session. On a motion made by Commissioner Bodek and seconded by Commissioner Mirabella, roll call showed seven members of the Board voted in the affirmative, with Commissioner Granados and Commissioner Kowalski absent.

Chairwoman Palmieri-Mouded called for a motion to return from Executive Session. On a motion made by Commissioner Mirabella and seconded by Commissioner Williams, roll call showed seven members of the Board voted in the affirmative, with Commissioner Granados and Commissioner Kowalski absent.

County Counsel Bergen advised that he had nothing to report following Executive Session.

APPROVAL OF COMMUNICATIONS

Note and File

Chairwoman Palmieri-Mouded called for a motion to approve the Communications. On a motion made by Commissioner Mirabella and seconded by Commissioner Williams, roll call showed seven members of the Board voted in the affirmative, with Commissioner Granados and Commissioner Kowalski absent.

PUBLIC COMMENT PORTION

The meeting was opened for the purpose of commenting on resolutions being offered for adoption and on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Local 5112 HPAE Secretary Treasurer, Alexis Rean Walker, of Roselle spoke relative to the Union's labor negotiations with the County of Union. She outlined the Union's requests and asked the County to negotiate in good faith and consider their demands.

Cornerstone Behavioral Health Hospital employee, Ann Marie Howard, of Middlesex County, also spoke relative to Local 5112 HPAE's union negotiations with the County of Union. She mentioned certain difficulties experienced in hiring and retaining quality employees, citing salaries as a central issue. She noted a petition she had bearing the signature of twenty-four employees that shared in her concerns.

Chairwoman Palmieri-Mouded advised that the Board of Commissioners was prohibited from getting involved in Union labor negotiations and or agreements.

Frank Wilson, of Roselle Park, spoke relative to Ash Brook Golf Course and the persistent flooding on-site, adding that these issues often made the courses unplayable. He noted the role of Hurricane Ida is exacerbating the existing problems.

John Cort, of Rahway, noted his frustration over the golf course as Ash Brook, adding that conditions had forced players to seek alternate courses outside of Union County.

Bob Kasko, of Westfield, also shared his frustrations over Ash Brook Golf Course, noting that courses were often unplayable. He invited the Board to visit the course and take a greater interest in remedying the problems on site.

Bruce Paterson, of Garwood, made comments and asked questions relative to several resolutions. Relative to Reso No. 2024-72, Reso No. 2024-74, and Reso No. 2024-76, he made comments relative to the cited vendor. He asked for additional information relative to Reso No. 2024-72. Relative to Reso No. 2024-74, he asked about the miles of road to be repaved. Relative to Reso No. 2024-83, he asked for additional information. Mr. Paterson also made comments about the funding for Reso No. 2024-101. Relative to general comments, he noted the removal of the Amphibious Excavator at the Ash Brook wetlands as well as the constant flooding of the fairways on the course. To close, he made allegations about Finance Director Taylor which prompted County Manager Oatman to refute Mr. Paterson's claim.

Relative to Reso No. 2024-72, County Engineer Matias advised that this item related to ongoing environmental remediation efforts at Lenape Park.

Relative to Reso No. 2024-74, County Engineer Matias advised that this paving project would include 15 miles of road. He advised that this project was awarded to the lowest bidder.

Relative to Reso No. 2024-83, County Engineer Matias advised that this was a new parking lot off Spring Street.

Labor Representative, Kathy Hatfield, spoke relative to the ongoing negotiations with Local 5112 HPAE, noting that she always negotiated in good faith. She discussed the disputes about salary, noting that she was committed to fair negotiations with reasonable concessions.

County Manager Oatman responded to Mr. Paterson's comments about Director Taylor; noting his comments have continued for 18 months.

Relative to Oak Ridge Golf Course, County Engineer Matias advised that work onsite was ongoing, noting that a consulting firm had been contracted to produce conceptual plans to present to NJDEP for general permitting. He added that those plans were currently being reviewed by NJDEP, noting a 90-day review period and a requested extension. He further advised that once general permitting was received, the consulting firm would finalize plans for the work to be bid on. Deputy County Clerk Fernandez advised that the increase in funding was needed for work that was initially slated to be done in-house. She added that all the renovation work was being funded by the County Clerk's Trust Fund.

There were no additional questions or comments.
