The following resolutions are being offered for adoption:

Authorizing the County Manager to enter into a contract with Elite Vehicle Solutions through New Jersey State Contract #17-FLEET-00749 for the purchase of equipment for Union County Sheriff's transport vehicles in the amount not to exceed \$229,500.00.

Amending Resolution 2020-96 adopted January 23, 2020, a contract with Neglia Engineering Associates, Mountainside, New Jersey, to provide additional design and construction administration services related to the 2021 Road Resurfacing Project in an amount not to exceed \$38,850.00 for a new contract amount not to exceed \$323,589.00 (Union County Engineering Project Number 2019-023).

Amending Resolution 2021-77 adopted January 21, 2021, a contract with Neglia Engineering Associates, Mountainside, New Jersey, to provide additional design and construction administration services related to the 2022 Road Resurfacing Project in an amount not to exceed \$47,385.00 for a new contract amount not to exceed \$360,277.00 (Union County Engineering Project Number 2020-010).

Authorizing the County Manager to enter into an Agreement between the County of Union and the City of Summit for the installation of a Rectangular Rapid Flashing Beacon (RRFB) Pedestrian Crosswalk System at the mid-block crosswalk on Morris Avenue that connects St. Teresa of Avila Church and Springfield Avenue in the City of Summit, New Jersey. System will be purchased and maintained by the City of Summit.

Authorizing the County Manager to award the proposed contract obtained through advertising public bidding in accordance with the Local Public Contracts Law, NJSA40A:11-1 et seq: Department of Engineering, Public Works and Facilities Management to Traffic Safety Service, LLC for the purpose of providing Traffic Paint for a contract period of twenty-four months (24) in the amount not to exceed \$123,122.90 (BA#UCCP 11-2024).
