CALL TO ORDER

Chairwoman Palmieri-Mouded presided over the meeting and called the meeting to order at 6:03 P.M.

Clerk of the Board Pellettiere advised that the agendas that were distributed prior to the start of the meeting were incomplete and missing pages. He asked Chairwoman Palmieri-Mouded if she wanted to continue with the presentations while new agendas were prepared and or if she preferred to pause the meeting until the new agendas were distributed.

PRESENTATIONS BY THE BOARD

A presentation was made to Cesar Vega recognizing him for his great work as JVJ Stem Academy #92 Boys Volleyball Head Coach and as Assistant to the Girls Varsity Volleyball team.

Chairwoman Palmieri-Mouded asked Vice-Chairwoman Leon to join her for this resolution presentation.

Chairwoman Palmieri-Mouded noted that the Board was honored to be able to recognize the efforts of Cesar Vega, Head Coach of the Elizabeth JVJ Boys Volleyball Team as well as the Assistant Coach of the Girls Varsity Team. She recognized Mr. Vega for his dedication and contributions, not only as a coach, but also as a teacher and mentor. She commended him for his commitment to the students of Elizabeth High School and congratulated him on being recognized that evening.

Vice-Chairwoman Leon noted that Cesar Vega's recognition that evening was well deserved, noting his many contributions as a teacher and coach.

Cesar Vega thanked the Board for the recognition, noting that he was honored to be able to give back to Union County and the City of Elizabeth. He recognized his family in attendance, adding that he was grateful to have their support that evening.

A presentation was made in recognition of National Donate Life Month to NJ Sharing Network General Counsel Catherine DeAppolonio, and NJ Sharing Network Foundation Executive Director Amanda Tibok, commending their efforts to support donor families, honor the legacy of those who gave the gift of life and raise awareness about the power of organ donation and transplantation.

Chairwoman Palmieri-Mouded asked Commissioner Mirabella to join her and Vice-Chairwoman Leon for the resolution presentation.

Chairwoman Palmieri-Mouded advised that in honor of National Donate Life Month in April, the Board was proud to recognize the NJ Sharing Network Foundation in New Providence for their efforts relative to organ and tissue recovery and placement. She noted that the NJ Sharing Network Foundation was part of a national recovery system for over 100,000 people on the national waiting list, adding the growing need for such donations. She thanked the NJ Sharing Network Foundation for their continued efforts in raising awareness, advancing transplant research and supporting families through the process.

Commissioner Mirabella recognized the NJ Sharing Network Foundation for their continued efforts and for the essential services they provide. Being an organ donor himself, he encouraged others to learn more and get involved. He added that he was happy to be able to recognize the NJ Sharing Network Foundation with a Resolution from the Board.

NJ Sharing Network Foundation Executive Director Amanda Tibok thanked the Board and the County of Union for their ongoing support of the foundation's efforts. She invited everyone to participate in the upcoming 5K Celebration of Life event taking place on June 9th in New Providence.
