CALL TO ORDER

Chairwoman Palmieri-Mouded presided over the meeting and called the meeting to order at 6:38 P.M.

ROLL CALL

Roll call showed Chairwoman Kimberly Palmieri-Mouded, Vice-Chairwoman Lourdes M. Leon, Commissioner Joseph C. Bodek, Commissioner Michèle S. Delisfort, Commissioner Bette Jane Kowalski, Commissioner Alexander Mirabella, and Commissioner Rebecca Williams were present, with Commissioner James E. Baker, Jr and Commissioner Sergio Granados were absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

Chairwoman Palmieri-Mouded called for a motion to approve the March Minutes. On a motion made by Commissioner Bodek and seconded by Commissioner Delisfort, roll call showed seven members of the Board voted in the affirmative for the March 13th Agenda Setting and Regular meeting minutes, with Commissioner Baker and Commissioner

Granados absent; and six members of the Board voted in the affirmative for the March 27th Agenda Setting and Regular Meeting Minutes, with Commissioner Mirabella abstaining and Commissioner Baker and Commissioner Granados absent.

PUBLIC COMMENT PORTION

The meeting was opened for the purpose of commenting on resolutions being offered for adoption and on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Bruce Paterson, of Garwood, asked questions and made comments relative to several resolutions Relative to Reso Nos. 2024-313 & 2024-314, he asked why increases were being requested now for prior year projects. Relative to Reso No. 2024-317, he asked for additional information. Mr. Paterson also asked for a status update on the Courthouse Stairwell Project. He made comments relative to the County's 2024 Annual Budget and Commissioner Baker.

Relative to Reso Nos. 2024 313 & 2024-314, County Engineer Matias advised that these items would fund additional design and inspection services being requested by the Department related to NJ storm water requirements as well as additional ADA considerations.

Relative to Reso No. 2024-317, County Engineer Matias advised that this item was related to a new requirement through NJ's Department of Transportation. He noted that the NJDOT now required pre-qualification by the contracting agency for any project that receives state DOT funding over \$5,000,000.

Relative to the Courthouse Stairwell Project, County Engineer Matias advised that the Department was working to closeout this project, adding that additional work was still needed.

Relative to the 2024 County Budget, County Manager Oatman advised that the County's 2024 Budget could be viewed on the County's website.

COMMISSIONER REPORTS AND COMMENTS

Commissioner Kowalski announced that the Rutgers Master Gardeners of Union County, through the Rutgers Cooperative Extension, would be hosting their 33rd annual Spring Garden Fair and Plant Sale on Sunday, May 18th at the Demonstration Garden at Trailside Nature and Science Center. She noted that the Spring Garden Fair would include a wide variety of vegetable transplants, native and ornamental perennials as well as annual flowers and houseplants for sale. She advised that all sales were cash only, adding that visitors were encouraged to bring a small wagon to transport their purchases. She added that the long-awaited reopening symbolized the restoration of crucial infrastructure and illustrated the culmination of community efforts dedicated to creating accessible pathways for all residents. On another note, she also spoke relative to her recent attendance of Kean University's 4th Annual Lavender Graduation, adding that it was a wonderful celebration honoring LGBTQ students.

Commissioner Bodek encouraged interested residents to become poll workers for Primary Election Day, on June 4th, 2024. He advised that poll workers would earn \$300 for the day, adding that new poll workers would be required to attend a mandatory inperson training session. He noted that poll workers had to be 16 years and older, adding that residents 18 years and older would have to be registered voters. On another note, he spoke relative to his recent visit to the County's Fire & EMS Training Academy in Linden, noting many exciting developments taking place. To close, he offered his condolences to Lisa Bullock and her family relative to the loss of her father.

On behalf of the Board of Elections, Commissioner Delisfort announced that a list of polling locations and drop-box locations for the 2024 Primary Election, taking place on June 4th, were now available on the County's website. She advised that all 24 secure ballot drop boxes were under 24/7 camera surveillance and would be open to voters from April 19th through the close of polls on June 4th. To close, Commissioner Delisfort offered her condolences to Lisa Bullock and her family as well as the family of Congressman Donald Payne Jr. She recognized Congressman Payne as a dedicated and beloved public servant that would be sourly missed.

County Manager Oatman left the meeting; Deputy County Manager Wagner replaced him.

Commissioner Mirabella announced that the 2024 Union County Senior Art Exhibit was now on display at Union College, noting that the exhibit included 158 original works in a variety of mediums created by County residents aged 60 and above. He added that the exhibit was coordinated and made possible by the Union County Office of Cultural and

Heritage Affairs, a partner of the NJ state Council on Cultural & Heritage Affairs. He encouraged residents to visit the County's website for additional information about cultural programs in Union County.

Vice-Chairwoman Leon invited seniors and their caregivers to visit the County's local Aging Services Kiosk in May, adding that bilingual staff would be present to offer support in Spanish. She advised that the ASK program, offered aging adults and their caregivers an opportunity to learn more about valuable services and resources being offered through the County's Department of Human Services, including home-delivered meals, respite care, adult day care, and other support services. She added that preregistration was required to attend. She encouraged interested residents to visit the County's website for a complete list of dates, times and locations.

Chairwoman Palmieri-Mouded thanked Commissioners Kowalski, Leon, and Mirabella for joining her for the Arbor Day Poetry Contest presentation. She also noted that the Board was pleased to be able recognize the efforts of Catherine DeApppolonio and Amanda Tibok from the NJ Sharing Network, noting the growing need for organ donation and transplantation. Alongside Commissioner Delisfort, Chairwoman Palmieri-Mouded spoke relative to her recent attendance to the Local Advisory Council on Alcoholism and Drug Abuse (LACADA) Annual Municipal Volunteers of the Year dinner, noting it as a wonderful event. She also reminded residents about Wild Earth Fest taking place on April 28th at Trailside Nature & Science Center in Mountainside. To close, she noted Take Your Child to Work Day, adding that her children were looking forward to participating.

ADJOURNMENT

Chairwoman Palmieri-Mouded asked for a motion to adjourn the meeting. On a motion made by Commissioner Mirabella and seconded by Commissioner Bodek, roll call showed seven members of the Board voted in the affirmative, with Commissioner Baker and Commissioner Granados absent.

The meeting was adjourned at 7:06 P.M.
