

# UNION COUNTY BOARD OF COUNTY COMMISSIONERS

### THURSDAY, JANUARY 23, 2025 AGENDA SETTING MEETING AGENDA

### CALL TO ORDER

Chairwoman Leon presided over the meeting and called the meeting to order at 6:01 P.M.

### ROLL CALL

Roll call showed Chairwoman Lourdes M. Leon, Vice-Chairman Joseph C. Bodek, Commissioner Sergio Granados, Commissioner Alexander Mirabella, Commissioner Kimberly Palmieri-Mouded, and Commissioner Rebecca Williams were present, with Commissioner James E. Baker Jr, Commissioner Michèle S. Delisfort, and Commissioner Bette Jane Kowalski absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

### STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

### PRESENTATIONS BY THE BOARD

A Resolution Presentation was made by the Board congratulating the National Association for the Advancement of Colored People (NAACP) Elizabeth Branch President Shawn McClain and Retired Detective Darin Williamson upon receiving the Presidential Gold Award.

Chairwoman Leon noted that she was honored to be able to recognize Shawn McClain and Darin Williamson, two exceptional individuals that exemplified the highest ideals of community service, adding that their contributions had left a lasting impact on Union County and beyond.
