# THURSDAY, MAY 15, 2025 REGULAR MEETING MINUTES

# CALL TO ORDER

Chairwoman Leon presided over the meeting and called the meeting to order at 7:03PM

#### ROLL CALL

Roll call showed Chairwoman Lourdes Leon, Vice-Chairman Joseph C. Bodek, Commissioner James E. Baker, Jr., Commissioner Michèle Delisfort, Commissioner Bette Jane Kowalski, Commissioner Alexander Mirabella, Commissioner Kimberly Palmieri-Mouded, Commissioner Rebecca Williams were present, with Commissioner Sergio Granados absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

#### PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board James E. Pellettiere.

#### STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

#### **ORDINANCES FOR ADOPTION**

Clerk Pellettiere read Ordinance No. 857-2025 by title.

857-2025 AN ORDINANCE TO AMEND "THE LAWS OF UNION COUNTY: ADMINISTRATIVE CODE AND POLICIES AND GENERAL LEGISLATION" BY AMENDING: PART II-POLICIES AND GENERAL LEGISLATION: CHAPTER 49, FEES, ARTICLE V, ENGINEERING & PUBLIC WORKS FEES AND ARTICLE VII (NEW), OFFICE OF THE UNION COUNTY SURROGATE FEES.

#### PUBLIC HEARING

Prior to opening the meeting up for public comment on Ordinance No. 857-2025, Chairwoman Leon turned the meeting over to Counsel Bergen to say a few words.

# Counsel Bergen addressed the public:

Before we begin any public comments this evening, the Chair has asked that I make a few remarks to remind those attending the rules of this meeting. First, based upon the number of people appearing tonight to address the Board, to ensure everyone who wishes to has an opportunity to speak, the amount of time each public speaker will be allowed during tonight's meeting will be three minutes. As always, please note the one-minute warning sign and please end your remarks once the red sign, indicating your time is over, is held up. No additional time is allowed. Second, to maintain decorum in the meeting and to allow all speakers to be heard by the Board, no telephone use is allowed during the meeting, and any in-person conversations should be taken out into the hallway, so as not to disturb other members of the public or the Board, Also, please do not call out from the audience or make any comments other than during your own speaking time. During your remarks, please refrain from profanity or vulgar comments and do not make any personal comments or attacks. Anyone violating these rules may have their speaking time ended. Further violation of these rules, or any action that disrupts the meeting or interferes with the Board's ability to conduct its business are grounds for removal from the meeting. Once again, to avoid safety issues and assist in the speaking process, we've handed out numbers to those people wishing to speak later during the general comment period. The numbers will be called in groups of 5. Please line up behind the microphone and wait until your number is called before you stand up so there is no blocking the aisle or interference with other people's ability to see. The current public hearing is for Ordinance only. Please do not make comments concerning any other issue on the agenda, as I noted that time will come shortly during the regular public comment portion. Thank you Chair.

The meeting was opened for public comment on Ordinance Number 857-2025 only.

Bruce Paterson, of Garwood, inquired about the fees being imposed by Public Works. He also commented on the new fees being added by the Surrogate's Office.

Counsel Bergen advised that the fees for the Public Works Department were related to tipping and a leaf composting facility, adding that the amount being charged to the municipalities for this service would slightly increase to help keep the service available. He noted that fees were still well below market cost. Counsel Bergen further advised that customers of the Surrogate's Office would now be responsible for paying the fees charged to the Office for credit card transactions.

#### FINAL READING STATEMENT

Vice Chairman Joseph Bodek, Policy Subcommittee Chairman, moved Ordinance Number 857-2025 for Final Reading and authorized the Clerk of the Board to advertise same in accordance with the law.

On a motion made by Vice-Chairman Bodek and seconded by Commissioner Kowalski, roll call showed eight members of the Board voted in the affirmative, with Commissioner Granados absent.

#### APPROVAL OF COMMUNICATIONS

On a motion made by Commissioner Mirabella and seconded by Commissioner Baker, roll call showed eight members voted in the affirmative, with Commissioner Granados absent.

On a motion made by Commissioner Kowalski and seconded by Commissioner Delisfort, roll call showed seven members of the Board bolted in the affirmative, with Commissioner Mirabella abstaining and Commissioner Granados absent.

#### **PUBLIC COMMENT PORTION**

The meeting was opened for the purpose of commenting on resolutions being offered for adoption and on any governmental issue that a member of the public feels may be of concern to the residents of the County.

Arman Aliasgharpour, employee of Spincube headquartered in Clark, spoke relative to Reso No. 2025-469 and inquired about the proposal submitted by the cited vendor.

Relative to Reso No. 2025-469, Counsel Bergen advised that Mr. Aliasgharpour's company had submitted a bid for this project and had no proper objection. He added that he believed the County had followed the appropriate process and recommended the Board proceed with passing the Resolution.

Bruce Paterson, of Garwood, made comments relative to Reso No. 2025-412, 2025-417, and 2025-419. He asked for additional information related to Reso No. 2025-426 & 2025-434. Relative to Reso No. 2025-426, County Manager Oatman advised that improvements would include an upgraded base for the top tracer.

Relative to Reso No. 2025-434, County Manager Oatman advised that this item would fund system upgrades and an expansion of the center.

Nancy Twaskas, of Clark, asked why a resolution was needed to change an account number as cited in Reso No. 2025-429. On another note, she spoke relative to the conditions at Ash Brook Golf Course in Clark.

Relative to Reso No. 2025-429, County Manager Oatman advised that by law, a resolution was required to change account numbers.

Elvira, of Elizabeth, spoke relative to her concerns over ICE deportations, adding that immigrants fled their countries in search of better opportunities and contributed greatly to the United States.

Karin Perolta, of Union County, noted her concerns over the UC Jail being used as an ICE detention center and how it would affect the community.

Teresa Diaz, of Elizabeth, asked the Board to commit to saying no to the creation of an ICE detention center at the former UC Jail. She also noted the recent events that took place at Delaney Hall in Newark that resulted in the arrest of Newark Mayor Ras J. Baraka.

Carlos Villavicencio, of Elizabeth, spoke out against private prisons, noting that these corporations were meant to destroy communities and instill fear. He encouraged the Board to consider alternative uses for the UC Jail. He also noted the recent events at Delaney Hall in Newark.

Carissa Cunningham, of New Brunswick, spoke out against an ICE detention center at the former UC Jail. She noted her concerns relative to ICE immigration enforcement efforts.

Adam McGovern, of Plainfield's Wind of the Spirit Immigration Resource Center, spoke relative to the recent events at Delaney Hall in Newark. He asked when the RFP would be shared with the public.

Maria Eva Dorigo, of Montclair, spoke in opposition to an ICE detention center at the former UC Jail. She implored the Board to follow in the example of Newark Mayor Baraka and resist ICE efforts.

David Heller, of Cranford, spoke relative to the recent events at Delaney Hall and asked the Board to condition the sale of the UC Jail to prevent ICE or other private detention centers from gaining access to the property.

Betsy Fabricant, of Elizabeth, spoke relative to the recent events at Delaney Hall and asked the Board to stipulate in the upcoming bid that they would not sell the property to ICE or any other private detention center.

Kara Morillo, of Union, noted a NJ State law that banned the creation of additional detention centers and asked the Board to commit to rejecting any bids from ICE and other private prison organizations. She added that she was happy the Board had stood in solidarity with Newark Mayor Baraka following the recent events at Delaney Hall.

Cynthia Galeota, of South Orange, spoke relative to the recent events that took place at Delaney Hall in Newark. She noted that the United States, although imperfect, was a vehicle for sharing the benefits and burdens for the good of all. She asked the Board to resist ICE efforts and not allow them to terrorize communities.

Susan Vercheak, of Maplewood, spoke relative to the recent events that took place at Delaney Hall in Newark and expressed her concerns over ICE deportation efforts.

Terri Suess, of Union County, spoke relative to the recent events that took place at Delaney Hall in Newark. On another note, she alleged that the sale of the UC Jail was already finalized. She also spoke about Project 2025.

Counsel Bergen asked the speaker to conclude her comments. He reminded speakers to adhere to the 3-minute time limit to ensure everyone an opportunity to speak.

Jenne Fortin, of Fortin, of Union County, noted her concerns relative to selling the UC Jail and using it as an ICE detention center, adding that this would have a devastating effect on the Union County community.

Aiel Laji, of Resistencia en Accion, shared a statement from colleague Ashnali Gooni, who was detained for protesting the opening of Delaney Hall. She asked the Board to oppose the expansion of ICE detention centers.

Isaac Jimenez, of Jersey City, spoke relative to his concerns over ICE deportation efforts and asked the Board to oppose such efforts.

Ana Paola Pazmiño, of Princeton, spoke relative to the recent events at Delaney Hall, adding that immigrant detainment and crime migration systems served no legitimate purpose other than to terrorize immigrants and their families.

Maya Ponto Aronoff, of Resistencia en Accion, asked the Board to restrict the bids of the Union County Jail to ensure it would not be purchased for the purpose of incarceration. She suggested alternative uses for the property include affordable housing, racial and economic programs, and or a job training facility.

Jordy Hernandez, of CWA, thanked all the speakers that evening for speaking out against ICE detention efforts. He also spoke relative to the recent events that took place at Delaney Hall. He asked the Board to ban any bid for the UC Jail from ICE or other private detention organizations.

Ami Hachalia, of the ACLU of NJ, noted her opposition of selling the UC Jail to ICE for the detention of immigrants, noting the harm this would cause the community.

Kathleen O'Leary, NJ Region Coordinator for PAX Christi, spoke against mass deportation and ICE detention efforts. She asked the Board to commit to not selling the UC Jail for the purpose of ICE detention and or incarceration. She also noted the recent events that took place at Delaney Hall in Newark.

Mary Heller, of Cranford, spoke relative to the recent events that took place at Delaney Hall in Newark. She noted that immigrants were statistically less likely to commit crimes when compared to natural-born citizens. She asked the Board to resist ICE detention efforts.

Mike Fabricant, of Elizabeth, asked the Board to resist and oppose ICE detention and deportation efforts.

There were no additional questions or comments.
