CALL TO ORDER

Chairwoman Leon presided over the meeting and called the meeting to order at 6:05 PM

ROLL CALL

Roll call showed Chairwoman Lourdes Leon, Vice-Chairman Joseph C. Bodek, Commissioner James E. PRESENTATION BY THE BOARD

A Resolution Presentation was made by the Board to the Cranford Police Department, Cranford Jaycees, Vinny's Pizza and Pasta, and Calabria Pizzeria in recognition of their successful "Keep Calm, Helmets On" safety initiative.

Chairwoman Leon was joined by Commissioner Kowalski and Commissioner Palmieri-Mouded.

Chairwoman Leon noted that the Board was proud to recognize the Cranford Police Department, Cranford Jaycees, Vinny's Pizza and Pasta and Calabria Pizzeria for their outstanding partnership in the "Keep Calm, Helmets On" safety campaign. Now it its third year, Chairwoman Leon noted that the initiative encouraged children under 17 to wear their helmets while riding their bikes by rewarding them with coupons for a free slice of pizza and a beverage. She added that in addition to encouraging and promoting safety, this initiative harnessed the power of public and private partnerships, bringing together law enforcement, civic organizations and local businesses to strengthen the Cranford community. On behalf of the Board, she commended these efforts in fostering a strong culture of safety in Union County neighborhoods.

Commissioner Kowalski recognized Shaun Reese of the Cranford Jaycees and thanked all the aforementioned organizations for being an integral part of Cranford and for proactively promoting and prioritizing the safety in the community.

Cranford Police Chief Matthew Navarro thanked Chairwoman Leon and the Board for the recognition, adding that he appreciated the collaborative effort between law enforcement and local businesses and volunteer groups. He noted that this annual initiative, funding by the Cranford Jaycees, allowed for children to engage positively with law enforcement and be rewarded for good behavior. Shaun Reese, of the Cranford Jaycees, thanked the Board for the recognition, noting they were honored to be part of this initiative. He thanked everyone involved for their efforts.

Vinny Savinelli, of Vinny's Pizza and Pasta, thanked the Board for the recognition, adding that he was proud to be able to participate in this initiative, noting his strong ties to the Township of Cranford.

Commissioner Kowalski thanked the Township of Cranford for their efforts, adding that the Board was in full support of such initiatives.
