CAPITAL ORDINANCE OF THE COUNTY OF UNION, NEW JERSEY
AUTHORIZING THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS IN, BY AND
FOR THE COUNTY, APPROPRIATING THEREFOR THE SUM OF \$10,000,000
AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED
FROM CAPITAL SURPLUS OF THE COUNTY.

BE IT ORDAINED by the Board of County Commissioners of the County of Union, New Jersey, as follows:

Section 1. The County of Union (the "County"), State of New Jersey is hereby authorized to make the following public improvements in, by and for the County, including all work, materials and appurtenances necessary and suitable therefor: (A) Renovation of the Gerald B. Green Plaza Parking Garage in Plainfield; and (B) Department of Parks and Recreation, Division of Park Maintenance — (i) installation and reconstruction of walking paths at various locations, (ii) improvements to athletic fields at Unami Park, (iii) resurfacing of athletic courts at various locations, (iv) paving and curbing improvements at various locations and (v) improvements to playgrounds at various locations.

Section 2. The sum of \$10,000,000 is hereby appropriated to the payment of the cost of the improvements authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from Capital Surplus of the County. The sum of \$10,000,000 is hereby appropriated from Capital Surplus of the County to the payment of the cost of said purpose.

Section 3. Said improvements are lawful capital improvements of the County having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Clerk of the Board of County Commissioners and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
