BE IT ORDAINED by the Board of County Commissioners of the County of Union, State of New Jersey, as follows:

Section 1. Section 4.H of Ordinance No. 740-2012 entitled:

"BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY, NEW AUTOMOTIVE VEHICLES, INCLUDING ORIGINAL APPARATUS AND EQUIPMENT, NEW ADDITIONAL FURNISHINGS, NEW COMMUNICATION AND SIGNAL SYSTEMS EQUIPMENT AND NEW INFORMATION TECHNOLOGY AND TELECOMMUNICATIONS EQUIPMENT IN, BY AND FOR THE COUNTY OF UNION, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$31,938,317 TO PAY THE COST THEREOF, TO APPROPRIATE A STATE GRANT, TO MAKE A DOWN PAYMENT, TO APPROPRIATE CAPITAL SURPLUS, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS."

Adopted by the Board of County Commissioners (formerly the Board of

Chosen Freeholders) of the County of Union, New Jersey (the "County") on September 13, 2012, as previously amended by the following three ordinances: Ordinance No. 760-2014 adopted on October 9, 2014; Ordinance No. 786-2017 adopted on August 17, 2017; and Ordinance No. 845-2023 adopted on September 7, 2023, is hereby amended to add the following to the purposes authorized: acquisition of new printers for the use of the Print Shop; and shall hereafter read as follows:

"[Section 4.] H. <u>Department of Engineering, Public Works and Facilities, Division of Facilities Management</u> - (i) Upgrading fire alarm systems and system controls in various public buildings and park facilities and (ii) acquisition of new printers for the use of the Print Shop.

Adopted by the County on July 16, 2015 is hereby amended to add the following to the projects authorized: renovation of and construction of an addition to Baxel Hall; and shall hereafter read as follows:

"[Section 4.]S. <u>Union County Vocational-Technical Schools</u> - Undertaking of the following improvements: (i) Courtyard drainage improvements, (ii) various renovations and improvements to facilities (district-wide), (iii) construction of Campus covered walkways and (iv) renovation of and construction of an addition to Baxel Hall. It is hereby determined and stated that (A) all resolutions to be filed by the Board of Education of the Union County Vocational-Technical Schools and the Board of School Estimate of Union County Vocational-Technical Schools in order to request the Board of Chosen Freeholders to raise funds for the aforesaid purposes have been filed, (B) no down payment is required for such purposes pursuant to the provisions of N.J.S.A. 18A:54-31 and (C) such public buildings being improved are of "Class B" or equivalent construction as defined in Section 22 of the Local Bond Law.

Appropriation and Estimated Cost \$824,000 Bonds and Notes Authorized \$824,000 Period of Usefulness 15 years."

Section 3. Section 4.I of Ordinance No. 776-2016 entitled:

Adopted by the County on August 18, 2016, as previously amended by Ordinance No. 805-2019 adopted on February 14, 2019 and Ordinance No. 810-2019 adopted on December 19, 2019, is hereby amended to add the following to the projects authorized: renovation of the tennis courts at Unami Park; and shall hereafter read as follows:

"[Section 4.] I. <u>Department of Public Safety; Department of Parks and Recreation</u> — (i) Renovation of a portion of the Ralph Froehlich Public Safety Building located in Westfield for County dispatch and additional office space (Department of Public Safety), (ii) additional funding for the construction and equipping of the Oak Ridge Park Sports Complex (Department of Parks and Recreation) and (iii) renovation of the tennis courts at Unami Park (Department of Parks and Recreation). It is hereby determined and stated that said public buildings to be renovated or constructed are or will be of "Class B" or equivalent construction as defined in Section 22 of the Local Bond Law (Chapter 2 of Title 40A of the New Jersey Statutes Annotated, as amended; the "Local Bond Law").

Adopted by the County on August 17, 2017, as previously amended by Ordinance No. 805-2019 adopted on February 14, 2019 and Ordinance No. 845-2023 adopted on September 7, 2023, is hereby amended to: (A) add the following to the purposes authorized: acquisition of various new automotive vehicles, including original apparatus and equipment; and (B) decrease the period of usefulness of the purposes authorized \underline{from} 10 years \underline{to} 5 years (a decrease of 5 years); and shall hereafter read as follows:

"[Section 4.]J. Department of Engineering, Public Works and Facilities Management, Division of Facilities Management - (i)

Section 5. Section 16 of Ordinance No. 787-2017 (as previously amended by Ordinance Nos. 805-2019 and 845-2023) is hereby amended to decrease the average period of usefulness of the purposes authorized $\underline{\text{from}}$ 12.05 years $\underline{\text{to}}$ 12.00 years (a decrease of 0.05 years), and shall hereafter read as follows:

"Section 16. It is hereby determined and declared that the average period of usefulness of said purposes, according to their reasonable lives, taking into consideration the respective amounts of bonds or notes authorized for said purposes, is a period of 12.00 years computed from the date of said bonds."

"[Section 4.]P. Department of Parks and Recreation - Undertaking of various park and recreation improvements consisting of (i) installation of synthetic turf athletic fields (including field lighting) at various parks, (ii) construction of a handicapped-accessible fishing dock at Cedar Brook Park, (iii) replacement of the fourth ring at the Watchung Stable, (iv) preparation and design phases of the Warinanco Park Master Plan, (v) extension of Cedar Brook Park, including gazebos, walkways, landscaping and stream stabilization, (vi) various improvements (including ADA improvements) to the Master Gardener Greenhouse at

Watchung Reservation, (vii) upgrading tennis courts at various locations (including professional services) and (viii) improvements to parking lots at various parks.
