AN ORDINANCE TO AMEND "THE LAWS OF UNION COUNTY: ADMINISTRATIVE CODE AND POLICIES AND GENERAL LEGISLATION" BY AMENDING PART II-GENERAL LEGISLATION: CHAPTER 107, PARKS AND RECREATION, ARTICLE IV, FEES FOR RECREATION FACILITIES.

BE IT ORDAINED by the Union County Board of County Commissioners that the "Laws of Union County" are hereby amended to be set forth in full as follows (those sections not listed are unchanged):

PART II — POLICIES AND GENERAL LEGISLATION

Chapter 107, PARKS AND RECREATION

ARTICLE IV, Fees for Recreation Facilities

§ 107-6. Park Fees. Unchanged.

§ 107-7. Park Fees for Overtime Costs for use of Equipment and for Special Events.
[NEW]

A. Special Events. Any individual or entity authorized to use any portion of the Union County Parks for purposes of a special event, shall reimburse Union County for the cost of Union County employees provided for such event (including but not limited to garbage collection, cleaning of bathrooms both during and after such event and driving County-owned golf carts), per written agreement. The cost for all such employees shall be charged at an hourly rate, per employee, of \$75.00.

B. Equipment usage. Any governmental entity authorized by written agreement to borrow any Union County equipment, shall reimburse Union County for the personnel cost in conjunction with the use of such equipment, occurring outside of regular working hours, as follows:

1. Bandwagon
 - a. Delivery and set up \$187.50
 - b. Breakdown and removal \$187.50

2. Sound system
 - Oversight \$75.00 per hour (duration of event)

3. Tables and chairs
 - a. 1-20 chairs/tables \$75.00
 - b. 21-40 chairs/tables \$150.00

4. Tents
 - a. Event tents (20x20)
 - Delivery and set up \$562.50
 - Breakdown & removal \$562.50

- b. Larger event tents
 - Delivery and set up \$1,350.00
 - Breakdown & removal \$1,350.00
- c. Pop-up tents
 - Delivery, set up & removal \$37.50
- 5. Haywagon
 - a. Delivery and set up \$75.00
 - b. Breakdown & removal \$75.00
 - c. Oversight \$75.00 per hour (duration of event)
- 6. Platform Stage
 - a. Delivery and set up \$225.00
 - b. Breakdown & removal \$225.00
- 7. Bleachers
 - a. Delivery and set up \$225.00
 - b. Breakdown & removal \$225.00
- 8. Golf Carts \$75.00 per hour per cart (duration of event)
- 9. Generators
 - a. Delivery and set up \$93.75
 - b. Breakdown & removal \$93.75

AND, BE IT FURTHER ORDAINED, in case any section, subsection, paragraph, subdivision, clause or provision of this ordinance shall be judged invalid by a court of competent jurisdiction, such order or judgment shall not affect or invalidate the remainder of any section, paragraph, subdivision, clause or provision of this ordinance, and to this end, the provisions of each section, paragraph, subdivision, clause or provision of this ordinance are hereby declared to be severable;

AND, BE IT FURTHER ORDAINED, that each section of this ordinance shall take effect at the time and in the manner provided by law, unless otherwise indicated.
