This renewal PSH project, for rental vouchers for persons with disabilities, will be administered by the Plainfield Housing Authority(PHA)in collaboration with the sponsoring agency, Bridgeway, Inc. (BWY). The responsibility of the PHA is linking the appropriate housing opportunities for rental vouchers with persons with disabilities and those with mental health disorders who are homeless individuals and/or families. The PHA will assist the participant by providing listings of available rental units, provide information on tenant/landlord issues and distribute rental vouchers payable to eligible landlords on behalf of the participants. Rental units will be chosen by participants who will control their own leases and living space. BWY’s Projects for Assistance in Transition from Homelessness (PATH) outreach staff will assist with identifying homeless individuals/families/transition aged youth meeting the criteria for the program with placing special emphasis on outreaching the chronic homeless. BWY staff will be a resource in showing units to participants and all participants will take part in a thorough and ongoing assessment of their housing needs; housing location and service plans will adjust according to individual need. BWY’S emphasis is on rehabilitation and individuals are encouraged to become as self-sufficient as possible. All phases of the rehabilitation process require active participation and input from the individual. BWY’s PATH outreach staff, multi-disciplinary Program of Assertive Community Treatment (PACT), and Supportive Housing teams will provide outreach contact to residents as needed for the purpose of assessment, planning, intervention and monitoring in all aspect of physical and mental health. Staff is available 24 hours a day 365 days a year. After hour access to staff is by ON CALL staff. Staff are organized in teams with mental health consumers employed as workers on each team. The PACT teams includes a psychiatrist, nurses, vocational counselors, substance abuse counselors and mental health consumer advocates. Individuals are encouraged to participate in their recovery by going to partial care day programs (there are 4 throughout the county), or doing volunteer work, school or employment. Psychiatric treatment including medication, education, substance abuse services, vocational development and placement, socialization, recreation, family support and advocacy are offered by BWY or accessed from affiliated service providers within the Continuum of Care. Participation in self-help groups and usage of natural supports systems encouraged by all programs. Employment services offered include career exploration, vocational readiness assessment, sheltered work and supported employment opportunities with local businesses. Services are designed to address the long term and recurrent nature of serious mental illness. Individuals are encouraged to be as self sufficient and integrated in the community.


