Through this Renewal Application, Community Access Unlimited will be providing safe and stable permanent housing at their Jaques Street condominiums for 8 youths between the ages of 18-25. The target population is the disabled. CAU will conduct a complete skills assessment prior to clients entering the housing units to identify individual independent living skills such as nutrition, sex education, public safety, independent reasoning skills, budgeting and accessing community resources. Each participating resident will work with CAU to develop an Individualized Service Plan. On-going case management will be provided to include 24 hours of on-call emergency support in conjunction with direct linkage to other community resources, such as Social Services: Welfare; WIB One Stop; Planned Parenthood; WIC; Social Security; Unemployment; Trinitas Hospital; and public transportation. In addition to case management, CAU will provide Support Services to help residents identify their current and future needs and strategically plan for their future. Services may include: life skills training; job readiness; educational training/assistance, health services, transportation and linkages to UC Vocational School; health care linkages and money management training. On-going tracking and updating of efforts made by the participant toward self-sufficiency will be recorded and combined into monthly reports. Referrals will be made primarily from selfreferring Homeless youth, and the NJ Division of Child Protection and Permanency (DCP&P)located in Union, Middlesex and Essex counties. DCP&P will be able to refer persons originating from UC back to UC for permanent supportive housing. CAU will also work closely and collaboratively with other existing agencies helping at-risk youth and their families. The project anticipates serving a minimum of eight individuals who are homeless with a documented disability. In addition, this project includes a budget to pay a portion of HMIS user group fees for the Union County CoC.



This is in response to your request of April 23, 2004 regarding your organization's tax-exempt status.

In October 1981 we issued a determination letter that recognized your organization as exempt from federal income tax. Our records indicate that your organization is currently exempt under section 501(c)(3) of the Internal Revenue Code.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. 
