Community Access Institute (CAI) is a private, not-for-profit human service agency. CAI will help 8 chronically homeless individuals and adults with disabilities reach self-sufficiency and independent living through our permanent supportive housing program. Through ongoing case management, residents will enhance their independent living skills, such as writing a resume and interviewing for a job, enhancing job skills and maintaining a job, budgeting and money management, and educational assistance. The Permanent Supportive Housing Program also provides linkages to social services including Social Security, welfare, employment assistance, mental health providers and other health supports.

Through agreement with Community Access Unlimited (CAU), CAI will provide an Information and Referral Coordinator who is responsible for handling all information and referral activities regarding CAI services and programs, including housing options. Each year, CAU receives hundreds of calls from people with housing needs. CAU also has in place a transitional living program where people who have been chronically homeless can graduate into permanent housing. This is in response to your request of April 23, 2004 regarding your organization's tax-exempt status.

In October 1981 we issued a determination letter that recognized your organization as exempt from federal income tax. Our records indicate that your organization is currently exempt under section 501(c)(3) of the Internal Revenue Code.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.




