In accordance with Attorney General Directive 2018-3 Early Warning System, the Union County Prosecutor's Office received correspondence from all law enforcement agencies in our jurisdiction assuring their compliance with the Directive.

The law enforcement agencies within our jurisdiction confirmed; their compliance with the Directive to include implementation of an Early Warning Policy consistent with the Directive, agencies have a system in place and personnel assigned to track performance indicators, and that appropriate notifications were made to the Union County Prosecutor's Office when personnel triggered the system. Our review further determined one department did not have their policy posted on their public website. That department is in the process of updating its websites to include their respective policy.
