AN ORDINANCE FIXING THE SALARIES OF MEMBERS OF THE BOARD OF CHOSEN FREEHOLDERS, THE COUNTY MANAGER AND DEPARTMENT HEADS

BE IT ORDAINED by the Board of Chosen Freeholders of the County of Union as follows:


Section 1. The salaries of the Members of the Board of Chosen Freeholders, County Manager and Departments Heads shall be as hereinafter set forth. The same shall be effective as of January 1, 2015 and January 1, 2016 as set forth in the schedule below.
